1. Purpose of Report.

- Fortnightly meetings provide for swifter feedback both from and to the monthly Policy Review and Scrutiny Committees.
- Fortnightly meetings would ensure that the Cabinet is able to provide effective leadership

4. Comment

- 4.1 The volume of work will come from a number of directions:
- Policy proposals arising out the work of the Cabinet's policy working groups (including budget proposals) for forwarding to Council
- The need to respond to the government and National Assembly for Wales' initiatives
- Decisions on delegated responsibilities including emergency powers functions
- Scrutiny Committee work responses.

4.2 Over time there will be a need to develop a cabinet work programme indicating the order in which the Cabinet will be considering issues. This will enable time for the Policy Review and Scrutiny Committees to feed into the process.

2. Background

Local Business Partnerships

- 2.1 The First Secretary of the National Assembly for Wales wrote to local authorities in March this year encouraging the setting up of local business partnerships in Wales. The specific focus of these partnerships is on enforcement issues.
- 2.2 The WLGA has indicated its support for this government initiative and has successfully lobbied the National Assembly to set up seminars in North and South Wales.
- 2.3 At this stage the WLGA are merely asking to see if there is sufficient interest. There are no dates. The seminars will take the form of evening receptions.
- 2.4.1 Local Forums could have a beneficial effect through securing better understanding on enforcement issues, the relevant legislation and the role of officers.

Meeting with Lead Members for Education with Rosemary Butler 14th July

- 2.5 A meeting has been arranged for all Lead Members for Education and Directors with Rosemary Butler on 14th July at Rhayader Leisure Centre. Formal invitations will be issued shortly by the Assembly.
- 2.6 There will be a pre-meeeting for the local authority delegates beforehand, which will be the first of planned quarterly meetings with the Education Spokesperson and Deputy Spokespersons of the WLGA. A calendar for future meetings will be agreed on the day. It is important that each authority is represented, so substitutes are requested if necessary.

- 2.7 the Assembly Secretary for the Environment is inviting an appropriate elected representative and technical officer to discuss planning issues as part of the attempt to develop the agenda of partnership to and I recognise our mutual dependence in delivering the agenda which we have set out in "Better Wales".
- 2.8 The meeting will take place in Conference Room A at the National Assembly Building, Cardiff Bay from 2.00pm-4.00pm on **Thursday 29th June 2000**. A buffet lunch will be available from 1.30pm in Conference Room C.

3. Comment.

3.1 It would be useful if Cabinet would consider delegating to the Chief Executive in consultation with the Leader the power to authorise the sending of representatives to meetings if the request comes after a Cabinet meeting and the meeting falls before the next. All attendance would be subsequently ratified at the nearest appropriate meeting of Cabinet.
