#### TREE PRESERVATION ORDER NO. 2/2004

#### 1. PURPOSE OF THE REPORT

1.1 To report on the serving of the Tree Preservation Order and to determine whether it should be confirmed without modification.

#### 2. BACKGROUND

- 2.1 The garden contains a number of trees which are of local amenity value. An Emergency Tree Preservation Order was served following considerable local opposition to felling which took place prior to determination of a Planning Application for 2 dwellings with detached garages.
- 2.2 The justification for making the Order is that the trees are of amenity value and considered vulnerable now that development of the site has been approved.

#### 3. OBJECTIONS

3.1 There has been a letter of objection form the applicant, Gwyn Roberts and Co, on the grounds that the trees are ornamental and not native and that the trees will require lopping to improve visibility at the access and for safety reasons.

#### 4. CONCLUSION

4.1 The Tree Preservation Order is required to protect the trees for their amenity value. An application to the Council for consent to carry out necessary tree works can be made by the owner.

#### 5. RECOMMENDATION

5.1 The Tree Preservation Order No. 2/2004 on land adjoining Cerddin, Berwyn Street, Llandrillo should be confirmed without modification.

## INFORMATION ITEMS FOR PLANNING COMMITTEE Member Training Public Access Portal Planning Surgeries High Hedges

#### 1. PURPOSE OF REPORT

- 1.1 This comprises the standing agenda item at Planning Committee providing a reference point for Members for information on emerging initiatives, policy, guidance and publications.
- 1.2 The information provided to Members is limited to a brief description of the relevant initiative and a reference to the source of any information (internet/intranet address). The report will also include a summary of any significant implications for Planning Committee decision making, where relevant.

#### 2. MEMBER TRAINING

- 2.1 It is important that training is offered to Planning Committee Members to ensure that sound decision making is carried out. The Code of Best Practice for Councillors and Officers Dealing with Planning Matters indicates that Members of the Planning Committee will be offered training annually. As part of the Planning: Delivering for Wales Initiative, WLGA and WAG have organized and funded training for Members. The first module took place in September 2004. The module was only attended by 10 members, despite the same training being provided on consecutive days.
- 2.2 Further modules of the training are planned for 14<sup>th</sup> February 2005. Members are urged to make every effort to attend to assist in their development as Planning Committee Members. At the time of writing this report only 2 Members had put their names forward. A handbook has also been produced to support the training provided within Module 1 (this will be distributed at Planning Committee). In addition to the training provided through this method, it is intended to visit development sites in the spring of this year, following a similar successful exercise in November 2003.

2.3 In some Councils it is practice to make training compulsory for Planning Committee Members. This matter may be considered by the Corporate Governance Committee who consider reports and recommendations on the Council's governance procedures from the Audit Commission for Wales.

#### 3. PUBLIC ACCESS PORTAL

- 3.1 Work has recently been undertaken with the provider of planning application processing software, SX3, to enable information on applications to be viewed via the website. This will allow the public to check on applications submitted, progress on applications, make representations via the web, and access other information about planning issues in a user friendly format.
- 3.2 Members can view the information via: http://planning.denbighshire.gov.uk/

#### 4. PLANNING SURGERIES

- 4.1 We are piloting a series of planning advice surgeries over the next few weeks in Rhyl, Prestatyn, Ruthin, Llangollen and Corwen. Details of the locations and timetables of the surgeries have been sent to our main customers, including Councillors, Community Councils, and agents. Posters have been sent to the surgery venues. A press release has been issued. The intention of the surgeries is to provide planning advice at locations near to our customers. To help get the best out of the surgeries we have asked that people make an appointment. Appointments will last 15 minutes. We will continue to provide an advice service from Caledfryn in Denbigh.
- 4.2 We will provide advice on the following matters the need for planning permission, how to submit a planning application and your chances of success, and how to get involved in applications already submitted. We will agree actions at the end of the appointment.
- 4.3 Following the two month programme of surgeries, the format, frequency and value of the surgeries will be reviewed taking into account feedback received from customers. It is anticipated that the surgeries will be continued in a similar form.

#### 5. HIGH HEDGES

5.1 Part 8 of the Anti-Social Behaviour Act came into force on Dec 31<sup>st</sup> 2004. It has provided local authorities with new procedures to enable

them to deal with complaints about high hedges. The complainant must prove to us that they have taken all reasonable steps to resolve the issue prior to approaching the Authority. The Planning Compliance Team will handle these complaints.

- 5.2 We have set an interim non-refundable fee of £240 to be paid by the complainant (to be reviewed in due course), in order to start the investigation. If the complaint is upheld, a remedial notice will be issued to the hedge owner setting out what is to be done. This will become a charge on the property.
- 5.3 The Act creates an offence of failing to comply with a remedial notice and if convicted by a Magistrates Court, the hedge owner may be fined up to £1000 with a further fine of up to £50 per day that the work remains uncompleted. Further failure to comply means that the authority may then arrange to have the requisite work carried out (at the cost of the hedge owner) and these costs would be registered as a local land charge over the property.

- 5.5 We are producing forms and leaflets to assist the public in understanding the legislation and making complaints. These will be made available on the Council web site.
