Minutes of the meeting of the Standing Advisory Council for Religious Education (SACRE) held in the Council Chamber, Ty Nant, Nant Hall Road, Prestatyn on Monday, 4th February 2008 at 10.00 a.m.

Apologies had also been received from the Interim Corporate Director Lifelong Learning and the Interim Head of School Improvement.

#### SILENT REFLECTION

The meeting began with a few minutes silent reflection.

#### WELCOME

The Chair welcomed members and officers to the meeting. A warm welcome was also extended to Captain Angela Tucker who was a new SACRE member attending her first meeting and Mr. Clive Halliday, Chair of Denbighshire's Standards Committee who was observing today's meeting.

#### 1 URGENT MATTERS

There were no urgent matters for consideration by the committee.

#### 2. MINUTES

The minutes of the meeting held on 12th November 2007 (previously circulated) as received by the County Council on 22nd January 2008 were submitted.

#### Matters Arising -

Page 2 - Item No. 4 - Minutes: Matters Arising: Issues to raise with the Minister for Education – The Inspector/Adviser RE submitted a report (circulated at the meeting) on the outcomes of the visit with the Minister held on 26th November 2007. The Inspector/Adviser RE summarised the report for members outlining the four questions put to the Minister and her response thereto. He was pleased to report that it had been a very positive meeting and the delegation had been encouraged by the Minister's personable approach and willingness to hear their views. The Minister had proved very supportive towards RE in a number of matters, particularly regarding the need to raise the profile of Post 16 RE. The delegation had suggested a high profile conference to raise awareness and the Minister had volunteered to give a key note speech at that event. At the end of the meeting the Minister stated that she valued the contribution of WASACRE and the role of SACREs and their great value to Local Education Authorities. Members were pleased to note the positive meeting and looked forward to future developments arising therefrom. The Chair thanked the Inspector/Adviser RE and the delegation for their hard work and support.

Page 2 – Item No. 2 Minutes: Matters Arising: Spiritual Development in the Curriculum – Copies of the final version of the document offering advice on Spiritual Development across the curriculum were made available for members to collect at the meeting. The Inspector/Adviser RE reiterated that the document would shortly be sent to every teacher in the authority and it was felt that schools and teachers would value that input. Members were pleased that all teachers would be given the opportunity to benefit from that guidance. Councillor G.J. Pickering emphasised the importance of feedback on the document from teachers which would prove useful for SACREs. In response to a query regarding distribution of the document the Inspector/Adviser RE confirmed that he would ensure all teachers, including those at St. Brigid's School who were not on the Council's payroll, would receive a copy.

Page 5 – Item No. 8: WASACRE – In accordance with SACRE's request at the last meeting, copies of the handbook issued to new SACRE members had been made available at the meeting for all members to collect.

**RESOLVED** that the minutes of the SACRE meeting held on 12th November 2007 be received.

#### 3. REVISED AGREED SYLLABUS

The Inspector/Adviser RE reminded members that SACRE had a statutory responsibility to advise the Local Education Authority on the adoption and revision of its Agreed Syllabus. Accordingly he sought SACRE's confirmation of the decision and recommendation to the Local Education Authority and Agreed Syllabus Conference to adopt the National Exemplar Framework as the Agreed Syllabus for Denbighshire, with appropriate amendments, and to provide supplementary guidance to schools. A meeting of the Agreed Syllabus Conference would be held immediately following today's SACRE meeting.

#### **RESOLVED** that:-

- (a) the decision and recommendation to the Local Education Authority and Agreed Syllabus Conference to adopt the National Exemplar Framework as the Agreed Syllabus for Denbighshire, with appropriate amendments, and to provide supplementary guidance to schools be confirmed, and
- (b) the Local Education Authority be requested to print and distribute copies of the Agreed Syllabus and Supplementary Guidance to schools.

#### 4. EXAMINATION RESULTS 2007

The Inspector/Adviser RE submitted tables (previously circulated) detailing examination results for schools in the GCE and GCSE examinations in Religious Studies for 2007 as compared with 2006 for members' review.

The Inspector/Adviser RE proceeded to take members through the results in detail and verbally reported upon comparisons between the 2007 and 2006 examination results. He particularly referred to the following points:-

- GCSE Results All Religious Studies 2007 there were 34 less candidates than the previous year; overall there had been an improvement on the previous year with 70.4% achieving A\* - C but this figure was 0.7% below the national average
- GCSE Results Boys Religious Studies 2007 there were 17 more candidates than the previous year with an improvement of 1.4% with 66.7% achieving A\* C which was 2.1% above the national average; this figure was the only one of the results this year above the national average
- GCSE Results Girls Religious Studies 2007 there were 51 less candidates with 73.5% achieving A\* - C which was an improvement on the previous year being 1.5% below the national average compared to 3.7% below the year before

- Religious Education All (Short Course) overall there were 22 more candidates; 43% achieved A\* - C which was a drop of 3.2% compared to the previous year which was 15.8% below the national average showing a decrease on the previous year's performance
- Religious Education Boys (Short Course) there were 13 more candidates than last year with 31.1% achieving A\* - C which was the same result as the previous year which was 20.1% below the national average
- Religious Education Girls (Short Course) there were 9 more candidates with 51.1% achieving A\* - C which was 4.9% below the previous year and 14.5% below the national average which was a decrease of 11.6% on the previous year
- GCE Advanced Level All Religious Studies 2007 there were 16 more candidates with 69% achieving A C which was a 14.2% increase on the previous year but still 6.9% below the national average level although an improvement on the 10.7 % below the national level the previous year
- GCE Advanced Level Boys Religious Studies 2007 there were 5 more candidates with 60% achieving A - C which was the same as the previous year but still 11% below the national average which was worse than the 9.1% below the national level the previous year
- GCE Advanced Level Girls Religious Studies 2007 there were 11 more candidates with 72.1% achieving A C which was an increase of 19% on the previous year but 5.2% below the national average but an improvement on the previous year which was 13.5% below the national average level.

The Inspector/Adviser RE referred to the mixed outcomes. Although five of the examination tables had shown an improvement only one of those was above the national average level. Two examination tables showed a decrease on previous performance and two remained the same as the previous year. Members were advised that there were no results for the COEA/Entry Level for 2007. The Inspector/Adviser RE reminded members that they had examined the trends the previous year and letters had been sent to those schools showing a decrease in performance over time. He advised that Rhyl High School was the only school this year showing a decrease in performance over three consecutive years advising that the GCSE results for the short course in RE were 23.8% for 2007; 46.8% for 2006, and 60.6% for 2005. Accordingly the Inspector/Adviser RE would be visiting the school the following term to address the poor performance. Prior to 2005 results at Rhyl High School had been good and there was a need to investigate the attainment levels. The Inspector/Adviser RE agreed to report back to members thereon.

During the ensuing discussion Councillor G.J. Pickering noted that most of the secondary schools required some assistance and stressed the need for actions at an early stage in order for performance levels to increase in the next examination results. The Inspector/Adviser RE reported upon work being undertaken in individual schools with the School Improvement Team and it was hoped that strategies being discussed at an all schools level would have a positive impact. Mrs. M.B. Lloyd

highlighted that much depended upon the cohorts of pupils following the courses which changed each year. She felt that schools should be thanked for the good work undertaken and encouraged to improve. The Chair agreed that SACRE needed to encourage the schools by offering the services of the Inspector/Adviser RE to bring about improvements. Councillor D. Owens expressed his disappointment regarding the poor performance results and felt that greater emphasis should be placed on this aspect of the curriculum through the Modernising Education Agenda and he stressed the importance of having a good standard of Religious Education within schools. Mrs. M.B. Lloyd advised that more emphasis had now been placed on RE in the curriculum and the new Agreed Syllabus would provide greater emphasis and guidance on this issue.

The Inspector/Adviser RE spoke generally about the difficulties and dilemmas facing schools and reported upon ongoing work with schools, including session work with those schools where results were below the national averages, to secure improvements. He also referred to a proposal to run an Examination Strategy Course for pupils and discussions with WJEC were ongoing in that regard to target examination performance for particular candidates. It was agreed that feedback on the feasibility of such a course be sought from schools. In response to a suggestion from Councillor D. Owens, the Inspector/Adviser RE agreed to meet with the newly appointed Head of School Improvement when he took up his position in order to address areas of poor performance in RE and secure improvements.

The Inspector/Adviser RE suggested that, for those schools where results had improved on the previous year and were above the national averages, letters of congratulations should be sent. Similarly, for those schools who had under performed letters should be sent asking what actions those schools were taking and offering assistance to bring about improvements.

#### RESOLVED that:-

- (a) the statistical data and summary be received;
- (b) the Inspector/Advser RE arrange a meeting the following term with those schools where results were below the national average;
- (c) feedback be sought from schools regarding the feasibility of the proposal for a Pupil Examination Strategy Day;
- (ch) letters of congratulation be sent to the schools where results had improved on the previous year and were above the national averages;
- (d) letters be sent to those schools where results had been below the national average in order to ask what actions were being taken and to offer the services of the Inspector/Adviser RE in helping to bring about improvements, and
- (dd) the Local Education Authority be requested to distribute the above letters.

#### 5. ANALYSIS OF INSPECTION REPORTS ON SCHOOLS

The Inspector/Adviser RE submitted a report (previously circulated) analysing the results of the recent inspections of two schools between June and October 2007 in the provision of Spiritual, Moral, Social and Cultural Development (SMSC), and Religious Education where it was part of the inspection. Inspections had been carried out at Ysgol Llantysilio and Ysgol Cefn Meiriadog and a brief history of each school had been incorporated into the report.

The Inspector/Adviser RE provided members with a brief resume of the findings relating to each school, explaining and clarifying specific issues in response to members' questions thereon. It was pleasing to note the 31 positive comments for SMSC between the two schools with only 5 negative comments. The schools would be addressing those negative points. With regard to the comment that no extra curricular activities were currently offered to pupils on the school site (Ysgol Llantysilio) members were advised that the distance travelled by the pupils to the school had an impact. Mrs. M.B. Lloyd added that, since the school had been clustered, there may be more of an opportunity to address that point. Councillor D. Owens referred to the negative comment regarding insufficient detailed planning for the promotion of pupils' active bilingual skills at Ysgol Cefn Meiriadog advising that the issue was actively being addressed. With regard to Religious Education the two schools had received 24 positive comments between them and there had been no shortcomings identified within the schools. No negative comments had been received in any of the Key Stages which had been Graded 2 (good features and no important shortcomings). Members were advised that there may be new grade descriptions during the new cycle of inspections.

Members congratulated the two schools on their positive inspection reports and were encouraged to note that no shortcomings had been identified.

#### **RESOLVED** that:-

- (a) the report be received and noted;
- (b) the Inspector/Adviser RE write to the schools inspected congratulating them on the good features and offering the services of the Inspector/Adviser RE or other officers of the LEA in terms of addressing any shortcomings or key issues, and
- (c) the Local Education Authority be requested to distribute the above letters.

#### 6. WALES ASSOCIATION OF SACRES

The minutes of the WASACRE meeting held in Ebbw Vale on 4th December 2007 (previously circulated) were submitted.

The Inspector/Adviser RE reported upon a presentation by Tudor Thomas 'Stretch and Challenge – The Key Concepts of the New RS A level for Introduction in 2008' outlining the new arrangements for A level specifications. A copy of the presentation slides would be appended to the final version of the minutes. The Inspector/Adviser

RE had delivered the second presentation to WASACRE on Post 16 RE and highlighted the proposal for a Post 16 RE Conference building on previous work to support an innovative way that RE might be approached and delivered in the curriculum with benefits and values. The proposal included a Conference in September/October 2008 at St. David's College in Cardiff (by invitation of the Governing Body) and consideration of a video conference link in North Wales. The Conference was also to include a key note speech by the Minister; report from young people via Funky Dragon; presentation by Dyfed Powys Police on their programme for Police Officers on religious issues; Cardiff University lecturer to speak on the essential value of Religious Studies for people considering medicine as a career, and the launch of a Guidance Pack to support RE at the Conference. WASACRE had agreed to provide some funding for the Conference with other means of support being sought. It was hoped that SACREs would encourage schools to send delegates to this Conference.

Mrs. M.B. Lloyd also advised of discussions at the WASACRE Executive regarding the provision of Post 16 RE at FE (Further Education) Colleges whom did not fall within the remit of the law in providing RE and highlighted the need for their involvement. The Inspector/Adviser RE confirmed that it had been agreed to invite FE Colleges to the Conference.

Councillor G.J. Pickering had also attended the WASACRE meeting and extended his thanks to Councillor M.M. Jones for her help and assistance on the day. He had found the meeting a very enjoyable and interesting experience. Councillor Pickering had noted the lack of representation from North Wales and had been pleased that his suggestion regarding establishing a video conference link to the proposed Post 16 Conference in Cardiff had been accepted. Reference had also been made to the various interesting displays in the foyer which members had been encouraged to see and Councillor Pickering had noted that the materials had been provided predominantly from the primary schools. He hoped that any North Wales hosts would consider a greater input from the secondary school sector. Finally Councillor Pickering stressed the importance of the Post 16 Conference on the future provision of Post 16 RE and highly recommended that secondary schools and FE Colleges attend the event.

**RESOLVED** that the minutes of the meeting of WASACRE held on 4th December 2007 together with the verbal report from members attending be received and noted.

Prior to the close of the meeting the Chair thanked members for their attendance and contributions to debate.

The meeting concluded at 11.15 a.m.

Apologies had also been received from the Interim Corporate Director Lifelong Learning and the Interim Head of School Improvement.

#### 1. THE NATIONAL EXEMPLAR FRAMEWORK FOR RE

The Inspector/Adviser RE sought members' approval to adopt the National Exemplar Framework for Religious Education for 3 to 19 year olds in Wales (previously circulated) produced by the Department for Children, Education, Lifelong Learning and Skills (DCELLS), subject to amendments as proposed in Agenda Item No. 2, as the Denbighshire Agreed Syllabus for Religious Education.

The Inspector/Adviser RE referred to the extensive consultation which had taken place prior to the production of the National Exemplar Framework including input

from SACREs. He briefly took members through the document highlighting particular aspects as follows:-

- The introductory pages were very similar to other curriculum subject areas with particular reference to aspects of RE on page 10
- Pages 14 17 referred to RE in the Foundation Phase; RE was the only subject in the basic curriculum with reference to the Foundation Phase and an age range of 3 to 19 year olds which was a significant achievement [It was also useful to note that reference had been made to the National Exemplar Framework for RE in the Foundation Phase which was largely due to the work of WASACRE]
- Pages 18/19 and 20/21 referred to the Programmes of Study at Key Stage 2 & 3 respectively based on the new arrangements
- Pages 22/23 detailed the National exemplar level descriptions for RE
- Pages 24/25 referred to the outcomes for RE below Level 1
- Pages 27/29 referred to RE at Key Stage 4 and Post 16 giving a very clear message that there was a statutory requirement for RE at those levels
- Annexes to the document referenced the legal requirements for agreed syllabuses and additional information.

The Chair paid tribute to the hard work undertaken by all those involved in contributing to the document through the consultation process.

#### RESOLVED that:-

- (a) subject to amendments as proposed in Agenda Item No. 2, the National Exemplar Framework for Religious Education for 3 to 19 year olds in Wales produced by the Department of Children, Education, Lifelong Learning and Skills (DCELLS) be adopted as the Denbighshire Agreed Syllabus for Religious Education, and
- (b) the Local Education Authority advise schools of the decision to adopt the Framework as the Denbighshire Agreed Syllabus and to ensure schools had copies of the document for their use.

#### 2. PROPOSED AMENDMENTS/ADDITIONS TO THE NATIONAL FRAMEWORK

The Inspector/Adviser RE sought members' approval of the proposed amendments to the National Exemplar Framework for RE (previously circulated) in order to localise the document and insert them into the copies to be forwarded to schools as the Denbighshire Agreed Syllabus.

The Inspector/Adviser RE explained that the proposed amendments to the National Framework would help schools and clarify some areas and assist in ensuring some continuity from the previous Agreed Syllabus. It was recommended that the amendments/additions to the Framework should replace the existing Introduction on pages 2 - 3. He outlined the amendments as follows:-

- Clarification regarding the statutory requirement for all registered pupils in all maintained schools up to 19 years of age to receive RE (except those withdrawn by the request of parents/guardian)
- Simplified diagram explaining how the Agreed Syllabus fits into the whole curriculum with references to the requirements during each school year from age 3 to 19 years [the diagram would be amended to show the National Curriculum up to age 14]
- Table detailing the religions to be studied to ensure that Christianity was studied at all stages and that other principal religions represented in Great Britain were introduced; a caveat had also been included at Key Stage 4 to reflect the different requirements for GCSE
- References to the aims of RE together with Collective Worship and RE as distinct provisions had been included as these issues had not been referenced within the National Framework document
- the expectation for at least 5% of curriculum time for RE at each Key Stage had been highlighted
- the national exemplar levels descriptions for attainment in RE had been contained within the Agreed Syllabus and schools would be expected to use them to record pupils' attainment at the end of key stages; such information may be requested by SACRE as part of its statutory process of monitoring standards and delivery of RE in its schools.

Members took the opportunity to raise questions with the Inspector/Adviser RE regarding the Agreed Syllabus and sought clarification regarding the Post 16 RE provision for students involved with FE Colleges and where there was collaboration with schools. The Inspector/Adviser RE indicated that guidance on this matter was currently being sought from Estyn. The statutory requirement for the provision of RE only applied to schools and the collaboration agenda did raise questions regarding provision. With regard to collaboration arrangements Estyn had advised that it was the schools responsibility to provide RE but there were difficulties over timetabling issues. The Inspector/Adviser RE indicated that the Post 16 RE Conference would help to raise awareness of the issue and provide a range of options for schools in providing RE.

**RESOLVED** that the proposed amendments to the National Exemplar Framework for RE (as detailed at Agenda Item No. 2) be approved and inserted into the copies to be forwarded to schools as the Denbighshire Agreed Syllabus.

# 3. ADOPTION OF THE NEW AGREED SYLLABUS FOR DENBIGHSHIRE 2008 - 2013

The Inspector/Adviser RE sought members' approval to adopt the new Agreed Syllabus for Religious Education in Denbighshire. [The Agreed Syllabus Conference was the statutory body empowered to determine the Agreed Syllabus for Religious Education in Denbighshire.]

The Inspector/Adviser RE referred to the design and printing of the document. As the proposed amendments would likely reflect the Agreed Syllabuses for Denbighshire, Flintshire and Conwy, SACRE was asked to approve one document featuring all three Councils' logos for printing and distribution to save on associated printing costs. Members indicated their consent to the recommendation pending approval by Flintshire and Conwy SACREs.

Members were advised that the approved Agreed Syllabus together with supplementary guidance would be distributed to schools during the summer term and letters would be sent to schools shortly in that regard.

#### RESOLVED that:-

- (a) the new Denbighshire Agreed Syllabus for Religious Education be adopted;
- (b) the Local Education Authority (LEA) advise schools of the new Denbighshire Agreed Syllabus and ensure schools had copies of the document for their use, and
- (c) subject to the agreement of Flintshire and Conwy SACREs the new Agreed Syllabus document include the logos of all three LEAs to reflect the collaboration arrangements and save on associated printing costs.

In closing the Chair thanked the Inspector/Adviser RE, Clerk to SACRE and the Council's Translator for their hard work.

The meeting concluded at 11.55 a.m.

#### 1. Background:

Following visits by the Inspector/Adviser RE to each of the schools during the spring term, a report of the visit and issues and outcomes was agreed with the school. There follows the Good Features, Shortcomings and Recommendations for each school, and a general summary of the whole consortium.

#### 2. Excerpts from the School Visits:

#### a) Glan Clwyd High School

The monitoring visit for this school was being carried out by the Adviser from Cynnal, and the report on the visit has not yet been received.

#### b) Ysgol y Llys

#### Good features

- The recent Inspection Report on RE

- Range of activities and engaging approaches to teaching and learning
- Monitoring process clear and effective
- Provision for acts of collective worship

#### Areas for Development

As with all monitoring, following the visits by the Inspector/Adviser RE to each of the schools during the spring term, a report of the issues and outcomes was agreed with the school. There follows the Good Features, Areas for Development and Recommendations for each school, and a general summary of the whole group of these schools.

#### 2. Excerpts from the School Visits:

#### a) Ysgol Bryn Clwyd, Llandyrnog (Denbigh HS Consortium)

#### Good Features

- The subject self-evaluation and its clear identifying of areas for development.
- The comprehensive policy for RE
- The use of Key Questions and Concepts in the KS 2 Scheme of Work
- The security of the subject in the timetable.

#### Areas for Development

- Religions other than Christianity in the scheme (\*)
- The use of ICT in teaching and learning in RE (\*)
- Sharpening the focus on key aspects/questions in the scheme (\*)
- Assessment and recording of achievement (\*)
- Greater linkage of taught curriculum with everyday life (\*)
- Ensure compliance with the statutory requirement for daily collective worship

#### <u>Recommendations</u>

- Develop a structured approach to Christmas and Easter within the revisions to the scheme of work.
- Widen out the range of teaching and learning approaches, and especially include opportunities for pupils in Years 5 and 6 to express their own responses and ideas to the topics they are studying.

#### Good Features

The school were confident that standards were Grade 3: Good features outweigh shortcomings, moving towards Grade 2: Good features and no important shortcomings, given the work in hand. It was not possible to confirm this judgement during the visit.

#### e) Ysgol Pant Pastynog (Denbigh High School Consortium)

#### Good Features

- Provision for collective worship is sound, and the experiences offered are reverent and meaningful.
- The self evaluation document clearly identifies strengths and areas for development; these seem appropriate and manageable.
- Links with the local faith community are positive and contribute to both collective worship and RE within the school.
- There is a good range of different styles of working and learning in pupils' books.

#### Areas for Development

- Enhancements to the scheme of work to include more of Islam, and to reflect the new approach in the new Agreed Syllabus (\*)
- Assessment of pupils achievement.

#### <u>Recommendations</u>

- Maintain the good practice identified.
- Carry out the proposed revisions to the scheme as identified in the self evaluation document.
- Prepare to record teacher assessments on pupil achievements as the scheme is amended and adapted to the new Agreed Syllabus.

#### <u>Standards.</u>

In one school it was not possible to make a judgement on standards from the work reviewed, but the school is due to be inspected. In one school a small sample of work was available and seemed to confirm the school's clear view that standards are Grade 2 (Good features with no important shortcomings) Three schools, who were all judged as Grade 3 (Good features outweigh shortcomings) in their last inspection felt that they were now moving towards Grade 2, although it was not possible to confirm this judgement during the visit. At the last inspection of one school in 2003 standards were satisfactory. The school is now confident that given to the changes to their scheme of work and delivery of the subject standards would now be judged as Grade 2. It was not possible to confirm this judgement during the visit. In one school they were confident that pupils were given the opportunity to develop and achieve their potential in RE. Although not possible to confirm this as such from the sample of books available, there was clear evidence of the subject being secure in the timetable and appropriate approach to the teaching and learning. As the scheme develops in line with the revised curriculum and Agreed Syllabus, the potential for this to be more fully and clearly achieved is there.



### 8. Presentation from Christian Education – <u>Tackling Tough Issues Project</u> The Chair welcomed Professor Russell Stannard and Mr.Peter Fishpool from CEO Christian Education.

Mr. Fishpool explained the background to the project as having been produced for use in RE in Secondary settings and it deals with difficult areas in life. Students were given opportunities to discuss and explore these important issues. An information sheet was distributed ( a copy is enclosed with these minutes) The charity, Christian Education has one 'branch' called RE Services, and also has the National Society of Teachers of RE in England as part of the charity. There are 4,000 subscriptions to the magazine made up of individuals, schools and SACREs. They are constantly on the lookout for new partners to work with in order to produce good resources. The Templeton Foundation had sponsored the Tackling Tough Questions project, which included an 85mins DVD, a teacher's book. questions for discussion and various activities. The project had been trialed in schools and refined before publication.

Professor Stannard spoke of two main reasons why people have problems with religious concepts :- a perceived conflict between religion and science and how God allows evil, suffering and death. Professor Stannard introduced himself as a scientist who is a licensed lay minister in the church of England. He emphasised that the project is not to make converts but it is to give two sides to an argument, it is Religious Education not Religious Instruction. The DVD follows the format of short exchanges between a believer and a non-believer (the listener is never told the faith origin of either person), then a quote from the presentation is used as a still picture to allow time for students to discuss the issues. Members watched some clips from the DVD and were then invited to take part in one of the group activities. The name of the Association shall be the Wales Association of SACREs (hereinafter called "the Association").

#### 2. The Aims of the Association

(i) To provide a forum in Wales for SACREs to discuss concerns and as necessary make representations to other bodies;

(ii) to enable co-operation between LEAs and their SACREs and Agreed Syllabus Conferences in pursuing common interests in the development of the religious education curriculum and collective worship;

(iii) to assist SACREs in fulfilling their responsibilities by the sharing of experience and expertise;

(iv) to undertake any other activities which may benefit religious education and collective worship in Wales.

3. Membership and Duties
(i) Each SACRE in Wales is eligible to be a member of the Association.

(ii) Each SACRE shall be invited to pass a resolution recommending its LEA to support membership of the Wales Association of SACREs.

### CONSTITUTION - Y CYFANSODDIAD

(As revised 26/6/08) - (Adolygwyd 26/6/08)

#### 1.. Enw'r Gymdeithas

Cymdeithas CYSAGau Cymru fydd enw'r Gymdeithas - (yma, "y Gymdeithas" fydd hi'n cael ei galw o hyn ymlaen.)

#### 2. Amcanion y Gymdeithas

(i) Ymorol bod fforwm yng Nghymru ar gyfer y CYSAGau, i drafod materion o bwys iddynt, ac i ddwyn achosion i sylw cyrff eraill pan fo gofyn;

(ii) hwyluso cydweithredu rhwng Awdurdodau Addysg Lleol, eu CYSAGau a Chynadleddau Maes Llafur Cytunedig, o ran mynd ar drywydd diddordebau cyffredin ynglyn a datblygu cwricwlwm addysg grefyddol ac addoli ar y cyd;

(iii) helpu'r CYSAGau i gyflawni eu gorchwylion trwy rannu profiad ac arbenigedd;

(iv) ymroi i unrhyw weithgareddau eraill a ddichon fod o fudd i addysg grefyddol ac addoli ar y cyd yng Nghymru.

3. Aelodaeth a Dyletswyddau

(i) Mae pob un o GYSAGau Cymru'n gymwys i fod yn aelod o'r Gymdeithas.

(ii) Bydd pob un o'r CYSAGau'n cael ei wahodd i basio penderfyniad yn argymell bod ei A A Ll yn cymeradwyo ymaelodi a Chymdeithas CYSAGau Cymru (iii) The Association shall meet three times annually.

(iv) Extraordinary meetings of the Association may be called by the Chairperson or at the request of a member SACRE. The Chairperson, in consultation with the other officers, may alter arrangements for meetings of the Association in an emergency.

(v) Each member SACRE shall be entitled to send up to four representatives, which may include professional representation, to meetings. Each SACRE will be entitled to one vote.

(vi) A meeting of the Association shall be deemed to be quorate when not fewer than one third of member SACREs are represented.

(vii) Any proposal to amend the constitution shall be communicated to SACREs at least four months prior to the AGM at which any such amendment will be considered. The AGM shall be held as part of the Association's summer meeting.

(viii) The Association can if it so wishes invite bodies to have observer status in the Association. Such observers can only speak with the permission of the Chairperson.

(ix) At a meeting of the Association, any members of the SACRE, whose LEA or Council is hosting the meeting, shall be entitled to attend the meeting as observers. (iii) Bydd y Gymdeithas yn cyfarfod deirgwaith y flwyddyn.

(ix) Bydd hawl gan unrhyw aelodau o'r CYSAG sydd a'u AALl neu Gyngor yr un sy'n croesawu'r cyfarfod hwnnw i fod yno fel sylwedyddion

#### 4. Officers of the Association

These shall be elected and/or (i) re-elected at the AGM and shall comprise: (a) the Chairperson (b) the Vice Chairperson (c) the Secretary (d) the Assistant Secretary (e) the Treasurer. The member SACRE to which the Secretary belongs shall normally be responsible for providing Secretarial support during the Secretary's term of office. No one SACRE may provide more than one officer in any one year. No one Chairperson may hold office for more than two consecutive years. When a Chairperson ceases to hold that office the Vice Chairperson shall succeed to it, subject to the requirement in para 4(ii).

(ii) If an officer is no longer a member of or associated with a SACRE, he or she shall cease to hold that office immediately. A replacement will be appointed at the next meeting and will serve until the AGM. If there is urgent need for a replacement the Executive Committee is empowered to make an appointment which will be effective until the next meeting of the Association.

(iii) There shall be an Executive Committee, which shall consist of the following:

a) the Officers, who shall be a Chairperson, a Vice-chairperson, a Secretary, an Assistant Secretary and a Treasurer.

b) six members elected from representatives of member SACREs other than those from which the Chairperson and Vice-chairperson have been nominated.

c) the immediate past Chairpersond) the immediate past Secretary

e) a representative of NAPfRE

and f) WASACRE's representative to the RE Council of England and Wales With the exception of the Secretary, Assistant Secretary and Treasurer, no one SACRE may provide more than one member of the Executive in any one year.

iv) The Executive Committee will only have executive powers which have been delegated to them at a meeting of the Association. The quorum shall be five and the majority vote will count.

(v) If a member of the Executive is no longer a member of or associated with a SACRE, he or she will cease to be a member of the Executive. The SACRE which he or she represented will be entitled to nominate a replacement member of the Executive, who will serve until the AGM.

(vi) In the absence of the Chairperson, the Vice Chairperson, if present, shall take the Chair. Otherwise the first business of the meeting shall be to elect a member to the Chair for that meeting. However, if the Chairperson or Vice-Chairperson arrives during the meeting, the Vice Chairperson, or the member in the Chair shall relinquish it once the item of business in hand has been completed. (a) The Chairperson will move "that the minutes of the last meeting be signed as an accurate record".

(b) The only part of the minutes which can be discussed is their accuracy. Any question about their accuracy must be raised by motion and as soon as it has been dealt with the Chairperson is authorised to sign the minutes.

ii) Any member SACRE may include an item on the Agenda for meetings of the association without the requirement for it to be seconded. Any motion moved at the meeting must be seconded.

(iii) In the event of a vote being required on any proposal each member SACRE shall have one vote and a decision reached by a simple majority. The Chairperson will have a casting vote.

(iv) Meetings and correspondence shall be conducted bilingually.

(v) Any other matters, of which notice has been given, may be added by the Chairperson.

Dear colleagues,

The last meeting of the Association, held in Carmarthen on 14<sup>th</sup> March 2008, was probably the least well attended for some time. There were a significant number of SACREs and LEAs that were not represented at all. This was very disappointing, especially as we had, as part of the agenda, outside providers who were informing SACREs and teachers in Wales of new initiatives and resources for Religious Education.

All member SACREs are well aware that the strength of the Association has been that all twenty two SACREs in Wales are paid up members, and that therefore the Association speaks on behalf of all of them. It would be a shame if it were to be thought less so, because attendance at meetings was becoming noticeably less well representative.

It is of course recognised that illness and sometimes unexpected events do detain people from attending, but the attendance was very low in Carmarthen, and there were no apologies from a number of SACREs where there were no representatives either. Given that the dates and venues of meetings are known and published quite well in advance, it was doubly disappointing.

At the meeting, I was asked to write to all SACREs and ask for a real effort to be made to send representatives to the meetings. As the next meeting is the Annual General Meeting as well, perhaps SACREs could make a special effort. The AGM is in County Hall, Mold, Flintshire on June 26th.

I was also asked to remind member SACREs that they are entitled to send three representatives, and that discussions had been raised in previous meetings about trying to encourage greater teacher representation at the meetings, and requesting of LEAs to pay for supply cover for teacher representatives to attend.

It would be helpful therefore, if this letter could be drawn to the attention of SACRE members, and that the attendance at the next and future meetings of WASACRE be more representative of the twenty two SACREs, and of the committees within the SACREs.

#### Religious Education in the 14 – 19 Curriculum

At the last meeting of the Wales Association of Standing Advisory Councils for Religious Education (WASACRE), members asked that I write to you, through the local SACREs. The Association is the voice for all twenty two SACREs in Wales, and meets termly; and as you know the SACREs are the statutory bodies responsible for the RE Curriculum in their areas.

You are no doubt fully aware of the statutory nature of Religious Education in the school curriculum, and that it is a requirement for the subject to be taught according to a locally Agreed Syllabus for Religious Education right up to and including age 19 (\*). All twenty two SACREs and LEAs in Wales have agreed to use *The National Exemplar Framework for Religious Education for 3 to 19-year-olds in Wales*, recently published by DCELLS, as their Agreed Syllabus, or as the basis of their Agreed Syllabus.

Given the responsibility for the 14 - 19 Networks in terms of the school curriculum, and the statutory responsibility of the SACREs for the monitoring of the provision and delivery of RE within their schools, it would seem pertinent and desirable for some discussion and contact between the two groups to take place. It was felt by members that a letter from WASACRE encouraging this dialogue and relationship to begin to take place would be helpful.

WASACRE has raised the issue of Post 16 RE with the Minister, and is - in partnership with DCELLS - arranging a national conference on 4<sup>th</sup> October 2008, where the Minister will be giving the key note speech. The Conference is designed to raise the profile of RE at this phase of education, and all delegates will be given copies of resources specially prepared for Post 16 RE, and a range of other helpful and stimulating materials. The Association has also been in discussion with the General Teaching Council for Wales, and has initiated a number of teacher sabbaticals for teachers to enhance their skills and professional development and produce innovative materials for delivering RE in Post 16 settings. These will also form part of the bilingual pack given to all secondary schools (with sixth forms) in Wales. FE Colleges are also being invited to the conference.

I trust therefore that you will seriously consider the issue of making arrangements to have dialogue and connection between yourself and your local SACRE in the matter of RE within the 14 - 19 curriculum.
