#### STANDING ADVISORY COUNCIL FOR RELIGIOUS EDUCATION (SACRE)

Minutes of the Standing Advisory Council for Religious Education (SACRE) held in the Council Chamber, County Hall, Ruthin on Wednesday, 8<sup>th</sup> October, 2008 at 2.00 p.m.

#### SILENT REFLECTION

The meeting began with a few minutes silent reflection.

#### 1 URGENT MATTERS

No items were raised which in the opinion of the Chair, should be considered at the meeting as a matter of urgency pursuant to Section 100B(4) of the Local Government Act, 1972.

#### 2 MINUTES

The Minutes of a meeting of the Standing Advisory Council for Religious Education (SACRE) held on Wednesday, 18<sup>th</sup> July, 2008 were submitted.

Accuracy:-

(a) Matter Arising – The Head of School Improvement explained that he felt the minute had not fully reflected his comments in respect of areas of poor performance

in RE and referred to the Estyn Report which had criticised the Authority for not earmarking resources. He explained that reference had been made to Key Stage 4, however, he had met with the respective advisers and all performance issues generally would be addressed within all schools and resources would be prioritised in respect of need.

The Head of School Improvement referred to the disappointment expressed that no representative from the local education authority had been in attendance at the meeting. He apologised for his and the Corporate Director Lifelong Learning's absence and explained that the Authority had been represented by the Inspector/Adviser RE.

#### Matters arising:-

(b) Matter Arising – The Inspector/Adviser RE informed Members of the Committee that the Agreed Syllabus together with a Comprehensive Guide to RE, which contained advice and support to schools and guidance for their schemes of work, had been circulated to all schools within the three Authorities and had been very successful and well received.

Reporting on Assessment in RE - The Inspector/Adviser RE referred to the need for the introduction of a process for the receipt of information from schools in respect of teacher assessment, and the number of pupils achieving at different levels, by the LEA and SACRE.

Members agreed that a trial run be at undertaken at the end of the current school year with the introduction of the process on a permanent basis the following year.

- (b) Provision of Religious Education: Outstanding Schools The Head of School Improvement referred to the future monitoring process in RE and collective worship in schools. He explained that although reference had been made to affording priority to Key Stage 4 and secondary schools, the monitoring process would be applied to all areas.
- (b) Nominations for the Executive Committee of the Wales Association of SACREs and proposed revisions to the Constitution Mrs M.B. Lloyd informed the Committee that Vicky Thomas and Eirian Pierce had been appointed to the Executive Committee.

**RESOLVED** – that, subject to the above, the Minutes be received and approved as a correct record.

#### 3 PRESENTATION: RE IN GELLIFOR SCHOOL

The Chair introduced and welcomed to the meeting Kate Dowell, of Ysgol Gellifor who was in attendance to deliver a presentation on the provision of Religious Education and collective worship at the school.

Mrs Dowell thanked Members of the Committee for her invitation to the meeting and referred to the period of change in respect of the Schools-based Curriculum

Development, particular reference having been made to the foundation and skill phases.

With the aid of a powerpoint presentation, Mrs Dowell provided an in depth summary of the following issues and points of interest in respect of Ysgol Gellifor:-

Planning for Religious Education Collective Worship The New Curriculum 2008 Development of ICT Specifically RE – Skills Range Staff Interests at Ysgol Gellifor Details of the Ysgol Gellifor web-page

In reply to a question from Mr R. Hayward regarding visitors to Ysgol Gellifor, Mrs Dowell highlighted the need for information on local contacts and the provision of a resource list. The Inspector/Adviser RE explained that difficulties had been experienced when endeavoring to produce a list, however, he explained that Mrs Dowell could contact his office for assistance.

In response to a question from Mrs S. Harris regarding the Christian Centre at Bala, the Chair explained that he had been involved in the running and operation of the Centre and provided detailed background information. He informed the Committee that the Centre was open to all denominations but was primarily available to young people and children who wished to deepen and develop their effectiveness in Christianity, particular reference was made to the opportunity afford to primary schools to learn the story about Easter.

The Chair thanked Mrs Dowell for her informative and effective presentation which had provided an insight to the work undertaken at Ysgol Gellifor.

**RESOLVED** – that the presentation on RE in Ysgol Gellifor be received and noted and a letter of thanks be sent to the school on behalf of SACRE.

#### 4 PRESENTATION: DENBIGHSHIRE 14 – 19 LEARNING NETWORK

Reference was made to the meeting of SACARE held on the  $18^{th}$  July, 2008 when it had been agreed that the letter from WASACRE about making links with 14-19 Learning Networks be forwarded to the 14-19 Learning Network Coordinator in Denbighshire, along with an invitation to make a presentation to SACRE.

The Chair introduced and welcomed to the meeting John Gambles who was in attendance to deliver a presentation on the remit and working procedures of the 14 – 19 Learning Network and explained that the opportunity had been afforded to Members to explore with the Coordinator ways in which SACRE might work in association with the Network in relation to Religious Instruction.

Mr Gambles thanked the Committee for inviting him to the meeting. He provided details pertaining to the Learning Core: Guidance on planning, implementation,

assessment and accreditation and explained that the Learning Core was one of the 6 Key elements of Learning Pathways which included:-

- Individual Pathways
- Wider curriculum choice
- The Learning Core
- Learning support
- Personal Support
- Careers Education and Guidance

Members of the Committee were informed that the major emphasis within the Learning Core for networks had been, and remained, Work Focused Education although the Core did encompass other attributes which were highlighted by Mr Gambles.

An outline of the remit and working procedures of the 14–19 Learning Network was provided by Mr Gambles, together with, the work undertaken by the 14 – 19 Strategy Group. He suggested that SACRE may wish to submit a nomination for a representative to serve on the Strategy Group, as a means of strengthening links and enhancing working relationships in association with the Network. The Committee sought nominations for a representative and Mrs M.B. Lloyd was proposed and seconded to represent SACRE on the 14-19 Strategy Group for the ensuing year.

In response to questions from Mrs M.B. Lloyd regarding difficulties in securing placements, and the provision of placements for disabled persons, Mr Gambles confirmed that there were 64 placements annually and that they had worked closely with Ysgol Tir Morfa, Rhyl and Rock House, Denbigh. Mr R. Hayward explained that with regards to his school pupils remained in main stream education.

#### **RESOLVED** – that

- (a) the presentation on the remit and working procedures of the 14 19 Learning Network be received and noted;
- (b) Mrs M.B. Lloyd be nominated to represent SACRE on the 14-19 Strategy Group, and
- (c) a letter of thanks be sent to the Network Coordinator on behalf of SACRE.

#### **5 DRAFT ANNUAL REPORT 2005 - 2006**

The Inspector/Adviser RE submitted a draft of the Annual Report on Denbighshire SACRE for the previous academic year, circulated previously, which provided a detailed summary of Denbighshire SACRE's activities during the year 2007/2008 including the Agreed Syllabus, Standards in Religious Education, Collective Worship/SMSC Development, INSET Provision and various other issues.

It was explained that the Annual Report had been prepared in accordance with the guidelines provided by DCELLS for submission by the end of the year. Members

were informed that, when finalised, the report would be translated and distributed to all schools, colleges in Denbighshire, and any other recipients as requested by law and identified in the report. The Inspector/Adviser RE informed Members that electronic copies would also be made available and sent to the respective recipients.

Mr R. Hayward referred to Page 19 of the Analysis of Inspection Reports and questioned the figure of 0.5% in respect of Blessed Edward Jones School, Rhyl.

The Head of School Improvement informed Members of the Committee that future Annual reports would provide details relating to the effectiveness of targeted reports.

The Chair and Committee Members expressed their appreciation for the working undertaking in preparing the report and it was requested that the positive and encouraging content of the report be noted.

#### **RESOLVED** – that

- (a) the Annual Report of the Denbighshire SACRE for 2007/2008 be received, and
- (b) the Local Education Authority be requested to prepare and distribute the report.

#### 6 ANALYSIS OF ESTYN INSPECTION REPORTS ON SCHOOLS

A copy of a report by the Inspector/Adviser RE, which provided an analysis of the results of the recent inspections of three schools in the provision of Spiritual, Moral, Social and Cultural Development (SMSC) and Religious Education where it had been part of the inspection, had been circulated with the papers for the meeting.

Inspections had been carried out at Ysgol Caer, Derwen, Ysgol Y Castell, Rhuddlan and Ysgol Penmorfa, Prestatyn and a brief history of the background of each school had been incorporated in the report.

The Inspector/Adviser RE provided a summary of the findings pertaining to each of the respective schools. He explained that Religious Education had not been inspected by Estyn at any of the three schools under the current inspection arrangements. The positive aspects of the reports, in respect of Spiritual, Moral, Social and Cultural Development, had been highlighted and the Inspector/Adviser RE had been pleased to report that there had been 59 positive comments and only one negative comment.

Details pertaining to the recent review of the Inspection process were provided by the Head of School Improvement. He explained that there would be a consultation soon on the issues of Inspection teams in future being lead by H.M. Inspectors and that the 7 Key questions would in future being reduced to 3.

Mrs M.B. Lloyd explained that the positive nature of the reports had provided confirmation of the emphasis placed by schools on the spiritual, moral, social and cultural development of pupils.

The Chair and Members of the Committee expressed their congratulations to the three schools on the very successful and positive nature of the reports.

#### **RESOLVED** – that

- (a) the report be received and noted, and
- (b) the Inspector/Adviser RE write to the respective schools congratulating them on the positive nature and findings of the reports.

#### 7 WALES ASSOCIATION OF SACRES

(a) A verbal report from Members who attended the meeting and AGM of the Association held in Mold on the 26<sup>th</sup> June, 2008

A copy of the draft minutes of the Welsh Association of Standing Advisory Council for Religious Education (WASACRE), held in Mold on the 26<sup>th</sup> June, 2008, was circulated to Members of the Committee at the meeting.

Mrs M.B. Lloyd explained that the meeting had been very successful and informative, however, difficulties had been experienced in respect of car parking provision. Mrs Loydd invited Members attention to Item No. 7, Presentation, on Page 6 of the minutes, and explained that the work of Careers Wales involved the provision of assistance for both employers and employees. She also referred to a number of practical examples of placements which covered the Liverpool Faith Trail and the multi-faith centre at Ysbyty Gwynedd, Bangor.

Reference was made by the Inspector/Adviser RE to the over provision of refreshments as the conference would be hosted in by Denbighshire in 2009. Mrs Lloyd explained that many of the Members attending the meeting may have been unaware of the provision of refreshments.

**RESOLVED** – that the draft minutes of Welsh Association of the Standing Advisory Council for Religious Education (WASACRE), held in Mold on the 26<sup>th</sup> June, 2008, be received and noted.

(b) A verbal report from Members who attended the meeting and AGM of the Association held in Mold on the 26<sup>th</sup> June, 2008.

The Inspector/Adviser RE informed the Committee that the conference had been very successful and that the facility of a video link between North and South Wales had been utilised for the first time. He confirmed that the conference had been well attended, however, expressed his disappointment at the lack of representation from senior management of many schools and of a low number of Welsh Medium schools.

He referred to the importance of raising the profile of RE and quality resources to schools, and details pertaining to the information packs obtained at the conference were provided for Members of the Committee, with an assurance

that all schools would be receiving the documents, apart from the Advance Copy of the DCELLS Guidance for RE 14 – 19 which was a conference edition.

**RESOLVED** – that the draft minutes of Annual General Meeting of the Welsh Association of the Standing Advisory Council for Religious Education, held in Mold on the 26<sup>th</sup> June, 2008, be received and noted.

#### 8 VISIT TO UGANDA

The Inspector/Adviser Re delivered a powerpoint presentation, Headed Building Hope – A Shared Experience, which provided a day by day detailed description of his recent visit to Uganda as part of a delegation visiting schools and communities. Places and destination visited included:-

- Sun Rise Village
- St Jude's Primary School, Lukaya
- Hope Destiny Childrens' Centre, Lukaya
- Little Angels Nursery and Primary School, Bubeberre

The powerpoint presentation provided a series of photographs of the time spent in Uganda and the activities and charity work undertaken. The Inspector/Adviser Re provided a detailed summary of the activities undertaken which included practical assistance and the provision of funding for development and building works, the provision of mattresses, bedding, lighting, sports equipment and clothing, the sponsorship of students. He also informed the Committee that during the visit he had conducted a wedding ceremony and had been whitewater rafting on the River Nile.

In reply to suggestions from Mrs C. Harmsworth, the Inspector/Adviser Re agreed that the possibility of the provision of solar panels to provide energy for lighting equipment could be examined and attempts to establish links with the Technology Centre had been unsuccessful, however, successful links had been established with Redrow.

The Chair thanked the Inspector/Adviser Re for the presentation and for sharing his experiences with the Committee and paid tribute to the charity wok being undertaken.

**RESOLVED** – that the presentation by the Inspector/Adviser Re be received and noted.

#### 9 DATE OF NEXT MEETING

The Chair reminded Members that the next meeting would be held at 10.00 a.m. on Monday, 2<sup>nd</sup> February, 2009 in the Council Chamber, County Hall, Ruthin.

Ysgol Pentrecelyn is located about four miles to the south of Ruthin. It is a natural bilingual school. The catchment area extends to about 10 miles with a significant number of pupils being transported to school daily by taxi. The pupils' backgrounds and their attainment on entry into the school represent the full range of circumstances and attainment. No pupil is registered as entitled to free school meals. Up to 44% of pupils come from Welsh speaking homes. The school's baseline assessments broadly match the county average.

Currently there are 22 pupils on the schools register from reception age to year 6; there are 7 children attending the nursery part time. #ten pupils have been identified with Additional Learning Needs. There are no pupils in the school receiving support for English as an additional language. The Local Authority looks after one pupil. As well as the head teacher who has class responsibility for three days of the week, there is one other full time teacher. Additionally there is one part time teacher.

Heulfre Junior school is situated in the small county town of Denbigh. Pupils who attend the school come mainly from the large estate adjacent to the school, which comprises predominantly of council-owned properties. The Catchment of the school is a Community First area, with a high level of deprivation. A small number of pupils travel from outside the town. There were 78 pupils on roll, between the ages of 7 and 11, and they are taught in four single-age classes. Numbers have decreased since the last inspection. Thirty-three pupils are identified as having special educational needs (SEN) which at 42% is above the average for other schools in Wales. Four pupils have formal statements of SEN. One pupil has been excluded from the school on a temporary basis in the past twelve months. 35% of pupils are entitled to free school meals, which is above the national and LEA averages. English is the home language for 100% of the pupils; no pupils speak Welsh as their first language.

The school has achieved the Basic Skills Quality Mark on two occasions, the first phase of the Healthy School's scheme and Investors in People status.

All year groups are involved in various international links, including raising funds to support a Ugandan boy to receive full time education. (Heulfre).

#### Programme for /impact of PSE provision

The school gives appropriate consideration to the Personal and Social Education Framework (*Pentrecelyn*)

Planning for personal and social education (PSE) is good, with all aspects incorporated successfully into pupils' experiences across the curriculum (Heulfre)

Pupils' awareness of the dangers of drugs and substance abuse is well promoted though many aspects of the curriculum and through talks by visitors such as the police liaison officer or the school nurse (*Heulfre*).

### Knowledge/understanding/awareness of other cultures and traditions 2 schools

Pupils deal with different cultures and religions in a mature and conscientious way (Pentrecelyn)

The curriculum is effective in ensuring that the pupils become aware of their own and other cultures. This is achieved well through subjects such as art, religious education, history and geography, and through participation in folk-dancing events. Visits to eisteddfodau, mosques, churches, and museums successfully promote pupils' respect for diversity of cultures, beliefs and background, both within Wales and beyond. (*Heulfre*).

The Curriculum Cymreig pervades the work of the school in a number of subjects and fully meets the requirements. There is a very good emphasis on studying the heritage of Wales and give pupils experiences that contribute to Welsh culture (*Pentecelyn*)

The school successfully promotes *Y Cwricwlwm Cymreig* through the inclusion of important aspects of Welsh history, both locally and nationally. Pupils make residential visits to Glan Llyn, which further promote their understanding of Welsh culture. The pupils' involvement in establishing a Welsh Heritage Trail is an outstanding feature of promoting an understanding of the locality and its environment. (*Heulfre*).

There is a good range of bilingual posters around the school, and pupils are rewarded through the use of Tocyn laith (Language Tokens) for their use of spoken Welsh. (Heulfre).

#### Awareness and promotion of sustainable development

Good attention is given to sustainable development. An Eco-Committee has been established, and the school has been awarded the Bronze Flag. There are plans to establish a garden in the school grounds and money has been allocated to this. A wild garden has long been established. These activities enhance the work followed by pupils in the classrooms, bringing relevance and reality to many subjects. (*Heulfre*) Visits to eisteddfodau, mosques, churches, and museums successfully promote pupils' respect for diversity of cultures, beliefs and background, both within Wales and beyond. (*Heulfre*).

#### Awareness of the local environment and heritage

The school is highly effective in extending pupils' awareness of their environment through their involvement in activities such as the Heritage Trail.

This involves pupils in practical work around the locality, including studying the history of the local hospital and the development of Denbigh. These environmental activities are outstanding features of off-site provision, which effectively extend the quality of the classroom curriculum. (Heulfre)

#### Observance/promotion of values/good manners/respect 1 school

The school provides good opportunities to develop a sense of moral responsibility in the pupils. For example, many pupils are encouraged to support and guide younger pupils around the school. These initiatives successfully develop pupils' understanding of how to contribute positively towards establishing a sense of belonging to a community (Heulfre)

#### Links with/involvement in the local community

Pupils' awareness of the dangers of drugs and substance abuse is well promoted though many aspects of the curriculum and through talks by visitors such as the police liaison officer or the school nurse (Heulfre). These links are used effectively to develop teaching and learning (Heulfre). The successful partnership with various individuals and organisations, such as the church, community police, emergency services and the school nurse have a positive effect on pupils' personal development and the tackling of social disadvantage. (Heulfre).

	Page 8ff, point 9: The Chair and members thanked Gavin for the work and success of the post-16 conference.
6.	6. Correspondence Correspondence was received from Christine Abbas on two matters. Due to the correspondence being received after the autumn term Executive Committee meeting, the correspondence would be included in the following Executive meeting.
7. Cyflwyniad	7. Presentation: Building Learning Power  A presentation was given by Laura Burridge from Michaelston Community College, Cardiff, entitled 'Building Learning Power in RE: improving collaboration and group work skills'. Handouts were distributed to members.  Overview: 'Building Learning Power' is a major professional development programme taking place in Cardiff which aims to help young people become better learners, and it was part of a GTCW funded enquiry. Building learning power has the potential to raise achievement, improve behaviour, increase motivation,
	enjoyment and creativity in learning, and establish habits of value for lifelong

learning. Michaelston Community College has high levels of social and economic disadvantage, supported by statistics relating to free schools meals and the SEN register. The presentation focused on the employment of BLP and its positive results with a year 8 class and a year 9 class. Members were introduced to the methodology employed, teaching approaches, and activities relevant to BLP. WASACRE members participated in one such activity. Although the presentation focused on the use of BLP in RE, it was emphasised that it was important for BLP to be viewed from a whole-school perspective.

Cardiff LEA hoped that all schools in the Authority would be able to have BLP training.

8.

8. Presentation: Exemplification of the **RE Framework.** Denize Morris, Subject Officer for RE at DCELLS updated members on the progress of the exemplification material for the RE framework. Copies of the 14-19 guidance document were made available at the meeting, summarising the possibilities for schools (the same guidance document was also shared with those attending the post-16 conference in October). The document presents a range of models for timetabling statutory RE, from standard provision to others, following various learning pathways. Case studies illustrating different timetabling models were explored. It was emphasised that RE is an essential part of education for 14-19 year olds and the guidance shows the various ways in which it can be implemented.

With regard to the KS2 and KS3 guidance, it was hoped that a draft copy would be made available in the new year and that there would be a dissemination event. The focus of the guidance is the skills-based approach, showing how to implement the three inter-related core

skills. It was emphased that this is different from a content-based approach and would take time to embed. However, in order to realise the skills, pupils should be working with content in more depth than before.

With regard to assessment, the whole work of the pupil had to be assessed throughout the key stage, and then a rounded judgement made of the skills and levels achieved by the end of the key stage.

The aim of the current work is to produce guidance on the framework and also materials to support the framework. The following DCELLS sponsored materials were introduced:

- (a) World Faiths Today series for key stage 2 pupils which starts from beliefs, teachings, and practice, while including fundamental questions.
- (b) *Important Fundamental Questions* series which starts from fundamental questions while including beliefs, teachings, and practice.

Both resources are important for a skills-based approach to RE.

- (c) Three DVD resources:
  - i. two DVD resources to support the Important Fundamental Questions series (see above), which includes interviews, games, etc. based around fundamental questions. The first part of the resource should be available in the spring term (on forgiveness and faith). Members were shown a clip from the draft 'What are the benefits of forgiveness?' section, exploring the theme from different faith perspectives. The second part of the resource will concern suffering, searching for meaning, and a case study of a reformed criminal. The resources will be available through the medium of Welsh and English.
  - ii. a third DVD was launched at the post-16 conference in October called

BBC e-clips. This is a large resource designed to support 14-19 RE, and is closely related to young people's lives and the World of Work. An information booklet accompanies the DVD which includes lesson plans and other material. Members viewed a catering clip which illustrated how understanding religions was essential to the world of work. Welsh and English medium versions of the DVD and information booklet will be available, and given free of charge to all secondary schools in Wales.

Other new DCELLS sponsored materials appearing in 2009 include foundation phase books, pack on the slave trade, KS2 active learning pack, KS3 thinking skills, and translations of GCSE materials.

(d) Publication of guidance for RE in the Foundation Phase is planned for the future. In addition, a chief moderator (and assistant) would be appointed to help schools at key stage 3 to develop portfolios for assessment in RE and application of the Levels (this would be done in pilot schools).

Denize Morris said that she was looking for examples of good practice in thinking skills, and asked members to report any examples to her. She concluded by expressing the hope that the collaborative work between DCELLS and WASACRE would continue.

The Chair thanked Denize Morris for her presentation. Questions and comments following the presentation clarified and introduced the following points:

(a) In theory the chief moderator and assistant would be in place by September 2009 but it was a matter of prioritising. Again, in theory, if the go-ahead would be given in September, there may be an opportunity for some input in the

	autumn 2009 WASACRE meeting.  (b) The Chair announced another DVD resource available relevant to RE and the World of Work. A recording (English medium) of a presentation given by Pam Kelly, Detective Chief Inspector Dyfed-Powys Police to Trinity College students, was available on application from Vaughan Salisbury. Pam Kelly was one of the speakers in the post-16 conference.
9.	9. Report from the Executive
	Committee held on 22 September, 2008 Members received a summary of this meeting with their papers. Two additional pieces of information were provided. The date for the summer WASACRE meeting was confirmed as Wednesday, 24 June 2009, The Wild Pheasant Hotel, Llangollen. The date and brief for the meeting with the Minister, Jane Hutt, on 25 November was drawn to members' attention.

	Requests had been made for the following resources to be drawn to members' attention:  (a) two books for Hinduism by Seeta Lakhani, entitled <i>Primary Hinduism</i> (key stages 1 to 3) and <i>Hinduism for Schools</i> (key stage 4 and above).
	(b) REMW has published two new Welsh adaptations of RE Today Services publications, entitled <i>Ymchwilio i Gredoau ar Waith yn y Byd</i> and <i>Ymchwilio i Gwestiynau Dyrys</i> .  NAPfRE had suggested the titles to REMW in light of their relevance to the new RE Framework. Another REMW publication, <i>Amazing Lives</i> is a translation of a Welsh title and presents 100 stories of faith for primary pupils, supporting the Curriculum Cymreig.
	The resources are available from the Welsh Books Council and the

- Secretary for REMW, Sali Roberts. Order forms were distributed to members.
- (c) Gill Vaisey introduced her recently published resources for Foundation Phase pupils. Puddles and the Christmas Play was available in Big Book format, in English only due to the viability of producing a Welsh version in this format. However, a Welsh version will be placed on CD. It is hoped that toys will be created to accompany the resource. The Baby Birds retells a Muslim story, illustrating care for living things. The story book is printed in standard size format for the English version and comes with an visual/audio version on CD for PC and Whiteboards, Two different Welsh CD versions are available written at different levels reflecting the Welsh language needs of Welsh-medium schools and English-medium schools. Leaflets detailing these resources were distributed to members.
- (d) Attention was also drawn to the presentations set out for the meeting: Nefoedd mewn Celf and the NATRE competition.

## 11. Inspiring RE: engaging young adults in the 21<sup>st</sup> Century. Summary and evaluation.

Gavin Craigen provided members with a summary and evaluation of the WASACRE/DCELLS conference for post-16 religious education held at two venues in Wales on 4 October 2008. The Conference was different from previous WASACRE conferences insofar as it was targeted at senior management in schools and was concerned with post-16 RE.

The aims of the Conference were:

- (a) to raise the profile of RE in a setting that very often does not receive it;
- (b) to identify and proclaim the clear benefits of good and stimulating RE

- at this level;
- (c) to offer to schools and colleges, resources, ideas and guidance to enable them to review their provision and re-energise their determination to deliver quality RE.

In order to achieve these aims, presentations were made by:

- (a) Jane Hutt, Minister for Children, Education, Lifelong Learning and Skills:
- (b) Lat Blaylock, of Dare2Engage;
- (c) Pam Kelly, Detective Chief Inspector Dyfed-Powys Police;
- (d) Emyr Williams and Alice Pyke (RS Graduate students) and Funky Dragon opinions;
- (e) Professor Ian Russell, Professor of Public Health, Bangor University.

The positive contribution of each presentation was summarised and evaluated for members. Workshops were also provided, relating to the free resources given to participants. Participant responses to the day collated in feedback forms emphasised the value of the event. However, two disappointments were identified:

- (a) the number of schools and colleges not represented;
- (b) the very small representation of
  Welsh medium schools and colleges.
  The resources available at the Conference
  would be mailed to non-participating
  schools (with the exception of the 14-19
  guidance), and the bill for this would be
  paid by WASACRE. A letter would be
  included with the packs to express
  disappointment that a representative for
  each school could not be found.

Sir Richard Gwyn (the venue in north Wales) would be willing to do something like this again, if WASACRE wished.

The cost for the event to date was £13,500, but there were more costs expected. WASACRE Treasurer has

indicated that this should not pose a problem. Generous support was received towards translation costs from a range of Christian denominations in Wales, with a £800 shortfall. REMW has agreed to meet that shortfall.

Gavin Craigen was thanked again for his work in organising the Conference.

After the presentation, Bethan James (with reference to the NAPfRE meeting held on the previous day) endorsed the thanks given to Gavin Craigen and Denize Morris and the success of the Conference. At the NAPfRE meeting it was discussed whether there could be a second chance of holding the conference for those who had not attended, but realised that costs meant that it was not practical to do so. However, it was asked whether it would be possible if future DCELLS conferences relating to the 14-19 agenda could include a section within it relating to RE, for those who had not been at the October conference.

It was agreed that a letter should be sent to LEA Directors of Education about this subject so that it was on their agenda and also encouraging them to push the post-16 materials at county level.

#### 12. U.F.A.

#### 12. A.O.B

(a) As WASACRE representative on the RE Council for England and Wales, Mairwenna Lloyd criticised the Council's policy of e-mail only correspondence which resulted in her not receiving any notifications since March 2006. It was agreed that another WASACRE delegate would be appointed and this would be considered in the next Executive meeting. Gavin Craigen (another representative on the Council) indicated that he also wished to be replaced. Both representatives were thanked for their work.

(b) The Chair, Vaughan Salisbury,

(b) The Chair, Vaughan Salisbury, informed members that Trinity College had been awarded a grade 1 in a recent

Estyn inspection, and thanked all those who had played a role in this.

(c) Attendence at WASACRE meetings was raised again; it was agreed that all appropriate measures had been taken to increase attendance. The position and value of advisors representing SACREs was affirmed. Although there were more teacher representatives present at the meeting, some members commented again on the funding problems that teachers in their LEAs had experienced which affected attendance.

The Chair closed the meeting, thanking Emma Tapper, Clerk to SACRE for Monmouthshire and Wyn Hobson, the translator.

The next meeting will be held in Bridgend, Friday, 13 March 2009 (location to be confirmed).

## Meeting with the Minister, Jane Hutt, 25 November 2008 (summary of the Minister's responses)

Present: Jane Hutt, Denize Morris, Enid Davies, Vaughan Salisbury, Gavin Craigen, Vicky Thomas, Tania ap Siôn.

The responses by the Minister to the four questions posed on behalf of WASACRE by the four WASACRE representatives were as follows:

**Question 1**: Following our previous meeting in 2007, where are we with regard to: a) the change in the law for pupils over 16 years of age opting out of collective worship

b) consideration of additional vocational qualifications in RE.

In response to question 1(a) the Minister anticipated that WAG would be sending out a letter early next year (January/February) to inform schools, SACREs, ITT providers and other relevant bodies about the change in the law for pupils over 16 years of age opting out of collective worship. The Minister emphasised the importance of working in partnership with WASACRE on this matter and it was agreed that;

- a draft letter would be sent to the WASACRE Executive Committee for comment (early in the new year or before)
- advisory information would be sent separately by WASACRE to schools, SACREs, ITT providers and other relevant bodies, providing advice concerning the change in law in respect of this issue. This advice would be referred to in the Ministerial letter above.

In response to question 1(b) the Minister commented on the importance of RE in vocational contexts highlighted in the post-16 conference, 4 October 2008. With reference to the Learning Pathways and Qualifications Framework, the Minister indicated that it would be useful to explore the possibilities for credit-earning units relevant to RE for 16-19 year olds and assess their viability, however, these would not be compulsory. It was suggested that working with WJEC may be useful as well as possible links with the Welsh Bacc. Denize Morris would explore possibilities in relation to WJEC.

**Question 2**: Given the current revision of Circular 1/94 in England, what might be the timetable and the nature of any consultation with regard to the possible revision of Circular 10/94 in Wales?

The Minister emphasised the point that Wales should not be bound by what is taking place in England on this issue, and that it was not a priority at the present time in Wales. Responding to the statement that England was in the process of producing a guidance document to increase the accessibility of the Circular, and to reflect the changes in Education since 1994

the Minister accepted that Wales could consider, in light of what is produced in England, whether additional revised guidance may be useful in Wales.

Question 3: Given the Welsh Assembly Government's commitment to the key cross-cutting themes of community cohesion and equality and diversity, is the Minister willing to engage in dialogue and collaborate with the religious education community in order to enhance the potential of RE teachers to contribute to fulfilling this agenda?

The Minister commented that this was 'difficult territory', but felt that the contribution of RE to these themes could be explored further in the following ways:

- the creation of a link between WASACRE and the Department of Equality and Social Justice (Brian Gibbons). Denize Morris would share a copy of the minutes of this meeting with Brian Gibbons and establish the necessary links
- making accessible to WASACRE the draft guidance and the framework entitled *Racial Equality and Social Diversity: unity in diversity*, in which RE is referred to and plays a role
- a presentation by a representative from the Department of Equality and Social Justice at a WASACRE meeting on this theme
- a WASACRE presentation to the First Minister's Faith Communities Forum

Question 4: Would the Minister be supportive in promoting Holocaust information in Wales?

Two separate issues were established: the provision of resources in Wales in relation to the Holocaust Memorial Trust and the Lessons from Auschwitz programme (trip) in relation to the Holocaust Educational Trust.

With regard to the resources, the Minister confirmed that she was following up the accessibility of these resources for schools in Wales and their bilingual provision. Denize Morris would ask John Lloyd, who is responsible for the commissioning of resources in DCELLS, about the possibilities.

With regard to the Lessons from Auschwitz programme and the availability of the trip for pupils in Wales, the Minister was exploring if and how support could be given in 2009, but stressed that this exploration was in its initial stages. The Minister concluded that the commissioning programme was the next step.

**Additional question:** An additional question was posed to the Minister regarding the training of teachers to deliver collective worship in schools and the lack of provision within the Better Schools Fund to provide for this in the CPD context. The Minister asked for this issue to be placed on the agenda for future discussions.
