The current front elevation is untidy and cluttered with various light fittings and associated cabling fixed to the wall along with signage of no historical value. The proposals will improve the general appearance of the front elevation facing Bridge Street and in my opinion are not detrimental to the character or appearance of the listed building or Conservation Area and I have no objection to this application.

Please note there is a probability the render on the front elevation is lime based and the choice of paint for the front elevation should be carefully considered. A suitable breathable paint should be specified for the Re-painting works.

Refers to the additional information received following the Local Highway Authority's concerns on the proposals.

Plan No. 2780/1/APR/16 shows that a visibility splay of 3.0 metres x 100 metres in both directions can be achieved at the point of access to the Highway. Referring to the visibility guidelines laid out in TAN 18 Table A. The latest speed survey carried out indicates that 85% percentile of traffic travelling on the East bound are 37 mph and West bound carriageway, 42.3 mph. In accordance with TAN 18 Visibility Standards, 2.4m x 120m shall be provided. Advises that following a measurement check on site this can be achieved and therefore a suitably worded condition to ensure that this is provided should be attached.

It is mentioned in the information that the existing access will be preserved for the house and outbuildings and will be separated from the remainder of the farming land by fencing and hedge. If planning permission is granted then a suitably worded condition could be imposed to ensure that this is carried out. This would ensure that the new access would be solely used for farming vehicles and the existing for the house and outbuildings.

There has been three recorded accidents in the vicinity on Abergele Road however, these have not been related to any movements arising from the existing access, Considers that the new access is an improvement on the existing arrangements.

#### **OFFICER NOTES**

Suggested additional conditions:

- 9. No works on the construction of the access shall be permitted to commence until the written approval of the Local Planning authority has been obtained to the detailed layout, design and construction of the access and the access shall be completed in accordance with the approved details before it is brought into use.
  - Reason To ensure the formation of a safe and satisfactory access in the interest of highway safety.
- 10. A visibility splay of 2.4m x 120m shall be provided in both directions measured along the nearside edge of the adjoining carriageway over land within the control of the Applicant and / or the Highway Authority, within which there shall be no obstruction in excess of 1.05m in height.
  - Reason To ensure that adequate visibility is provided at the point of access to the highway in interest of highway safety.
- 11. The agricultural access hereby permitted shall not be permitted to be brought into use until the written approval of the Local Planning Authority has been obtained to details of a scheme to ensure the existing access off the highway serving the complex at Morfa Lodge cannot be used by agricultural vehicles. The scheme as approved shall be implemented no later than one month following the first use of the new access, and the arrangements shall be retained at all times thereafter.
  - Reason To ensure the existing access is not used by agricultural vehicles in the interests of traffic safety.

- (i) Highway Supplementary Notes Nos. 1,3,4,5 & 10.
- (ii) New Roads and Street Works Act 1991 Part N Notice.
- (iii) Highways Act 1980 Section 184 consent to construct a vehicular crossing over a verge.

You are also advised that a road traffic sign within the visibility splay will require altering/re-siting and you should contact Gail McEvoy in the Highway Section to discuss before works start on site.
