



Dear Sir/Madam  
 I am writing to object to the Denbighshire County Council's proposals to deliver both permanent and transit Gypsy and Traveller sites at Green-gates Farm East, St Asaph.

My objection is on the following grounds:

1. The proposals are contrary to the adopted Local Development Plan (LDP)

The development sites are in the open countryside where development activity should be strictly controlled, as informed by both local and nation planning policy. Policy BSC 10 of the Council's LDP relates specifically to gypsy and traveler accommodation of an established settlement boundary that have access to a range of facilities/services. The proposal sites at Green-gates Farm are located a considerable distance from St Asaph's settlement boundary and these sites are isolated with limited access to facilities and services and generally poor public transport.

The proposals therefore do not accord with the Council's own planning policy position. In addition, no justification or evidence is provided in the draft application documents to support why the development is acceptable in this location.

## Tudalen 1

### Impact on the rural character of the area

The proposed developments do not respect the character of the surrounding rural area. The proposals will lead to an urbanising effect both through the development of permanent new homes and through the significant increase in traffic movements to and from these sites. The current tranquillity of this rural setting is likely to be ruined by the proposed developments.

### 3. Impact on amenity

I've also seen the press article in the Daily Post about the local resident whose daughter suffers from the rare genetic condition Pitt-Hopkins Syndrome. It's clear that the family have very specific needs and that they have chosen to live in this area due to the quiet and peaceful nature of its surroundings that provide the best possible environment to support their daughter. The proposed development sites are to be located immediately either side of that resident's property and will undoubtedly disrupt their amenity. This is likely to have a particularly acute impact on health and well-being of the family. If earlier consultation had been undertaken or the potential sites for development had been in the public domain this issue would have been raised and known to the Council. It would also have been apparent (on researching the child's condition) that this is not a suitable location for the proposals.

### 4. Business Impact

The proposed gypsy and traveller sites are to be located in close proximity to St Asaph Business Park, especially when considering the land that has been allocated under the Local Development Plan for the future expansion of the business park.

St Asaph Business Park is an important economic asset within the County, it is one of the largest employment sites in the region, providing highly valuable working opportunities to many residents of the area. The importance of the Business Park has been demonstrated by the recent work of the North Wales Growth Board, which is seeking to attract large scale funding to help develop the business park into a specialist facility for enterprise and engineering. The aim is to deliver world leading facilities and attract advanced manufacturing jobs into the area.

However, these plans would be totally undermined through the negative implications of siting a gypsy and traveller site nearby. There is an inescapable stigma attached to Gypsy and Traveller sites and the perceptions are entirely negative.

### 5. Lack of Evidence to support the need for these sites

No evidence has been presented to show that these sites are needed. Consultation documents suggest that the need for the accommodation identified in the Gypsy and Traveller Accommodation Assessment. However, it is not possible to determine how robust the GTAA and recommendations are because a key chapter of the report that details findings has been entirely redacted under the Data Protection Act.

The validity of the identified need is therefore questionable.

While it may be necessary to redact certain elements of the GTAA purposes (e.g. names/addresses of respondents and findings etc.) it is entirely prevent any of the survey discussions and findings from being published.

### 6. Lack of Evidence to demonstrate this is the correct location for these sites

As a resident of [Denbighshire/St Asaph] I am appalled at the manner in which the Council have dealt with taking forward these proposals. There has been a lack of transparency in the decision-making process that has led to these sites as the preferred location for gypsy and traveller accommodation. Council's decision to keep all assessments of potential sites confidential prevented any public scrutiny and undermines democratic practices and principles. It also calls into question the validity and robustness of the assessments.

No evidence has been put forward with the planning application as to why these sites are appropriate for the developments. The onus is on the Council to justify that the proposals are acceptable and that the correct sites have been selected. This cannot be proven without fully demonstrating the reasons alternative sites were discounted.

I cannot believe that there are not more appropriate locations within these proposals and plead with the Council to reject these sites and alternative locations where development could more suitably take place.

### 7. The Gypsy and Traveller Sites should be dealt with through the Development Plan Process

Given that the Authority is currently reviewing its adopted Local Development Plan, the allocation of a gypsy site should be part of the current examination/review. It should be subject to public scrutiny and independent examination/review.




It is also important that the Council recognise the significance of the local community as to how these proposals have been taken forward. The matter is dealt with in a much more transparent and accountable way.
