3. Progress summary since March, including ‘kick start’ actions and timelines/tasks to the end of the financial year

Progress Summary

HVE updated the group on ‘kick start actions’ and took group through tasks progressed since March which included the following:

- Analysing the responses from the public engagement period.
- Cllr Brian Jones, Cllr Tony Thomas and Cllr Graham Timms attended 2 days training on Zero Carbon Britain delivered by Centre for Alternative Technology,
- Collating the net carbon zero baseline (2019/20)- carbon emissions and carbon sequestration.
- Completion of 2 hour workshops with all service areas on the strategy and action plan.

- Deliberate 'no cut' of c.20 street scene sites over growing season to benefit biodiversity.
- Delivering plans for constitutional change and supporting processes/documents for decisions to have regard for tackling climate and ecological change.
- Modelling carbon emissions reduction and carbon sequestration increase pathways to get to net carbon zero by 2030.
- Recruiting Climate Change Project Officer (6 month internal secondment).
- Devising options for baselining Ecologically Positive Council (2019/20).
- Supporting specification development for procuring new energy management software for buildings.
- Facilitating workshops on developing bid for Community Woodlands NLHF funding.
- Liaison with Welsh Government Energy Service, securing free consultancy to complete ULEV Fleet Transition Study for electrifying fleet and grey fleet mileage and collating and submitting data required for ULEV study.
- Supporting community consortium in their bid to Welsh Government for Circular Economy Funding to introduce and reuse repair service in Mold, Llangollen and Ruthin.
- Feasibility work and early project management for potential Tree Nursery at Greengates West.
- Presentations to the Member Area Groups- Denbigh and Elwy completed.
- Climate and Ecological Change All Member Newsletter and public Newsletter (will be produced and sent every 6 months)

Group expressed thanks to officers for their hard work over this period.

Group meeting; 30.09.20

Discussion around options for eco-friendlier road surfacing, use of technology and reusing material in road repairs. BJ confirmed officers are looking at pilots.

Discussion around solar farms and the Cadw's stance on solar panels on listed buildings. GK asked whether smaller sized solar farms could be an option. TB confirmed that the Feed in Tariff incentive had now come to an end which has made it more difficult to deploy a viable scheme.

Discussion around use of power down automatic switch off software for reducing electric use in officers. HVE confirmed this was being looked at for County Hall. Ysgol Brynhyfryd can already installed such a software with good results.

Discussion around ash die back and the need to sufficiently replace any trees that are felled. BF suggestion for the Council to produce communication and guidance to the public on how to identify ash die back in their gardens/community areas and what to do about it.

Discussion around the value of road side areas for carbon sequestration and biodiversity improvement. HVE/JW confirmed road side green spaces/ verges are part of the land holding mix in improving species diversity over next 9 years.

Discussion around ensuring any new Council owned building is low carbon in operation. HVE confirmed this is an active consideration in the developing 21st Century Schools Band B programme of projects

Discussion around the number of electric vehicles in the Council owned fleet. HVE confirmed less than 10 are electric. Work progressing to increase EV charging

ACTIONS:

- **HVE-** send project manager for the Ash Die Back Project groups suggestion for the Council to produce communication and guidance to the public on how to identify ash die back in their gardens/community areas and what to do about it.

infrastructure in the Council and thus support more cars and small vans to transition to electric. The Council has introduced an “EV first” fleet procurement policy.

Timeline for rest of 2020/21

HVE took the group through key milestones for the rest of 2020/21 including:

- October = drafting of strategy and action plan document and preparation for public consultation
- November = Public consultation on the draft climate and ecological change strategy and action plan
- December = Carbon Literacy Training for Member and key officers commence
- January = Seeking approval/adoption of the Climate and Ecological Change Strategy and Action Plan at Cabinet/Full Council
- February and March = Preparing for project delivery 2021/22 including external funding bids. Developing and Implementing any process/policy changes required.

4. DCC’s Net Carbon Zero Baseline and Pathways to 2030

HVE presented to the group DCC’s net carbon zero baseline. This has been calculated following Welsh Government Greenhouse Gas Reporting guidelines.

18,915 tonnes of carbon was emitted by the Council in 2019/20 from the following sources:

- Buildings
- Waste
- Fleet
- Staff Commuting
- Street Lighting
- Business Travel

Plus 22,710 tonnes of carbon was emitted from the Council’s supply chain.

2,417 tonnes of carbon was absorbed by the land owned and operated by the Council in 2019/20 from the following land use:

- Grassland
- Forestland / Woodland

HVE presented to the group the proposed aims on carbon reduction and the increase in carbon sequestration for DCC which will form part of the Climate and Ecological Change Strategy and Action Plan.

1. It is proposed DCC aims to reduce its emissions from the following sources by 50% by 31st March 2030 to 9,440 tonnes per annum.
 - Buildings
 - Waste
 - Fleet
 - Staff Commuting
 - Street Lighting
 - Business Travel

2. It is proposed DCC aims to increase its carbon absorption by 390% by 31st March 2030 to 9,440 tonnes per annum.

If the Council is successful on the achieving 1 and 2 above, total carbon emissions will be equal to the total carbon absorbed per annum by 31st March 2030.

In addition, it is proposed DCC aims to reduce the carbon emissions from its supply chain by 35% by 31st March 2030.

Discussion around budgets to progress work. JG confirmed budget setting process had commenced and work continues.

Discussion around Covid 19 and impact of that on Council's carbon footprint. BF suggested potential impacts could be less travel, people shopping locally, a more local supply chain. JG confirmed 'new ways of working' was a theme in the Council's Covid 19 Recovery plans.

HS raised Natural Resource Wales new Blue Carbon report which highlights the carbon absorption benefit of the sea.

HR raised the opportunity for the Council to develop and manage land to achieve its optimal carbon storage capacity.

ACTIONS

- **HVE-** to continue to draft the Climate and Ecological Change Strategy and Action Plan and present draft document at Octobers working group meeting

5. Plans for continued engagement with the public

LWJ took group through the plans for continued public engagement on the Climate and Ecological Change agenda, including an update on webpages on the Council website, an update on setting up a climate and ecological change sub group of Y Panel and outline draft plans for the public consultation on the draft strategy and action plan.

Website

The new corporate website went live in mid-September and we can now progress this action to create a set of climate and ecological change webpages.

The short URL will be www.denbighshire.gov.uk/climatechange.

We hope to launch the new set of webpages during Wales Climate Week, week commencing 2nd November.

Climate and Ecological Change sub group of Y Panel

As previously reported, it was agreed to progress the option of creating a sub group of the Council's Y Panel on the Council's County Conversation portal and run discussion forums on the County Conversation portal for the public to engage with the Council and each other on that topic to share learning via the messaging platform.

The intention is to run a discussion forum topic every 6 weeks.

We hope to launch the first discussion forum in Wales Climate Week, week commencing 2nd November.

Plan for Public Consultation on draft DCC's Climate & Ecological Change Strategy and Action Plan

It is intended that the draft Climate and Ecological Change Strategy and Action Plan goes out to public consultation for 21 days during November/December.

In light of COVID-19, the following is proposed in terms of the methods of consultation:

- Online survey via County Conversation portal.
- 1 public evening meeting- if there is provision for meetings to be held virtually.
- Presentations at School Council and Youth Council/Parliament meetings- if there is provision for meetings to be held virtually.
- Distribution of youth friendly consultation information to schools.

Discussion around information and resources for schools about climate change. HVE suggested this is something the Council can build on over time on the website.

ACTIONS

- **LWJ / HVE-** to continue with plans for website, discussion forum and public consultation.
