The application was subject to a Site Inspection Panel meeting at 10:30 Friday 1st November 2024.

The Officer present was Paul Griffin (Development Management).

The reason for calling the site panel was to allow opportunity to view the details of the proposal, the highway, the proposed parking area, and the relationship to surrounding properties.

At the Site Inspection panel meeting, Members considered the following matters:

- 1. The details of the proposal, including the proposed site layout.
- 2. The highway and proposed parking area.
- 3. The site in relation to the surrounding area and the neighbouring dwelling.

In relation to the matters outlined:

- 1. The Officer described the proposal and outlined the extent of the works to the building, the location of the proposed extension, and the layout of the parking area.
- 2. Members considered the character of the existing building, the character of that vestry (which is to be demolished) and considered the details of the proposed works and the impacts that would have on the character of the building. Members also considered the setting of the building within the AONB.
- 3. Members asked for clarity on the precise location and size of the proposed parking area, and the works required to create the access. Members also asked about what uses the building could be put to without the need for planning permission. The Officer advised that the building could be used for any use within a 'D1 use class' (health centres, crèches, day nurseries, day centres, schools, art galleries etc.) and considered what highway impacts this 'fall back position' might result in. Members asked about highway safety during the demolition of the vestry should permission be granted.
- 4. Members observed the rear of the site and the layout of the garden area. The relationship of the proposed extension to the neighbouring dwelling and the location windows was also observed.

Summary of planning based comments:

- The proposal would result in a loss of local historical features and the proposed design does not respect the character of the original building.
- The elevational changes are excessive and not in line with adopted guidance on the conversion of buildings.
- The plans do not show the impact on Ty Capel. Concern is raised locally regarding a loss of privacy and overshadowing of Ty Capel.
- Detrimental impact on road safety lack of visibility available for cars leaving the proposed parking area.
- Lack of clarity regarding the drainage proposals
- Concern is raised regarding the safety of the highway during the works.
- Insufficient parking arrangements
- Lack of marketing

Officer Note -

In relation to the questions raised about foul drainage, officers can confirm that the submitted site layout plan, when read in conjunction with the drainage plan show the existing connection to the existing septic tank to remain, but the septic tank to be replaced with a private treatment plant. Officers understand this is exempt from the need for a permit from NRW, but would be controlled by Building Regulations.

In relation to questions regarding highway safety during construction (should permission be granted) Officers consider these can be addressed through the imposition of a Construction Management Plan condition. This is now detailed below as an additional condition.

All other late representation issues raised are considered to have been covered in the main Officer Report and/or were considered/observed at the Site Panel meeting.

Amended/ additional conditions -

No site clearance or construction works shall be permitted to commence until the written approval of the Local Planning Authority has been obtained to a detailed Construction Method Statement. The Statement shall provide details of:

- a) the arrangements for the parking of vehicles of site operatives and visitors;
- b) the location of any construction compound and measures to reinstate the land following completion of the works;
- c) the hours of site works and deliveries;
- d) the proposed method for demolition of the vestry to ensure no obstruction to the safe and free flow of traffic on the adjacent highway
- e) the location of areas designated for the loading, unloading, and storage of plant and materials;
- f) the piling methods, in the event that this form of foundation construction is proposed The development shall be carried out strictly in accordance with the approved elements of the Construction Method Statement throughout the construction period.
