### 1. What type of proposal / decision is being assessed?

### 2. What is the purpose of this proposal / decision, and what change (to staff or the community) will occur as a result of its implementation?

The purpose of this proposal is to inform Cabinet members of the findings of the Formal Consultation that took place from 11/11/2013-23/12/2013 regarding the proposal to close Ysgol Llanbedr as of the 31<sup>st</sup> of August 2014 with existing pupils transferring to Ysgol Borthyn, Ruthin subject to parental preference.

The report recommends that Cabinet approve the publication of a statutory notice to close Ysgol Llanbedr as of the 31<sup>st</sup> of August following a 4 week period allowing for any objections to be received.

Should the proposal be implemented primary education provision would cease in the village of Llanbedr DC.

All stakeholders were identified prior to the Formal Consultation, all consultees identified (inclusive of parents, staff, Governing Bodies and pupils) were provided with a formal consultation document (English, Welsh and Children's versions were made available in hardcopy and via Denbighshire County Councils website). Stakeholders were able to respond to the formal consultation in a number of ways, including;

--> Standard Response Form (available in hardcopy and electronically via the Denbighshire County Council website in both Welsh and English)

--> Details were provided for responses to be submitted by post and by email

--> Details of parent and staff meetings were published within the Formal Consultation document

--> Governing Bodies were held during the Formal Consultation period.

--> Pupil consultation events were arranged with Ysgol Llanbedr and Ysgol Borthyn as a named alternative school. Permission was refused to hold a consultation event with the pupils of Ysgol Llanbedr.

In total 50 letters and emails were received, 85 standard response forms and 61 community questionnaires were submitted during the Formal Consultation period. A full analysis of submission is provided within the Formal Consultation Report.
