Roedd copi o adroddiad gan y Rheolwr Cyllid Addysg, a oedd yn manylu ar y cynnydd a wnaed o ran adolygu dyraniad adnoddau ychwanegol i Anghenion Addysgol Arbennig (AAA) mewn Ysgolion Cynradd, wedi'i ddosbarthu gyda'r papurau i'r cyfarfod.

Rhoddodd y Pennaeth Gwella a Chynhwysiant Ysgol amlinelliad o'r adroddiad a oedd yn manylu ar y cynnydd a wnaed o ran adolygu dyraniad adnoddau ychwanegol i Anghenion Addysgol Arbennig (AAA) mewn Ysgolion Cynradd, a'r cynnydd a wnaed o ran adnabod opsiynau ar gyfer ariannu AAA mewn Ysgolion Cynradd yn y dyfodol. Roedd yr adroddiad a gyflwynwyd i'r Pwyllgor yn Rhagfyr 2011, a oedd yn amlinellu cynlluniau ar gyfer proses o ddyrrannu adnoddau i ysgolion ar gyfer AAA, wedi'i gynnwys fel Atodiad 1 i'r adroddiad.

Esboniodd y Pennaeth Gwella a Chynhwysiant Ysgol bod cynnydd sylweddol wedi'i wneud a bod y cynlluniau yn destun ymgynghoriad ar hyn o bryd, fel y manylir yn y papur ymgynghori sydd wedi'i gynnwys yn Atodiad 2. Darparwyd amlinelliad o'r gwaith sy'n cael ei gynnal mewn perthynas â rheoli Newidiadau Cytundeb Cyflogaeth i Gefnogaeth AAA 1 i 1 mewn Ysgolion, ac roedd hyn yn cynnwys y

broses ymgynghori, y gweithredoedd sydd eu hangen a'r amserlenni a argymhellir. Cadarnhawyd y byddai'r model ariannu newydd yn adlinio adnoddau sy'n bodoli eisoes i wneud defnydd mwy effeithiol ac effeithlon o'r gyllideb AAA gyfredol ac y byddai'r lefel cyfredol o orwariant yn cael ei negyddu gan y broses fonitro newydd. Byddai ariannu yn dryloyw a theg a byddai unrhyw arbedion a wnaed yn erbyn y gyllideb yn cael eu dychwelyd i'r gyllideb ddirprwyedig ysgol gydag unrhyw gynnydd yn y cyfanswm cost yn cael ei ddyrannu o'r gyllideb ddirprwyedig.

Tynnodd y Dr D. Marjoram sylw at bwysigrwydd cefnogaeth 1 i 1 i blant ag anghenion arbennig a mynegodd ei chefnogaeth i'r cynigion, gan gyfeirio at y manteision i'w sicrhau a'u cyflawni. Amlinellodd Aelodau fanteision y system a oedd yn galluogi gweithwyr cynnal i drosglwyddo gyda'r plentyn os oedd angen hynny, a'r angen i fonitro a gwerthuso'r broses, drwy'r broses graffu, i asesu buddiannau'r system.

Mewn ymateb i gwestiynau, esboniodd y Pennaeth Gwella a Chynhwysiant Ysgol y byddai cytundebau yn cael eu rheoli'n fewnol ac amlinellwyd manylion o'r broses rheoli ariannol a'r mein prawn ar gyfer dyrannu adnoddau i'r Pwyllgor. Cyfeiriwyd at arwyddocâd cyfansoddiad y Panel Safoni, ei rôl monitro, penodiad Cadeirydd annibynnol - yr unig Banel o'r fath yng Nghymru i gael cadeirydd annibynnol, a hysbyswyd Aelodau bod ymgynghori a chydlynu rheolaidd yn digwydd gyda'r Awdurdod lechyd, er bod gan lechyd banel comisiynu ar wahân. Rhoddwyd manylion ar ddarpariaeth hyfforddiant i gynorthwywyr cefnogi ac Aelodau Panel i'r Pwyllgor. Rhoddodd y Rheolwr Ariannu Addysg fanylion o'r broses weinyddu, gan roi sylw penodol i'r agweddu ariannol, mewn perthynas â mecanweithiau ariannu i Ysgolion Uwchradd a Chynradd.

Esboniwyd bod yna risg ynghylch safbwyt ysgolion unigol at benderfyniadau'r Panel a diffiniad lefelau addas o gefnogaeth i'w ddarparu i ddisgyblion. Fodd bynnag, dylai mein prawn cadarn y Panel Safoni ac annibyniaeth yr Aelodau Panel a benodir gyfyngu ar hyn. RHAN I

6 ADOLYGIAD O WASANAETHAU DYDD YNG NGOGLEDD Y SIR

Roedd copi o adroddiad gan y Pennaeth Gwasanaethau Oedolion a Busnes, a oedd yn rhoi diweddariad ar adolygiad Gwasanaethau Dydd yng Ngogledd y Sir, ac yn cynnig yr opsiwn dymunol ar gyfer darparu gwasanaethau i'r dyfodol ar gyfer ymgynghoriad ffurfiol, wedi'i ddosbarthu gyda'r papurau i'r cyfarfod.

Esboniodd y Pennaeth Gwasanaethau Oedolion a Busnes bod angen, fel rhan o foderneiddio gwasanaethau cymdeithasol, adolygu'r ddarpariaeth o wasanaethau dydd arunig i bobl hŷn, Hafan Deg yn Rhyl a Llys Nant ym Mhrestatyn, i sicrhau bod y gwasanaeth a gynigiwyd yn gyson gyda'r polisi ail-alluogi. Darparwyd disgrifiadau

manwl o'r canolfannau i Aelodau. Roedd adolygiad o'r gwasanaethau wedi'i gomisiynu yng Ngorffennaf 2011 ac roedd yr argymhellion a wnaed wedi'u crynhoi yn yr adroddiad. Oherwydd mesurau oedd eisoes wedi'u gweithredu, roedd y gofyniad arbedion bellach wedi gostwng i £60,000, i'w gyflawni o'r argymhellion a amlinellwyd ar gyfer 2013/14.

Amlinellwyd yr egwyddorion yn yr adroddiad, a thynnodd y Pennaeth Gwasanaethau Oedolion a Busnes sylw at yr angen i wneud newidiadau i gyflawni anghenion y bobl fwyaf bregus yn y Sir yn y dyfodol. Aeth ati i gydnabod yr angen am ddarparu gwasanaethau gofal dydd yn Rhyl, Prestatyn ac ardaloedd eraill, a bod mynediad rhwydd at yr adeiladau a ddefnyddiwyd yn hollbwysig.

Mewn ymateb i gwestiwn yngylch y gwahaniaeth rhwng ymyriad tymor byr a gofal tymor hir, esboniwyd bod y GIG a'r Deddf Gofal Cymdeithasol 1990 yn rhoi dyletswydd ar Awdurdodau Lleol i asesu anghenion gofal cymdeithasol. Roedd Deddf Cymorth Gwladol 1948 a Deddf Cleifion Cronig a Phersonau Anabl 1970 yn darparu ar gyfer darparu gwasanaethau i gyflawni unrhyw anghenion cymwys. Roedd modd cyflawni hyn trwy drefniadau trydydd person fel sy'n bodoli ar hyn o bryd gyda gofal yn y cartref a gwasanaethau preswyl.

Cododd Aelodau'r pwyntiau canlynol wrth gefnogi cadw'r Canolfannau dan sylw:-

- Tynnwyd sylw at bwysigrwydd sicrhau cyfranogiad Aelod Lleol ymhob cam o'r broses ymgynghori. Mynegwyd pryder bod dileu'r cymhorthdal i ffioedd wedi eithrio nifer sylweddol o ddefnyddwyr gwasanaeth potensial o'r broses ymgynghori a allai effeithio yn y pen draw ar yr adborth a geir o'r ymgynghoriad, ac na fyddai darparu gwasanaethau trwy'r sector preifat yn cwrdd â'r safonau a oedd yn cael eu darparu ar hyn o bryd. Roedd y cynnydd mewn ffioedd hefyd wedi rhwystro defnyddwyr rhag defnyddio'r cyfleusterau ac roedd hynny'n rhoi'r argraff nad oedd angen y gwasanaethau.
- Codwyd pryderon hefyd bod rhai gofalwyr nawr yn talu am ofal dydd i'w hanwyliaid o'u lwfansau gofalwyr eu hunain.
- Cyfeiriwyd at y staff a'r cyfleusterau ardderchog sydd ar gael ar hyn o bryd, y colli swyddi posibl pe byddai'r gwasanaethau'n cael eu preifateiddio, pwysigrwydd yr ysbryd cymunedol a'r gwmniaeth y mae'r sefydliadau hyn yn eu cynnig, a'r angen i'r Awdurdod barhau i ddarparu gwasanaethau lefel uchel.
- Wrth ystyried yr Opsiynau, roedd y Cynghorydd J. Butterfield yn teimlo y byddai'n bwysig cymryd i ystyriaeth y tanwariant o £713k o fewn y Gyfarwyddiaeth. Esboniodd y byddai'n bwysig cadw'r gwasanaethau o fewn y Canolfannau dan sylw a oedd wedi'u hadeiladu'n bwrpasol. Teimlwyd hefyd na fyddai'r cyhoeddiadau a ddisgwyliwyd yngylch Adolygiadau Gwasanaeth y GIG yn cael dylanwad mewn perthynas â darparu'r gwasanaeth hwn.
- Cwestiynwyd y prosesau asesu ac ymgynghori, gyda chyfeiriad arbennig at faterion yn ymwnedd â ffioedd.
- Mynegwyd pryderon bod nifer y llefydd gofal dydd ar gael ym Mhrestatyn wedi gostwng yn sylweddol ar ôl i Llys Nant gau.
- Codwyd pryderon gan y Cynghorydd D. Simmons yngylch

Cyfeiriodd y Pennaeth Gwasanaethau Oedolion a Busnes at y materion allweddol canlynol wrth ymateb i Aelodau:-

- Roedd Aelodau Lleol wedi bod yn rhan o'r broses ymgynghori ac wedi cael eu gwahodd i fynychu cyfarfodydd y Grŵp Ffocws.
- Roedd y Cabinet wedi cytuno ar ffioedd a thaliadau gydag uchafswm tâl o £50 yr wythnos am wasanaethau gofal cartref, yn unol â chanllawiau Llywodraeth Cymru, er bod modd hepgor hyn pe na fyddai'r defnyddiwr gwasanaeth yn gallu fforddio'r tâl penodol. Cadarnhawyd y byddai gofyn i'r Awdurdod gyflawni unrhyw anghenion a adnabuwyd waeth beth fo'r gost.
- Byddai ymgynghoriad yn cwmpasu'r gymuned ehangach, gan gynnwys defnyddwyr gwasanaeth, defnyddwyr gwasanaeth potensial a staff, a byddai Asesiad Effaith ar Gydraddoldeb hefyd yn cael ei gynnal.
- Rhoddwyd manylion o'r ymgynghoriad a gynhaliwyd fel rhan o'r adolygiad gyda staff, defnyddwyr a gofalwyr yn y 2 Ganolfan.

Yn ystod y drafodaeth a ddilynodd, cytunodd y Pwyllgor bod yn rhaid mabwysiadu Cynllun Ymgynghori a oedd yn eglur, manwl, tryloyw ac yn cynnwys Aelodau Lleol ar bob cam. Cytunodd Aelodau hefyd y dylai'r Cynllun Ymgynghori nodi holl randdeiliaid â ganddynt ddiddordeb ac y dylid adrodd nôl i'r Pwyllgor maes o law ar ganlyniadau'r ymgynghoriad.

7 PROSIECTAU SEILWAITH MAWR: DYRANNU ADNODDAU AC YMGYSYLTIAD CYMUNEDOL

Roedd copi o adroddiad gan y Swyddog Cynllunio: Cynlluniau Ynni Adnewyddadwy, a oedd yn ceisio arweiniad ar yr ymrwymiad o ran adnoddau a lefelau ymgysylltiad cymunedol gyda phrosiectau seilwaith mawr, wedi'i ddosbarthu gyda'r papurau i'r cyfarfod.

Roedd prosiectau seilwaith mawr yn gynigion datblygu ar raddfa fawr sydd angen caniatâd a elwir yn 'ganiatâd datblygu' dan weithdrefnau a nodir gan Ddeddf Gynllunio 2008 (fel y'i diwygiwyd gan Ddeddf Lleoliaeth 2011). Roedd angen i ddatblygwyr oedd am adeiladu prosiectau seilwaith mawr ymgeisio am ganiatâd cynllunio i'r Arolygaeth Gynllunio ac roedd yn rhaid ymgynghori'n statudol ag Awdurdodau Lleol. Roedd Adroddiad yn nodi'r cyd-destun ar gyfer prosiectau seilwaith mawr wedi'i ystyried gan y Pwyllgor Cynllunio ym Mai 2012, ac mae Atodiadau 1 a 2 i'r adroddiad yn cynnwys manylion am rôl yr Awdurdod Cynllunio yn y broses gynllunio. Roedd y goblygiadau o ran arian ac adnoddau ac effeithiau/risgiau potensial yn gysylltiedig â phob opsiwn wedi'u cynnwys yn Atodiad 3, ac roedd costau allanol dangosol i ymateb i brosiectau seilwaith mawr wedi'u cynnwys yn Atodiad 4. Nid oedd unrhyw reidrwydd statudol ar yr Awdurdod Lleol i

gyfranogi yn y broses o asesu cynlluniau o'r fath. Fodd bynnag, gan fod i rai prosiectau seilwaith mawr effeithiau cymdeithasol, economaidd ac amgylcheddol sylweddol ar y Sir a chymunedau lleol, rhoddwyd ymateb casgliadol i'r Arolygaeth a chyfranogodd y Cyngor, i ryw raddau, yn y broses. Roedd gofyn am arweiniad gan Aelodau yng hylch lefel y dyraniad adnoddau ac i ba raddau y dylid cael ymgysylltiad cymunedol gyda phrosiectau seilwaith mawr yn y dyfodol, yn enwedig o gofio dyhead yr Awdurdod i ddod yn agosach at y gymuned.

Rhoddodd swyddogion grynodeb o'r prif bwyntiau yn yr adroddiad a oedd yn ymdrin â dyrannu adnoddau, yr opsiynau ar gael i'r Cyngor yn nhermau sut y mae'n ymateb i brosiectau seilwaith mawr, ac yn nhermau ymgysylltiad cymunedol mewn perthynas â phrosiectau mawr o'r fath. Roedd rheidrwydd statudol i ymgynghori ag Awdurdodau Lleol ar brosiectau seilwaith mawr, ac roedd ganddynt rôl bwysig i'w chwarae pe byddent yn dewis ymgysylltu â'r broses. Fodd bynnag, nid oedd unrhyw daliad cynllunio yn gysylltiedig â chynlluniau o'r fath i dalu am unrhyw gostau fyddai'n codi.

Welch nad oedd trigolion yn ei ward ef wedi bod yn ymwybodol o gynigion diweddar a gyflwynwyd yn yr ardal honno, ac awgrymodd y dylai'r Awdurdod Lleol fabwysiadu ymagwedd mwy rhagweithiol i gynyddu ymwybyddiaeth yn lleol. Cyfeiriodd hefyd at yr effeithiau y gallai cynigion mewn rhannau amrywiol o'r sir eu cael ar gymunedau ar hyd yr A5 o safbwyt materion cysylltiedig â thraffig. Roedd y Cyngorydd C.H. Williams yn teimlo bod gan yr Awdurdod ddyletswydd i sichau nad oedd unrhyw effaith niweidiol ar drigolion y Sir, beth bynnag oedd maint y datblygiadau a gynigiwyd. Cadarnhaodd y Pennaeth Cynllunio a Gwasanaethau Rheoleiddio y byddai'n rhaid cyflwyno'r cais i'r Awdurdod Cynllunio Lleol (LPA) pe byddai'r rhifau yn gostwng fel bod y cais islaw trothwy penodol. Byddai'r LPA wedyn yn gallu derbyn taliad penodol gyda'r cais, gan olygu bod gwell adnoddau ar gael i ymdrin â'r cais.

Mewn ymateb i gwestiwn gan y Cyngorydd J.M. Davies yng hylch ariannu a goblygiadau ariannol pob un o'r opsiynau a gyflwynwyd, cyfeiriodd y Pennaeth Cynllunio a Gwasanaethau Rheoleiddio at Ddatganiad y Prif Swyddog Ariannol yng hylch y goblygiadau o ran adnoddau a chyllid, a'r broses ar gyfer seisio am adnoddau mewnol ychwanegol. Cyfeiriodd y Cyngorydd H.O. Williams at effaith gweledol strwythurau, fel ffermydd gwynt, ar gymunedau y tu allan i'r ardal gynllunio, a phwysleisiodd bwysigrwydd cynnwys y cymunedau hyn yn y broses ymgynghori.

Roedd y Swyddog Cynllunio: Cynlluniau Ynni Adnewyddadwy yn teimlo y dylai'r Awdurdod ymgysylltu â'r broses. Fodd bynnag, roedd yn bwysig bod yn realistig yng hylch beth fyddai'r Cyngor yn gallu ei gyfrannu, ac am y rheswm hwn, roedd Opsiwn B yn cael ei argymhell i aelodau, sef defnyddio adnoddau oedd eisoes ar gael. Rhoddodd fanylion o'r broses ymgynghori hyd yn hyn, a chadarnhaodd nad

oedd unrhyw gyfeiriad yn y Ddeddf Gynllunio at ymgysylltu cymunedol. Amlinellodd y Rheolwr Rheoli Datblygiad y risg potensial i'r Awdurdod pe byddai'n penderfynu ymestyn ei gyfraniad y tu hwnt i'w rôl statudol yn y broses ymgynghori, a nododd y byddai'n bwysig bod yr Awdurdod yn ymddangos fel rhanddeiliad o fewn y broses tra'n cefnogi'r gymuned leol.

Gyda chaniatâd y Cadeirydd, bu i aelodau o'r cyhoedd a oedd yn bresennol yn y cyfarfod godi ac amlinellu'r pwyntiau canlynol a materion yn ymwneud â nifer o geisiadau seilwaith mawr cyfredol neu botensial:-

- byddai cyfranogiad yr awdurdod lleol yn bwysig cherwydd yr effaith sylweddol ar y Sir gyfan; cyfeiriwyd at y diwydiant twristiaeth, fforestydd lleol ac yn enwedig at gyflenwadau dŵr yn yr ardal.
- awgrymodd cynrychiolydd o 'Stop the Exploitation of Mynydd Mynydd' (STEMM), bod y broses ymgynghori yn achos y datblygiad arbennig hwnnw yn cael ei rheoli'n ofalus gan yr ymgeiswyr. Roedd yn cwestiynu didueddrwydd y broses ymgynghori, gan gyfeirio'n benodol at y mapiau a ddosbarthwyd nad oedd yn cyfeirio at y cymunedau a fyddai'n cael eu heffeithio o fewn yr ardal Gais.
- Roedd asesiadau effaith weledol wedi cael eu gwrthod.

Ymgysylltu cymunedol - Opsiwn C: sy'n cwmpasu Opsiwn B ac yn ychwanegol bod y Cyngor yn neilltuo adnoddau mewnol pellach i gefnogi mudiadau trydydd person yn rhagweithiol ac i helpu cymunedau lleol ddeall, cyfrannu at, ac ymateb i brosiectau seilwaith mawr.

Mewn ymateb i geisiadau gan aelodau, cytunodd swyddogion i lunio strategaeth gyfathrebu i ymgynghoriadau, gan gytuno i ddosbarthu'r cynllun drafft i aelodau'r Pwyllgor cyn cyfarfod nesaf y Pwyllgor.

Roedd ffurflen ar gyfer cynnig prosiect (Atodiad 1) i gyd-fynd â'r canllawiau, a oedd yn esbonio'r egwyddorion wrth wraidd y broses ddyrannu a'r amserlen debygol ar gyfer dosbarthu'r arian. Roedd copi o'r ddogfen 'Trosolwg o'r Gwariant Hyd Yma', yn manylu ar bob prosiect unigol, wedi'i ddosbarthu yn y Papurau Gwybodaeth i'r cyfarfod.

Davies y byddai'n haws mewn Trefi, lle mae Cynlluniau Tref, i weithio tuag at, a chyflawni prosiectau a chynlluniau penodol gan fod materion yn ymwneud â ffiniau daearyddol a dylanwadau allanol eraill yn gallu cymhlethu'r broses o ddyrannu arian i ardaloedd gwledig. - Twristiaeth a'r Llain Arfordirol
- Manwerthu a Chanol y Dref

4.2 Ciplun o'r strategaeth

Mae Ardal Adfywio Gorllewin y Rhyl yn canolbwytio ar Edward Henry Street, Abbey Street, Aquarium Street a John Street, ac mae yno dai mawrion, agos at ei gilydd – llawer ohonynt wedi eu hadeiladu'n wreiddiol fel Tai Aros i letya twristiaeth ar anterth cyfnod gwyliau'r Oes Fictoriaid. Wrth i dwristiaeth ddirwyio, troswyd y tai yn fflatiau bach, a gelwir hwy nawr yn aml yn Dai Amlfeddiannaeth. Mae oedran a defnydd dwys y tai hyn wedi eu gweld yn dirywio ac mae wedi creu cymdogaeth gyda delwedd wael ac enw drwg. Ein strategaeth yma yw gwella yn gyffredinol gyflwr y tai a'r amgylchedd o gwmpas.

Yn allweddol i'r strategaeth hon mae lleihau nifer y Tai Amlfeddiannaeth, ac fe gyflawnir hyn trwy amrywiol gamau megis caffaol a dymchwel rhai, trosi eraill yn

gartrefi sengl neu fflatiau mwy, o ansawdd da a/neu ystyried defnyddio rhai fel swyddfeydd. Ynghyd â hyn bydd rheoli y tai amlfeiddiannaeth sydd ar ôl yn gadarnhach, er mwyn sicrhau eu bod yn cynnig llety o ansawdd, wedi eu cynnal a'u cadw a'u rheoli yn dda ar gyfer ei trigolion.

Mewn ymateb i'r pryderon a fynegir yn rheolaidd gan drigolion lleol ynglŷn â diffyg man agored, rydym hefyd yn bwriadu ceisio creu parc / sgwâr trefol newydd yn yr ardal hon. Nod y Prosiect Gwella Tai yw gweddnewid ardal yng nghanol Gorllewin y Rhyl, creu man agored newydd o gwmpas yr hwn y bydd y cartrefi sy'n wynebu'r man gwyrdd yn cael eu hailfodelu a'u hailwampio. Manteision yr agwedd hon yw:

- Delio â'r cysylltiadau negyddol sydd gan yr ardal ar hyn o bryd;
- Creu marchnad dai gytbwys o ran y math o dai sydd ar gael a'r daliadaethau;
- Gwella hyder buddsoddwyr, lle byddant yn buddsoddi heb yr angen am gymhorthdal parhaus gan y sector cyhoeddus.

Mae'r Prosiect Gwella Tai yn broiect partneriaeth rhwng Cyngor Sir Ddinbych, Llywodraeth Cymru a Chymdeithas Tai Clwyd Alyn. Bydd y prosiect yn caffael yr eiddo o amgylch y man gwyrdd newydd a fwriedir ac yn gweithio gyda Chymdeithas Tai Clwyd Alyn/Pennaf a datblygwyr sector preifat i adlunio a/neu ailwampio'r cartrefi sydd yno eisoes ac i adeiladu cartrefi newydd a denu a chadw pobl sy'n economaidd weithgar. Byddwn yn ceisio caffael eiddo drwy gytundeb, ond rydym yn cydnabod rhagweld y bydd pwerau prynu gorfodol yn cael eu defnyddio i sicrhau bod yr eiddo sy'n ofynnol i gyflenwi'r prosiect yn dod i feddiant cyhoeddus.

Yn amlwg, mae pobl yn byw yn rhan fwyaf o'r tai ar hyn o bryd, ac yn rhan o'r prosiect hwn byddwn yn ariannu Swyddog Adsefydlu a fydd yn gyfrifol am gynorthwyo'r preswylwyr i ddod o hyd i lety newydd a symud iddo. Byddwn yn ceisio symud y preswylwyr i'r gymuned o'u dewis, a dylai'r pecyn iawndal a gynigir drwy'r cynllun sicrhau bod holl gostau rhesymol y symud a'r aflonyddu a ddioldefir yn cael eu talu.

4.4.3 Y math o dai i'w creu

Lle cedwir tai mawr, bydd llawer yn cael eu hadlunio i'w haddasu i fod yn gartrefi ar gyfer un teulu. Lle cedwir tai llai o faint (2/3 ystafell wely), bydd y rhain yn cael eu hailwampio i safon uchel i greu cartrefi dynunol i barau a theuluoedd bach. Lle adeiladir cartrefi newydd gan y sector preifat, byddwn yn eu hannog i ddatblygu cartrefi a fydd yn ddeniadol i deuluoedd. Gan amlaf, disgwyliwn mai cartrefi tair ystafell wely fydd y rhain gyda gerddi a pharcio oddi ar y stryd. Ym mhob achos, boed adlunio, ailwampio neu adeiladu o'r newydd, byddwn yn ceisio gwella effeithlonrwydd ynni'r cartrefi'n sylweddol a lleihau'r gofyniad am waith cynnal a chadw parhaus i sicrhau eu bod yn fforddiadwy.

Er cydnabyddir y gallai'r newidiadau arfaethedig yn y system Les gynyddu'r galw am gartrefi meddiannaeth unigol, un o amcanion allweddol y prosiect hwn fydd lleihau niferoedd y math hwn o lety. Role of the Programme Board

The role of the Programme Board will be to effectively deliver strategic change, not to govern the delivery of individual projects. These should be addressed at the project level unless there are significant problems with delivery or the strategic context for the project has changed. In these circumstances it will be appropriate for the Programme Board to intervene, but in general the Board's role should be more strategic in terms of:

- ensuring the right projects are selected
- ensuring money is not wasted on projects that do not deliver benefits
- ensuring that scarce resources are prioritised
- improving communication with stakeholders
- commitment to adequate resources and cash
- providing better focus on the real drivers of change
- delivering tangible results

In undertaking this role the Programme Board will need to:

- Discuss the strengths, weaknesses and challenges facing Rhyl and identify and share best practice;
- Discuss the application of alternative ways of doing things;
- Identify, scope and justify candidate projects;
- Analyse the quick wins, longer term wins and decide which projects to approve;
- Select those projects which will generate significant benefits;
- Co-ordinate the delivery of the agreed set of projects;
- Involve stakeholders and ensure that projects respond to emergent evidence and other changes in the political and operational context;
- Review and maintain the quality and ambition of projects; and
- Follow through to implement projects and realise projected benefits.



West Rhyl Regeneration Area July 2012



A Snapshot of the Strategy

The West Rhyl Regeneration Area is centred around Edward Henry Street, Abbey Street, Aquarium Street and John Street, and is characterised by closely packed, large houses – many of which were originally built as Guest Houses to accommodate tourists at the height of Rhyl's Victorian heyday. As tourism declined these houses were converted into small apartments and bedsits, now often referred to as HMO's – Houses in Multiple Occupation. Age and the intensive use of these houses has seen them deteriorate and created a neighbourhood with a poor image and reputation. Our strategy here is to generally improve the quality of housing and the surrounding environment.

Key to this strategy is reducing the number of HMO's, and this will be achieved through a range of actions including acquisition and demolition of some, conversion of others into single homes or good quality, more spacious apartments and/or consideration of different uses such as offices. Allied to this will be more rigorous regulation of the HMO's that remain to ensure that they provide good quality, well maintained and managed accommodation for their residents.

In response to the concerns regularly expressed by local residents about the lack of open space, we also propose to try and create a new park/urban square in this area. Given the built up nature of the neighbourhood, to achieve this will require the acquisition and demolition of some properties. We will be supporting people affected by this change, and will sensitively deal with all relocation issues.



4.4 Prosiectau Allweddol

4.4.1 Adnewyddu'r Orsaf Fysus

Ail-agorodd Gorsaf Fysus y Rhyl ym Medi 2010 ar ôl gwaith ailwampio £3.7 miliwn. Yn cyffinio'r Orsaf Reilffordd, mae'r cynllun hwn, gyda'i lochesi newydd, gwell trefniadau mynediad a gwaith tirlunio ansawdd uchel, yn creu teimlad gwirioneddol o ‘gyrraedd’ i ymwelwyr sy'n cyrraedd gyda chludiant cyhoeddus. Estynnwyd y cynllun hefyd i wella rhan o brif faes parcio canol y dref i siopwyr a chreu gwell cysylltiadau i gerddwyr â chanol y dref.

4.4.2 Rheolwr Canol y Dref

Penodwyd Rheolwr Canol y Dref i gydgysylltu gweithgareddau i sicrhau bod y Rhyl yn aros yn dref gyda chanol dymunol a deniadol. Bydd y rôl yn cynnwys cysylltu â busnesau lleol i ddatblygu blaengareddau i wella canol y dref, datblygu raglen o ddigwyddiadau a fydd yn creu gweithgarwch a diddordeb, a hyrwyddo'r dref yn gyffredinol fel lle i siopa, ymweld a buddsoddi ynddi. Mae grŵp rheolaeth canol y dref sy'n cynnwys partneriaid allweddol wedi cael ei sefydlu i lywio gwaith Rheolwr Canol y Dref, ac mae'r gwaith o lunio Cynllun Busnes Rheoli Canol y Dref ar y gweill.

4.4.3 Datblygiad Swyddfa'r Bee & Station

4.4.4 Costigans

Fel adeilad y Bee & Station ar ochr arall y ffordd, mae'r adeilad hwn gyferbyn â Gorsaf Reilffordd y Rhyl wedi bod yn adfail am lawer o flynyddoedd. Cafodd ei brynu gan y Cyngor ym mis Rhagfyr 2011, a daeth y gwaith adnewyddu cynhwysfawr i ben yn Awst 2012. Bydd yr adeilad yn addas ar gyfer nifer o bethau, megis siop, tafarn, caffi neu swyddfa ac rydym ar hyn o bryd yn chwilio am ddeiliad addas i ddefnyddio'r eiddo.

4.4.5 Marchnad Rhyl

Sefydlwyd y farchnad yn 2011 ac mae ganddi ar hyn o bryd ganiatâd cynllunio dros dro. Mae ymgynghorwyr annibynnol yn y broses o adolygu'r farchnad ar hyn o bryd er mwyn canfod os yw'r farchnad yn cael effaith gadarnhaol ar ganol y dref ai peidio. Ar adeg ysgrifennu'r adroddiad hwn, rydym yn parhau i aros am adroddiad yr ymgynghorwyr.

4.4.6 Prosiectau a gweithgareddau eraill

Yn ogystal â'r prosiectau y soniwyd amdanyst uchod, mae gwaith ar y gweill gyda gwasanaeth Parth Cyhoeddus y Cyngor i archwilio ffyrdd o wella'r drefn o lanhau strydoedd canol y dref. Mae gwaith wedi'i gynnal gyda pherchnogion eiddo lleol i ymgymryd â pheth gwaith cynnal a chadw i wella edrychiad eu hadeiladau. Mae'r cyngor hefyd yn edrych ar y posibilrwydd o orfodi perchnogion adeiladau sydd mewn cyflwr gwael i ymgymryd â gwelliannau.

4.4.7 Sicrhau Buddiannau

Her fawr i ganol dref Y Rhyl yw'r ffaith bod y ffordd y mae pobl yn siopa wedi newid cymaint. Mae twf anhygoel siopa ar-lein, cynnydd manwerthu symudol, cyflymdra a phrosesau soffistigedig y prif fanwerthwyr cenedlaethol, y profiadau amrywiol a chyffrous sy'n cael eu cynnig gan y canolfannau siopa mawr diweddaraf oll wedi cyfrannu at newid y tirlun manwerthu fel y mae heddiw. Mae disgwyliadau newydd wedi cael eu creu yn nhermau gwerth, gwasanaeth, adloniant a phrofiad ac nid yw canol tref Y Rhyl wedi llwyddo i wireddu'r disgwyliadau hyn.

Yn wyneb ailstrwythuro sylfaenol y diwydiant manwerthu, bydd canol tref Y Rhyl yn parhau i ddirywio os na fydd camau breision yn cael eu cymryd. Felly, mae arnom angen datblygu'r strategaeth, ac yn dilyn hynny, ymgymryd â'r gwaith sy'n ofynnol i sicrhau bod y strategaeth yn dwyn ffrwyth. Yn fwy nag unrhyw un o'r ffrydiau gwaith eraill, mae'r gweithgaredd sy'n digwydd ar hyn o bryd yn dueddol o fod yn ymdrin â symptomau'r dirywiad - strydoedd blêr, eiddo ac adeiladau heb gael gofal, ayyb - yn hytrach na'r achosion. Mae ar ganol tref Y Rhyl angen strategaeth economaidd newydd sy'n cynnwys manwerthu, ond sydd ddim yn hollol ddibynnol ar fanwerthu.

O holl ffrydiau gwaith Y Rhyl yn Symud Ymlaen, yr un canol y dref yw'r un sydd wedi'i ddiffinio lleiaf yn nhermau cyfeiriad y gwaith a'r strategaeth gyffredinol. Mae arnom angen datblygu gweledigaeth eglur i ganol y dref, a bod yn onest ac agored wrth drafod sut ydym yn gweld rôl canol tref Y Rhyl yn datblygu, yn enwedig sut all Rhyl gyd-fynd â'r hyn sy'n digwydd ym Mhrestatyn yn hytrach na chystadlu yn erbyn Prestatyn. Gallai'r canlynol fod yn bosibiliadau o ran strategaeth i Ganol Tref y Rhyl:

- Ceisio cadw a denu brandiau cenedlaethol newydd i ardal y Stryd Fawr – gan dderbyn mai'r sector gwerth am arian sy'n debygol o ddwyn ffrwyth yn y lle

8.2 Cynnal a chadw, atgyweirio a buddsoddi mewn isadeiledd stryd gyhoeddus - mae rhai o'r dodrefn stryd yn edrych yn flêr; nid yw elfennau sydd angen sylw yn cael eu hatgyweirio'n rheolaidd, ac yn aml mae'n rhaid cael llu o gwynion cyn y bydd unrhyw atgyweirio'n digwydd. Rydym yn derbyn cwynion rheolaidd o'r cyhoedd a gwleidyddion am y mater hwn.

8.3 Edrychiad gwael adeiladau - mae gan ganol y dref benсаerniaeth Fictoraidd a deunydd trefol allai fod yn hynod o ddeniadol, ond mae llawer o adeiladau bellach mewn cyflwr gwael iawn ac felly'n cyfleo delwedd wael iawn i'r sawl sy'n defnyddio canol y dref. Mae'n rhaid i ni dderbyn nad yw rôl gorfodi'r Cyngor wedi bod mor nerthol ag y dylai o bosibl fod wedi bod, ond mae yna hefyd bwysau economaidd sylweddol sy'n creu'r broblem hon. 8.4 Parcio - daw cwynion rheolaidd o fusnesau yn Y Rhyl ynghylch cost parcio ac effaith negyddol hyn ar fusnes. Tra bod swyddogion yn amau'n gryf os yw'r pwyntiau hyn yn dal dŵr (mae dymunoldeb y canol fel cyrchfan yn dibynnu'n fwy ar yr hyn sydd ar gael nag ar gost y parcio), gellir dadlau bod problemau ynghylch cael mynediad at barcio yn Y Rhyl. Mae system unffordd y dref a lleoliad y meysydd parcio yn Y Rhyl yn golygu ei bod yn anodd canfod lle i barcio os nad ydych yn adnabod y dref. Yn hytrach na gostyngiad cyffredinol, dylid ystyried sut y gallwn ddefnyddio'r pwerau dewisol hyn i hyrwyddo'r defnyddiau yr ydym yn ceisio eu sefydlu a'u helpu i ffynnu yn Y Rhyl.

8.6 Cynyddu manwerthu "gwerth" yn Rhyl - y brandiau sy'n ymddangos fel petaent yn ffynnu yn Y Rhyl ar hyn o bryd yw'r rhai sy'n cynnig gwerth am arian - Peacocks, B & M Bargains, Poundland, ayyb. Er bod dyhead yn lleol am fwy o ansawdd yn hytrach na 'gwerth', mae'r farchnad ar hyn y bryd yn mynd i'r cyfeiriad arall. Agwedd arall o'r 'gwerth' hyn yw'r nifer cynyddol o siopau benthyg arian a siopau betio, sydd eto'n amhoblogaidd gyda busnesau eraill a gwleidyddion, ond sy'n ateb galw'r farchnad.

8.7 Gormodedd o unedau manwerthu anaddas - mae newidiadau i natur manwerthu yn golygu bod llawer llai o alw am unedau manwerthu canol y dref wrth i'r fasnach symud ar-lein ac i gyrrion trefi. Rhagwelir y bydd y duedd hon yn parhau ac felly rydym yn wynebu'r broblem o ormodedd o unedau (mae nifer cynyddol yr unedau gwag yn dystiolaeth o hyn). Ymhellach, mae'r adeiladau Fictoraidd yn dueddol o gynnig unedau bach, cul, tra bod manwerthwyr modern yn galw am unedau mwy o faint sy'n fwy sgwâr eu natur. Mae hyn yn dechrau codi cwestiynau ynghylch cyfangiad posibl canol y dref (haws dweud na gwneud), ac arallgyfeirio cynyddol o ran y defnydd a wneir o ganol y dref.

8.8 Effaith Prestatyn – mae'r datblygiad newydd ym Mhrestatyn a'r ffaith bod manwerthwyr allweddol fel Marks and Spencers wedi symud o'r Rhyl i Brestatyn yn debygol o olygu mai Prestatyn, ac nid Y Rhyl, fydd prif leoliad manwerthu Sir Ddinbych. Yn sicr, dyma sut fydd y farchnad yn gweld pethau, os nad yw'r Cyngor yn cyd-weld, a gallai hynny wedyn arwain at alw pellach am fwy o ddatblygiadau manwerthu ar nifer o safleoedd sydd eisoes yn bodoli ar gyrrion canol tref Prestatyn. Heb safleoedd tebyg i'w cynnig, gallai'r Rhyl syrthio nôl yn bellach fyth tu ôl Prestatyn.

A Snapshot of the Strategy

The town centre retains much of its splendid Victorian architecture, and offers a good range of high street brands along with quality independent shops. However, to remain competitive in a rapidly changing retail environment, a comprehensive package of training, enterprise support, physical improvements, marketing and promotion is necessary.

Improving the quality and management of the physical environment is a priority. This will include improving public spaces such as the streets and pedestrian areas, but also addressing problems with those private properties in the town which have been allowed to deteriorate and are now a bit of an eyesore. Grants are available under the Townscape Heritage Initiative (see Useful Links) to assist such works.

We are also exploring how we can create a “Free Ideas Zone” for the streets at the edge of the town centre. The aim would be to embrace experimentation and innovation to encourage entrepreneurs to respond to tourism, retail and business service opportunities. This type of offer could be complimented by the street market, which currently has planning consent until December 2012. Until then we will continue to make improvements, manage and monitor the market, with a view to renewing the planning consent if its positive impact on the town centre can be clearly demonstrated.

There is a longer-term aspiration of the redevelopment of the Queen’s Market area as a new shopping centre, offering units of the right size and quality to retain and continue to attract new shops into the town.

Cafodd y cynllun ei ariannu gan Lywodraeth Cymru/UE ac roedd y gost oddeutu £8.2 miliwn. Mae trafodaethau ar y gweill gyda Llywodraeth Cymru ynghylch trydydd cam terfynol y gwaith a fyddai'n ymdrin â'r ardal o Afon Clwyd at Barc Drifft. I ddechrau, roedd Llywodraeth Cymru yn cynnig ateb peirianyddol ei natur sef defnyddio meini, ond mae trafodaethau mwy diweddar wedi derbyn y byddai meini a haenau yn ateb mwy priodol i gwrchfan gwyliau fel Y Rhyl.

4.4.3 Harbwr a Phont y Foryd

Dechreuodd y prosiect hwn ar y safle yng Ngorffennaf 2012 a bydd yn creu:

- Pont i gerddwyr a beicwyr
- Sgwâr cyhoeddus ac adeilad ar ymyl y cei
- Muriau newydd i'r cei

Nod y prosiect yw denu ymwelwyr a chyfrannu at yr economi lleol yn ogystal â bod yn adnodd gwych i breswylwyr lleol. Bydd y llithrfa newydd ar gael i lansio cychod hwylio bychan, a bydd yn golygu bod modd tynnu cychod allan o'r dŵr yn haws ar gyfer eu storio yn yr iard gychod ddiogel sydd gerllaw. Bydd dwy uned ar gael i fusnesau yn adeilad yr Harbwr; mae'n rhaid i un ohonynt fod yn gaffi, a bydd modd defnyddio'r llall fel ystafell gyfarfod neu i fusnes harbwr perthnasol nes y bydd cyfle busnes yn dod i'r amlwg.

Bydd y bont yn cysylltu adeiladau sydd yno eisoes a datblygiadau arfaethedig ar ddwy ochr Harbwr y Foryd a bydd yn strwythur nodedig, gan ddarparu atyniad gwirioneddol eiconig a nodedig i ddod â thwristiaid i'r rhan yma o'r Rhyl. Bydd y bont yn cau'r bwlc yn y llwybr beicio cenedlaethol 5 ac yn darparu llwybr mwy diogel, cyflymach a rhwyddach i gerddwyr a beicwyr.

Bydd y bont newydd i gerddwyr a beicwyr wedi'i chwblhau ac yn barod i'w defnyddio yng Ngwanwyn 2013 a chaiff y Sgwâr Cyhoeddus, Adeiladu'r Harbwr a Wal y Cei eu hagor yn 2014. Llwyddwyd i sicrhau £10.3 miliwn o arian gan Lywodraeth Chymru gan gynnwys Cronfa Ddatblygu Rhanbarthol Ewrop, Cronfa Fawr y Loteri drwy SUSTRANS a Chyngor Sir Ddinbych. Ar hyn o bryd, rhagwelir y bydd gorwariant yn y prosiect, er bod nifer o ffynonellau ariannu posibl yn cael eu trafod ar hyn o bryd er mwyn ceisio cyfyngu ar y gorwario.

Er mwyn rhoi'r newyddion diweddar ynghylch Prosiect Harbwr y Foryd, mae'r Adroddiad Statws Prosiect diweddaraf ynghlwm fel:

4.4.4 Adnewyddu'r Honey Club

Prynodd y Cyngor hen adeilad yr *Honey Club* yn gynnar yn 2011, gan gydnabod ei arwyddocâd potensial fel safle ddatblygu oherwydd ei leoliad yn union gyferbyn â'r sinema a adnewyddwyd (gweler adran 4.4.1 uchod) a gerllaw canol y dref. Mae'r cyngor wedi prynu eiddo pellach o amgylch yr adeilad er mwyn creu safle y gellir ei datblygu. Nid yw'r Cyngor hyd yma wedi llwyddo i brynu un eiddo - 25/26 West Parade - sydd wedi bod mewn cyflwr truenus ers 20 mlynedd. Er gwaethaf trafodaethau helaeth, nid ydym wedi llwyddo i ddod i gytundeb gyda'r perchenog, ac yn dilyn penderfyniad gan y Cyngor yng Ngorffennaf 2012, mae gorchymyn prynu gorfodol (CPO) wedi'i gyflwyno. Ar adeg ysgrifennu'r adroddiad hwn, ni dderbyniwyd unrhyw wrthwynebiad i'r CPO, er bod sawl wythnos o'r cyfnod hysbysu yn parhau.

Mae nifer o adroddiadau ynghyd â monitro parhaus wedi sefydlu bod adeilad yr *Honey Club* mewn cyflwr peryglus. Er nad yw'n adeilad rhestredig, mae'r eiddo o fewn Ardal Gadwraeth ac o ganlyniad, mae angen caniatâd Llywodraeth Cymru cyn y gellir ei ddymchwel. Fel rheol, byddai angen caniatâd cynllunio ar gyfer ailddatblygu'r safle cyn y gallai hynny ddigwydd, ond o ystyried cyflwr yr adeilad a'r risg potensial i ddiogelwch y cyhoedd, mae'r Cyngor wedi gwneud cais i Lywodraeth Cymru am ganiatâd i ddymchwel heb fod caniatâd cynllunio yn ei le. Ar adeg ysgrifennu'r adroddiad hwn, rydym yn dal i aros am benderfyniad Llywodraeth Cymru.

Mae'r Cyngor hefyd, trwy broses gystadleuol, wedi dewis Partner Datblygu – Chesham Estates, sy'n cynnig adeiladu gwesty cystadleuol 60 ystafell gyda bwyty ar lefel y llawr gwaelod. Rydym ar hyn o bryd yn y broses o gytuno ar y Cytundeb datblygu ffurfiol gyda Chesham Estates, ond yn y cyfamser, maen nhw'n datblygu cynlluniau manwl i'r safle. Yn nhermau amser, mae Chesham Estates yn gobeithio dechrau ar y gwaith adeiladu yn 2013 fel bod yr adeilad yn barod ar gyfer ei ddefnyddio yn gynnar yn 2014.

Am y wybodaeth ddiweddaraf am y gwaith o adnewyddu'r *Honey Club*, mae'r Adroddiad Statws Prosiect diweddaraf ynghlwm fel:

4.4.5 Ocean Plaza

Ar y safle 7 hectar hwn lle'r oedd y ffair gynt, mae'r perchnogion, Scarborough Group yn bwriadu datblygu archfarchnad Asda newydd (adleoliad siop Bae Cinmel) a thafarn a gwesty newydd i'r teulu. Byddai'r datblygiad hefyd yn gweld ffordd fynediad newydd trwy'r safle a fydd yn caniatáu pedestreaniddio rhan o Rodfa'r Gorllewin - elfen bwysig yn y cynlluniau ar gyfer Pont Feicio newydd Foryd (gweler adran 4.4.3 uchod) i sicrhau bod llwybr beicio heb draffig, o ansawdd, yn cael ei greu ar y ddynesfa i'r bont newydd. Yn y dyfodol, mae yna hefyd gynlluniau ar gyfer cyfnod datblygu pellach llety preswyl a swyddfeydd, ond mae'r cynlluniau hyn yn cael eu dal yn ôl nes bydd marchnad ddatblygu'r DU wedi gwella. Yn y cyfamser, y cynnig yw tirlunio'r elfennau hyn dros dro ar y safle mwy.

Mae trafodaethau rhwng datblygiad Scarborough a deiliaid potensial wedi arwain at rai newidiadau yn y cynllun. Tra bo'r cymysgedd o ddefnyddiau ac adeiladau i bob pwrpas yn aros yr un fath, mae maint a ffurfweddiad yr adeiladau wedi newid. O

ganlyniad, mae datblygiad Scarborough yn bwriadu cyflwyno cais cynllunio newydd yn ddiweddarach yn 2012.

Mae Ocean Plaza yn ailddatblygiad sy'n cael ei arwain gan y sector preifat, ond mae ymddangosiad truenus presennol y safle yn cyfleo negeseuon negyddol iawn i ymwelwyr a darpar fuddsoddwyr fel ei gilydd. Byddai ailddatblygiad y safle yn hwb sylweddol i'r dref. Mae'r safle ar hyn y bryd yn wynebu her sylweddol gan fod angen is-orsaf drydan gynradd newydd a fyddai'n costio oddeutu £2 filiwn; yn ogystal â hynny, mae yna rai pryderon hefyd ynghylch y risg o lifogydd. Mae'r tîm RGF yn gweithio gyda Scarborough Developments i chwilio am ffyrdd o oresgyn y cyfyngiadau hyn a sicrhau bod y datblygiad yn dechrau cyn gynted â phosibl.

4.4.7 Prosiectau a gweithgareddau eraill

Mae nifer o brosiectau a gweithgareddau ar raddfa lai wedi digwydd neu'n cael eu datblygu ar hyn o bryd. Mae adeilad a wal ddiangen ar y promenâd wedi cael eu dymchwel i wella mynediad at y môr a golygfeydd o'r môr - yn unol â'r strategaeth a amlinellwyd yn adran 4.2 uchod. Mae cynlluniau i adeiladu llithrfa i longau bach (syrrfio barcut, syrrfio gwynt, ayyb) a mynediad anabl newydd i'r traeth yn datblygu'n dda. Dros gyfnod gwyliau'r haf, mae nifer o weithgareddau i blant a ariannwyd gan y prosiect BRAND Ewropeaidd wedi digwydd ar y promenâd - sioeau pyped, gweithdai syrcas, cerfluniau tywod, ayyb.

4.4.8 Sicrhau Buddiannau

Prif nod y rhaglen hon yw cynyddu nifer yr ymwelwyr, gan greu mwy o gyfleoedd busnes a swyddi yn y sector twristiaeth. Mae dangosyddion cynnar yn awgrymu bod niferoedd yn cael eu cynnal, ond bydd monitro tymor-hir o dueddiadau ymwelwyr yn hanfodol.

4.4.9 Cynlluniau i'r Dyfodol

Yn y gorffennol, mae gweithgareddau adfywio physical yn Rhyl wedi cael eu dominyddu gan welliannau i'r ardal promenade glan môr a ariannwyd 100% gan arian cyhoeddus. Ychydig iawn o fuddsoddiad sector preifat a ddigwyddodd (ac eithrio'r cinema a drafodwyd yn adran 4.4.1). Yn ystod y 18 mis diwethaf, mae'r ffocws wedi symud at weld sut allwn ni ddarparu hyder a hwyluso buddsoddiad sector preifat, ac iddyn nhw wedyn i weithredu a chynnal yr isadeiledd twristiaeth (fel yn achos ailddatblygiad yr *Honey Club* a drafodwyd yn adran 4.4.4).

Gallai sicrhau rhywbeth yn lle'r Heulfan fod yn allweddol i'r strategaeth hon. Mae gofynion cynnal a chadw'r adeilad fel ag y mae yn golygu ei fod ond yn debygol o fod yn weithredol am ychydig o flynyddoedd eto. Mae rhai trafodaethau cynnar ynghylch cyfleuster newydd yn lle'r Heulfan wedi'u cynnal gyda phartner hamdden strategol y Cyngor, sef *Alliance Leisure*, ond ar adeg ysgrifennu'r adroddiad hwn, rydym yn dal i aros am adborth ganddynt ynghylch dichonoldeb (*feasibility*) y cynnig.

Mae gan brosiectau unigol eu strategaethau ymgynghori eu hunain, ond mae'r ymgynghoriad cyflawn o'r strategaeth ehangach wedi'i atodi i Ddiweddarriad Ffrwd Gwaith Adfywio Gorllewin Rhyl.

8. Beth yw'r risgiau, ac a oes yna unrhyw beth y gallwn ei wneud i'w lleihau?

I greu economi twristiaeth gryfach ac ymdrin â delwedd negyddol Rhyl, rydym yn cydnabod bod yna nifer o faterion/risgiau y mae'n rhaid ymdrin â nhw:

8.1 Mae angen meincnodau o ansawdd dda - Yn genedlaethol, y cyrchiannau gwyliau sydd wedi cael y llwyddiant mwyaf o ran adfywiad yw'r rhai sydd wedi cael gwared ag olion diwerth yr hen ddyddiau - y siopau sglodion, y manau gwely a brecwast o ansawdd isel, y siopau rhoddion rhad, ayyb - er mwyn apelio at gynulleidfa ehangach. Mae angen lefel hollol newydd o ansawdd os am sicrhau ffyniant i'r dyfodol.

8.2 Yr her o leihau – er yn ffaith drist, mae'n rhaid cydnabod nad yw llawer o fusnesau sy'n gysylltiedig â thwristiaeth yn Rhyl yn mynd i oroesi. Mae busnesau ymylol wedi bod yn mynd allan o fusnes ar gyfradd gyflym iawn ac mae bron yn sicr y bydd hyn yn parhau. Yn fwy dadleuol, mae'n bosibl y bydd angen strategol i annog busnesau o'r fath i roi'r gorau i fashachu. Mewn rhai achosion, ni fydd y busnesau

hyn yn gweddu gyda'r safonau ansawdd uchel newydd y mae'n rhaid i Rhyl anelu atynt.

8.3 Ni all cyrchfannau llwyddiannus fod yn llwyddiannus os ydyn nhw wrth ymyl amddfadedd cymdeithasol – Mae cyrchfan yn dibynnu ar fod yn fan deniadol a chyfeillgar i ymweld ag ef (ac i fyw ynddo). Mae presenoldeb amddfadedd cymdeithasol eithafol yn creu effaith hollol wahanol. Felly, rhan allweddol o'r rhaglen adfywio yw mynd i'r afael â'r amddfadedd (dylid cyfeirio at Ddiweddariad Ffrwd Gwaith Adfywiad Gorllewin Rhyl).

8.4 Cymryd gofal gydag atyniadau newydd i ymwelwyr – yn aml, credir mai atyniadau newydd i ymwelwyr yw'r ateb. Weithiau, mae'n bosibl y byddan nhw'n ateb, ond yn amlach na pheidio, nid yw'r canlyniadau yn gwreddu disgwyliadau ac mae'n anodd cynnal yr atyniadau'n ariannol. Mae atyniadau i ymwelwyr yn rhan bwysig o gyrchfannau, ond nid dyna'r unig ran o bell ffordd, ac nid dyna'r rhan bwysicaf bob amser ychwaith. Byddai busnes siopa neu gyda'r nos ardderchog, er enghraifft, yn debygol o ddenu llawer mwy o ymwelwyr nag amgueddfa. Ar y cyfan, credir ei bod yn well cyfeirio buddsoddiad at greu amodau a fydd wedyn yn annog buddsoddiad gan y sector preifat.

8.5 Mae gan ddigwyddiadau a gweithgareddau rôl bwysig i'w chwaree - yn gynyddol, mae dewisiadau bobl yngylch mannau i ymweld â nhw yn cael eu dylanwadu gan yr ystod o weithgareddau sydd ar gael - ni fydd y traeth ei hunan yn ddigon i ddenu'r nifer o ymwelwyr sy'n ofynnol i gynnal busnesau lleol sy'n ymwneud â thwristiaeth. Bydd gwella nifer ac ansawdd digwyddiadau pwysig yn help, ynghyd ag ymyriadau ar raddfa fach ar y promenâd ac ynghanol y dref.

Appendix 1

A Snapshot of the Strategy

The Coastal Strip – from Foryd Harbour to Splash Point – is the focus for tourist related activity in Rhyl. The main appeal of this area is the sandy beach and the associated activities usually found at a traditional seaside location – bathing, sandcastles, promenading, amusements, fairground rides, etc. The approach here is to build on Rhyl's reputation as a family resort by providing facilities and activities which will sustain and grow this market. The strategy recognises that the visitor experience is likely to be dominated by day visits, although there are clearly opportunities to tap into the enormous number of people who stay at the caravan sites in and around Rhyl.

The short-term focus will be on improving the quality of the public realm along the coastal strip, and on modest improvements to amenities and to revealing the beach. This will improve the promenade as a place for walking, cycling, relaxation and general seaside experience. In the medium to long-term, we will be seeking to create new attractions to increase the number of people visiting Rhyl. This includes the substantial investment planned in the Foryd Harbour Area with a new, iconic pedestrian and cycle bridge as the centrepiece. Recent works to refurbish the Apollo Cinema have created the opportunity to create a "Entertainment Zone" in this area, and we will be working with the private sector to provide new leisure facilities, along with good quality restaurants. We are also considering options for renewing Rhyl's major attractions of the Sun Centre and Pavilion Theatre.

Combined with these improvements to the physical environment, there will also be consideration as to how we strengthen Rhyl's Events Programme and the town's ability to host major events. We will also explore ways to animate the promenade at a smaller scale but on a regular basis, for example with organised children's activities, buskers and street theatre.

- The category 3 check for the bridge is incomplete; however it has been completed for the elements presently being constructed.
- The specification for the building is complete and an invitation to tender and pre qualification has been advertised in Buy4Wales with a closing date of 17th August 2012. A panel to evaluate the tenders will be appointed by the third week in September.
- The final design for the bridge will not be completed until October at the earliest, given that the Mechanical and electrical design is outstanding. The Cat 3 check for the bridge has been completed other than for the M & E design. The Contractor has capped the cost of the M & E works for the bridge to provide cost surety.
- A landscape architect will be employed to advise on the finishing works contracts. In the meanwhile work is progressing on obtaining the costs and options for the various features and evaluating their inclusion within the scheme.

Contract Documents

- The Contract documents for the Bridge Construction Contract (Contract 1) have been delayed, as 'Giffords' the bridge designer had not provided the full set of drawings; these have only just been received and the contract is now ready to be signed.
- The Public Square enabling contract (Contract 2), is now ready to be signed.
- The Bridge Maintenance Contract for the bridge (Contract 3) is awaiting additional information from DCC.
- The harbour building contract is being prepared.
- The public square completion contracts have not yet considered

Construction

- Works on site commenced to programme. Works presently being undertaken are:-
 - Site clearance and fencing

 - Off site fabrication of the bridge decks has commenced
 - Ecology- no issues to report

Staffing

- Nigel Holding has now resigned.
- Gareth Young has been recruited to replace Nigel Holding
- Elgan Williams will be on site full time to supervise the works.

Financial

- The capital cost of the project has increased by £36,577 due in the main to the accommodation costs transferred to the bridge from the coastal defence scheme; this was in respect of ducting work and the installation of a CCTV column. The staff risk budget has been reduced to staffing arrangements made and other small cost fluctuations account for the balance.
- Staffing costs are within the anticipated expenditure for the reporting period.
- Construction costs are within the anticipated expenditure for the reporting period, however an additional £30k of cost has been transferred to this project from the coastal defence project in respect of accommodation works for the bridge.
- No DCC risk allowance has been expended in the reporting period.
- SUSTRANS has verbally committed a further £250k to the project; this sum includes the £100k previously reported as a likely additional contribution.
- A letter has been sent to RWE asking for an opportunity to meet with them to discuss the project, in an attempt to change their earlier negative decision to contribute £155k to the project
- On the basis of confirmed funding, the project cost is currently £310,571 over the budget allocated.
- The value engineering option for the hand rail to the bridge discussed at the last Foryd Harbour Board meeting is still being developed, and could be in the order of £70k; this has not been factored into the budget figure above

BREEAM / CEEQUAL

- The second batch of CEEQUAL information has been sent for assessment.
- At present the CEEQUAL work is 20% complete and will require a great deal of input in the next month.
- The bridge which had been developed in advance of the public square and quay walls should have had CEEQUAL applied to it to meet the grant requirements. Unfortunately this had not been built into the scheme as the initial offer letter of August 2009 did not specify CEEQUAL. The

second offer letter dated March 2010 stated the CEEQUAL requirement. A report is being prepared for WG explaining the difficulties of applying CEEQUAL to the bridge retrospectively, and hence ask for its omission from the CEEQUAL certification.

- The BREEAM certification for the quayside building has not been progressed due to the resignation of Nigel Holding. This will be considered in the next month.

CDMC

- The pre-construction and construction phase Health and Safety plan has been completed. There are currently no issues to report.

WG communication and audit

- The WG has appointed an external Contractor to undertake an evaluation of the P5T1 Physical Regeneration of North Wales which includes the Fordy Harbour projects. The external contractor has undertaken interviews with project managers from all schemes, and is continuing to take an interest in the progress of all projects within the P5T1 Physical Regeneration of North Wales Programme.

Programme

- Letters of intent were issued to Dawnus Construction Ltd in respect of the bridge construction and the public square enabling works contracts early in July to enable them to get to site, on the basis that there was agreement by both parties to the contractual terms proposed.
- The site set up commenced on 17th July 2012, and the on- site works started on 30th July 2012 and are progressing satisfactorily with the public square enabling works and bridge construction contracts both on programme
- The harbour building and the public square finishing works are presently four months behind programme, but is hoped to gain back this time.

Previous Fordy Harbour works

- There are some outstanding items from previous Fordy Harbour projects associated with works within the boatyard and the DCC moorings that were installed in 2011:-

Moorings contract

- A meeting with Capita Symonds took place on 4th July 2012, and Capita Symonds has now confirmed that the mooring shackles installed by their sub contractor Mulcair Ltd, will now be replaced with the shackle that DCC has requested. Capita Symonds are now in the process of procuring the equipment and will then arrange with DCC for the work to be undertaken

Phase 1 Fordy Harbour works

- The outstanding easement is being progressed through the current project and its progress covered earlier in this report
- The faulty electric metres were also discussed at the site meeting on 4th July with Capita Symonds and Daniels who had carried out the works. There was agreement by Daniels that the existing bollards for the water and electric were insufficient which had resulted in the corrosion of the electric metres. The manufacturer of the electric metres also attended the meeting, and has since provided a sample bollard containing electric and water has been provided for DCC to review.

Harbour and Maritime Service

- The business case has been extended to include most of the facilities and activities within the proposed Harbour and Maritime Service remit, but information pertaining to any existing budget and associated costs to maintain the Marine Lake have yet to be included
- A paper was shared at the Collaboration Board at the end of March discussing the opportunities

for an integrated Harbour & Maritime Service between DCC and CCBC. CCBC has requested a report regarding the benefits/ disbenefits to its organisation, which has been completed, and it had been anticipated that the Cabinets of both DCC and CCBC would review this report and make a recommendation from their own perspective. It is now planned that the consideration of a joint Harbour and Maritime Service will form part of the gateway review planned for September in respect of all the collaboration projects.

- In the meanwhile in order to progress the project it will be assumed that DCC has a 'stand alone' Harbour and Maritime Service.
- The opportunity to open the slipways at Barkby Beach and Garford Road for the 2012 season has been missed as the report due has not been completed in sufficient time.

Publicity

- The publicity event scheduled for 12th September, has now been rearranged to 20th September. The Minister's office has now confirmed that Huw Lewis AM will be available to attend for 45 minutes from 9am – 9.45am. Sunnyvale Caravan Park has confirmed that DCC can hire their social venue for any events which is ideal given its proximity to the harbour and the risk of inclement weather.
- An initial stakeholder identification exercise has been completed and a communication plan will now be developed.
- The Liverpool Daily Post ran an article on Friday 10th August further to the press release that went out last week.

Stakeholder Management

Rhyl Yacht Club had commenced remedial works to the slipway that is within the parcel of land leased by them from DCC. DCC has asked that the works are stopped until it can be established that the correct legal procedures have been followed and the relevant permits gained as there is potential for DCC to be fined if the works have not been correctly undertaken with the relevant permissions.

RGF: Future of Rhyl Sky Tower

1. Purpose of the Report

This report provides information regarding the current position with the Rhyl Sky Tower and outlines options for the future.

2. Background

The Sky Tower was opened in 1993 and was operated under a lease from DCC for a number of years by Clwyd Leisure Limited (“CLL”). The Sky Tower as an attraction has seen a diminishing number of visitors over the past ten years or so reflecting the down turn in Rhyl as a leisure destination and the lack of investment in developing the attraction. In recent years the physical condition of the Tower has deteriorated to such an extent that in early 2011 DCC commissioned a report on the Tower in order to determine how best to deal with the situation.

As a result of this report DCC decided not to renew the lease arrangements with CLL due on 31 March 2011 and close the attraction for the 2011 season. This decision was taken on the basis that the structure was unsafe and required a significant capital investment of circa £400k to bring it back into use as a ride. The site was hoarded to ensure public safety, and the facility has not operated since its closure.

The Council receive an annual rental income from the tower of £7,862 from telecommunications companies for the equipment they have installed at the top of the tower. There is the potential to increase this significantly when leases are renewed and/or when additional equipment is installed.

A more recent report (Jul 2012) has indicated that, whilst there remain significant costs associated with refurbishing the Sky Tower as a ride, the main structural elements of the tower (basically excluding the parts that move and make the facility a “ride”) were sound and probably have a further 30 years life.

3. Options

There are three main options for consideration:

3.1 Refurbish and reinstate as a ride

The current estimated cost of bringing the tower back into use as a ride are currently estimated to be in the region of £400K (based on a surveyors report from 2011. At the start of the 2012 season, at their request the operators of the Tir Prince fairground were invited to inspect the tower for their consideration and opinion on the possibility of bringing the tower back into use as a ride. They considered that, whilst they may be able to make some savings on the £400K estimate, the

investment required was still significant and would not stack up from a business point of view without very significant grant support from the public sector.

PROS:

- A refurbished skytower would create another attraction for Rhyl
- Income from the telecommunication equipment could be maintained and possibly increased

CONS:

- Rhyl would lose another attraction/facility (although the basis of the ride could be duplicated by having a big wheel erected for the season -as per Chester and Beaumaris. There has been some expressions of interest from operators for this, and would offer a much lower cost/low risk option.
- The cost of refurbishment is considerable and no funding source identified.
- The cost of capital investment is not justifiable in terms of the revenue the attraction is likely to generate

3.2 Dismantle and remove

The tower could be dismantled and removed. The cost of such dismantling has not been investigated, but in any case could be offset either by the scrap value of the metal or through the tower being bought by another organisation for refurbishment elsewhere (we understand that this would be a possibility). This may make this option cost neutral, although there would be issues of compensation for the telecommunications companies for loss of the site for their equipment.

PROS:

- All ongoing costs and risks associated with the tower would be removed
- It may be a cost neutral option (although the telecommunications compensation issue may mean this is not the case)
- It would create a site which could be used for additional car parking or installation of a new ride

CONS:

- Rhyl would lose an iconic structure that can be seen for miles
- Income from the telecommunications equipment would be lost
- Another Rhyl facility would be lost with no plans for re-provision of a new attraction

3.3 Retain structure for a new use

The existing tower structure is sound, and as such there is an option to retain the tower but accept that it will never operate as a ride again. This would involve removing all the equipment associated with the ride (observation gondola, wires, etc) but retain the main tower structure. The cost of this is estimated to be in the region of £30,000, although this would need to be confirmed through a full external survey. Alternative uses for the tower could then be explored, and options here could be to seek sponsorship (as per Morecambe's "polo" tower) or using the tower as a site for a public art installation (eg installing lighting)

PROS:

- All ongoing costs and risks associated with the tower would be significantly reduced
- The iconic nature of the tower would be retained and potentially enhanced
- Income from the telecommunication equipment could be maintained and possibly increased

CONS:

- Rhyl would lose the “ride” aspect of the Sky Tower permanently
- There is still a cost in the region of £30K that would need to be found from somewhere

4. Recommendation

The officer recommendation is that Option 3 – retain structure for a new use – is the most appropriate course of action, and this is likely to form the basis of a report to Denbighshire’s Cabinet on 23 October 2012.

Rhyl Member Area Group are requested to indicate which of the detailed options, or other option not outlined, they consider to be the most appropriate course of action for the Sky Tower. The views of the RMAG will be included in the report to Cabinet referenced above.

1. Purpose of the Report

This report provides information regarding the current position with the above land and outlines an option we are pursuing for the future.

2. Background

Apollo Cinema was subject to considerable improvements which were completed in August 2011. The improvements were jointly funded by WG, DCC and Apollo Cinemas in the sum of £2.4million. Apollo Cinemas a company were very keen not only to develop the cinema building itself, but also the surrounding area to make the location more of a destination to enhance the footfall to the cinema and to provide Rhyl promenade with a catalyst for further investment and development.

With this intention the land to the front of the cinema was advertised for leasing with the sole purpose of developing an outdoor arena with large screen. Apollo Cinemas were the only respondent.

This facility would have created an outdoor cinema, broadcasting digitally live events such as sporting occasions, opera and ballet during the spring/summer months. This area would have easily converted to accommodate an ice skating rink in the winter. This facility would have also provided an attraction Rhyl promenade does not currently offer and would have encouraged surrounding leisure operators to invest. Apollo's funding was to be used for the construction of this facility in order to avoid potential "State Aid Rules". As such there was a delay in commencing the construction of this facility due to Apollo's budget availability.

In April 2012, very unexpectedly Vue Cinemas bought out the whole Apollo portfolio country wide. After a period of consolidation Vue Cinemas were contacted by RGF Officers through an agent to establish what their intention was for this space as the lease for this land had not been completed and was still under the control of Denbighshire County Council. Their response was that they focus entirely on the cinema business and are not interested in proceeding with the development of the Entertainment Plaza.

The cinema continues to trade well and there are no risks regarding the funding WG have contributed to the improvements to the cinema

3. Current Option

There is currently one option under consideration:

3.1 Siting a giant ferris wheel

An advert was placed in the local press for expressions of interest to procure a giant ferris wheel in this location for the 2012 season. Unfortunately there was no response to this advert and after making subsequent enquiries it would appear that they were in short supply due to the Queen's Diamond Jubilee celebrations and the Olympics. Despite a second advert the response was the same

It is our intention to place the advert once again in September in order to ensure the best chance of securing such an attraction 2012 for the 2013 season

PROS:

- An attraction such as this would further enhance the promenade, increasing visitors to the town thereby enhancing the economic situation for surrounding businesses
- Income from the lease would benefit the Council

CONS:

- The attraction would only be seasonal as the exposure to inclement weather in this location would more than likely deter ride operators in the winter period and the demand for such attractions in city centres at Christmas time will be great

4. Recommendation

The proceed with efforts to secure such an attraction for the 2013 season

Bus Service Reductions Working Group

2nd August 2012

1. Reason for the Working Group

It was resolved at the Communities Scrutiny of 14th June 2012 that officers would consult residents, passengers & communities on potential bus service reductions in the light of WG's then 27 per cent reductions in funding. It was further resolved that a working group be established to consider the proposed reductions in the light of the consultation, with a view to recommending further action.

2. Changes since Scrutiny

The WG had now reduced the cuts in 2012/13 from 27 to 10 per cent. It was highly likely that the full 27 per cent would fall in 2013/14. In the light of these changes, members were asked to consider what might appear the least painful reductions for 2012/13 but the full reductions for 2013/14. The cuts included a contingency to take forward passenger requests, notably a service to the new Abergel Hospital eye clinic (though there remained discussions on the potential for some sort of BCU-supported trial).

3. 2012/13 (10%)

It was agreed that the following proposals be included in the final report on bus service reductions. Other than in iv below, no consultee had expressed any issues about these:

- i. Withdraw the £10,000 subsidy for the custody suite demand responsive taxi service from St Asaph to Rhyl.
- ii. Withdraw the approximate £20,000 (a balancing item) in LTSG funding for bus shelters.
- iii. Withdraw £10,000 funding for the bus enquiry office at Rhyl Bus Station.
- iv. Reconfigure the Denbigh town taxi to include the bus to Llansannan and Nantglyn (£15,000) (under consideration before the WG announcement and required because the existing rural arrangements were not working)
- v. At need, £9,000 from other changes as proposed within the original scrutiny report, at need.

4. 2013/14 (10% + 17%)

The officer proposals were discussed in the light of the consultation responses. Members accepted that the decisions they faced were not palatable but that in view of likely reductions in budget in 2013/14 there was a need for decisions.

For April 2013 reductions, it was therefore agreed that all the savings identified under Saving Tranche 1 of the Appendix to the Scrutiny report be included in the final report on bus service reductions, including those in 3. above, save in the light of consultation for:

- i. While recognising the high cost of this service per passenger, officers to seek a compromise for the X5 1640 Ruthin to Corwen and return that might reduce the afternoon service by one bus without jeopardising existing passenger journeys. This would involve examination of both the 1640 and 1740 journeys.
- ii. Reconsideration of the small savings on Saturdays on the Prestatyn Town Service 38.
- iii. Noting that the press had misreported changes to villages south & west of Ruthin, there was nevertheless an opportunity to make some adjustment to services 70/77 (Betws/Clawdd/Cyffylliog/Llanelidan to Ruthin) and 91/95 (Betws/Carrog to Llangollen or Wrexham). These had previously been circulated to the local members affected and would be again, for further thoughts.

In addition, the officer would confirm that the 1818 Denbigh to Ruthin service 76 did not serve Highfield Park, Llangwyfan.

It was also agreed that the officer would forward a copy an indicative 2008 service 1 timetable that would give the suggested level of service to which the service might revert (attached as service B5).

5. Next Steps

As time was now of the essence, members agreed that the best course of action might be for the final report to go straight to Cabinet. The officer agreed to seek a view on this from Democratic Services.
