**ANNEX 1
LICENSING ACT 2003 - MANDATORY CONDITIONS**

Supply of Alcohol

- 1) "No supply of alcohol may be made under this licence"
 - a. At a time when there is no designated premises supervisor in respect of it or,
 - b. At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended."
- 2) "Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence."

The following mandatory conditions are to be applied to the licence stated above in accordance with section 3 (1) of The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010.

1. (1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children-

ANNEXES

(a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-

(i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or

(ii) drink as much alcohol as possible (whether within a time limit or otherwise);

(b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);

(c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;

(d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on-

(i) the outcome of a race, competition or other event or process, or

(ii) the likelihood of anything occurring or not occurring;

(e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.

2. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).

3. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

4. (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

(2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

5. The responsible person shall ensure that-

(a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-

(i) beer or cider: ½ pint;

(ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and

(iii) still wine in a glass: 125 ml; and

(b) customers are made aware of the availability of these measures.

ANNEXES

ANNEX 2 - CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

a) General - all four licensing objectives (b,c,d,e)

Rear car park to be locked by 23:00 hrs

Signs to be displayed requesting patrons to show consideration to neighbours by leaving quietly

Smoking area to be closed by 23:30 hrs

b) The prevention of crime and disorder

The premise adopt a terminal hour of entry to the premise at 23:30 hrs on all days the premise is open

That the core hours of opening are displayed and promoted outside the premise

Premise is an active and supporting member of any Pubwatch scheme in place in the area

CCTV system installed for monitoring purposes only and recorded onto a hard drive to help with the prevention of crime. Only key staff will have access to the system and will be available to the police in the event of an incident. The CCTV will be in operation at all times that the Premises is open; all CCTV footage to be made available to the Police on reasonable request.

Premise to implement a zero tolerance policy on drugs and crime, staff will be advised on what to look for concerning drugs

If an individual is thought to be drunk or acting disorderly they will be asked to leave the premise, if they refuse to leave the police may be requested to assist in the removal of such individuals.

Information is posted inside the building giving information about Challenge 21. The only acceptable forms of ID the premise will accept is; photocard driving licence, passport or proof of age card with hologram. All staff will be made aware of the policy

Full co-operation with North Wales Police and Licensing Authority

SIA Registered Door Supervisors to be employed as required

The Premises will not remain open beyond 00:00 hrs * Refer to Annex 3

c) Public safety

There is a large floodlit car park at the rear of the premises with safe and easy access to Vale Street

The Premises will comply with all relevant Health & Safety/Fire Safety regulations.

d) The prevention of public nuisance

Refer to paragraph (b) above

The provision of live music and juke box music will be discreet and will not be disruptive for neighbouring properties

e) The protection of children from harm

Lounge/snug/restaurant provided for families

No children to remain on the premises after 21:00 hrs

No children in the bar area at any time

Children must be supervised by responsible adult

ANNEX 3 - CONDITIONS ATTACHED AFTER A HEARING BY THE LICENSING AUTHORITY

Conditions attached following Review of Licence on 21st May, 2010

1. To install a CCTV system in place in the Premises within 28 days of the hearing date (21 May 2010) to comply with the minimum requirements as stipulated by the North Wales Police (attached).
2. To install an effective Challenge 25 Policy at the premise and to ensure that all existing and new staff employed at the premises are trained in its use.
3. To ensure that the premises has a fully effective Refusal Book and that all existing and new staff employed at the premises are trained in its use. To ensure that the Refusal Book is available for inspection by authorised officers at all reasonable times.
4. To ensure that the premises has till prompts at each till location reminding all staff to Challenge 25.
5. To ensure that all staff including the Designated Premises Supervisor are fully trained to assess the state of customers and refuse entry to the premises or further sales of alcohol to any person or those with the person assessed as being drunk.
6. To ensure that all training records are retained and are made available for inspection by authorised officers at all reasonable times.
7. Where SIA registered door staff are employed at the premises on those occasions when the premises is serving alcohol past 00:00 hrs, those door supervisors shall be employed from the hour of 22:00 hrs or such a time as the Premises Licence Holder deems fit until the last customer leaves the premises.

CCTV Requirement Minimum Specification

1. Minimum of one high resolution, minimum of 450tvl colour day/night camera, complete with auto iris vari-focal lens, fitted in a heated weatherproof external housing, for external coverage of entrances.
2. Minimum of one high resolution colour camera complete with auto vari-focal lens shall be fitted to each public entrance/exit. Door entrance cameras must be capable of providing good quality head and shoulder images of persons entering/leaving the premises.
3. There must be sufficient cameras able to cope with the normal operating illumination, located within the premises to cover all public areas.
4. Lighting in the foyer and outside must be of sufficient brightness to complement the quality of the camera images
5. In addition to the control equipment, it is recommended that an additional high-resolution monitor should be sited in or near the bar area of foyer entrance. This will give customers and staff visible reassurance on the installation and quality of images provided.
6. All equipment shall have constant time / date generation.

DVD System

1. The unit shall have an on-board CD/DVD re-writer, or have the facility to export images via USB or other device, for evidence recovery.
2. There should be a 'save as' feature so that a still image can be saved and exported to an external system in JPEG or other format.
3. The system must be capable of downloading / copying all the stored CCTV footage to another medium in its native format.
4. There shall be sufficient members of staff trained and available during the hours of operation of

the premise who are able to retrieve evidence at the request of Police or authorised officer.

5. CCTV warning signs shall be fitted in public areas of the premises

6. The CCTV system should be maintained and checked every twelve months, with the installing company producing a letter of compliance.

7. All recording must be kept for a minimum of 31 days. In circumstances where a large number of cameras / system limitation do not allow this, the premise will ensure that images are kept as long as practicable.

8. Recording of incidents at the premise must be made secure and available for inspection by Police or authorised officer. Failure to comply with this request will be regarded as a breach of this condition.

9. The Designated Premises Supervisor of Premise Licence Holder must be able to demonstrate that they have devised a method that prevents recording being tampered with, stolen, misplaced or that have failed to record.

10. An authorised officer may at any time request a recording. Failure to comply with this request will be regarded as a breach of this condition.

11. Unauthorised persons should not be allowed access to the system of view personal data.

12. In the event of a system malfunction, the Designated Premise Supervisor or Premises Licence Holder must immediately notify the Licensing Authority and Police. Details of this malfunction must be recorded in the premise incident book.

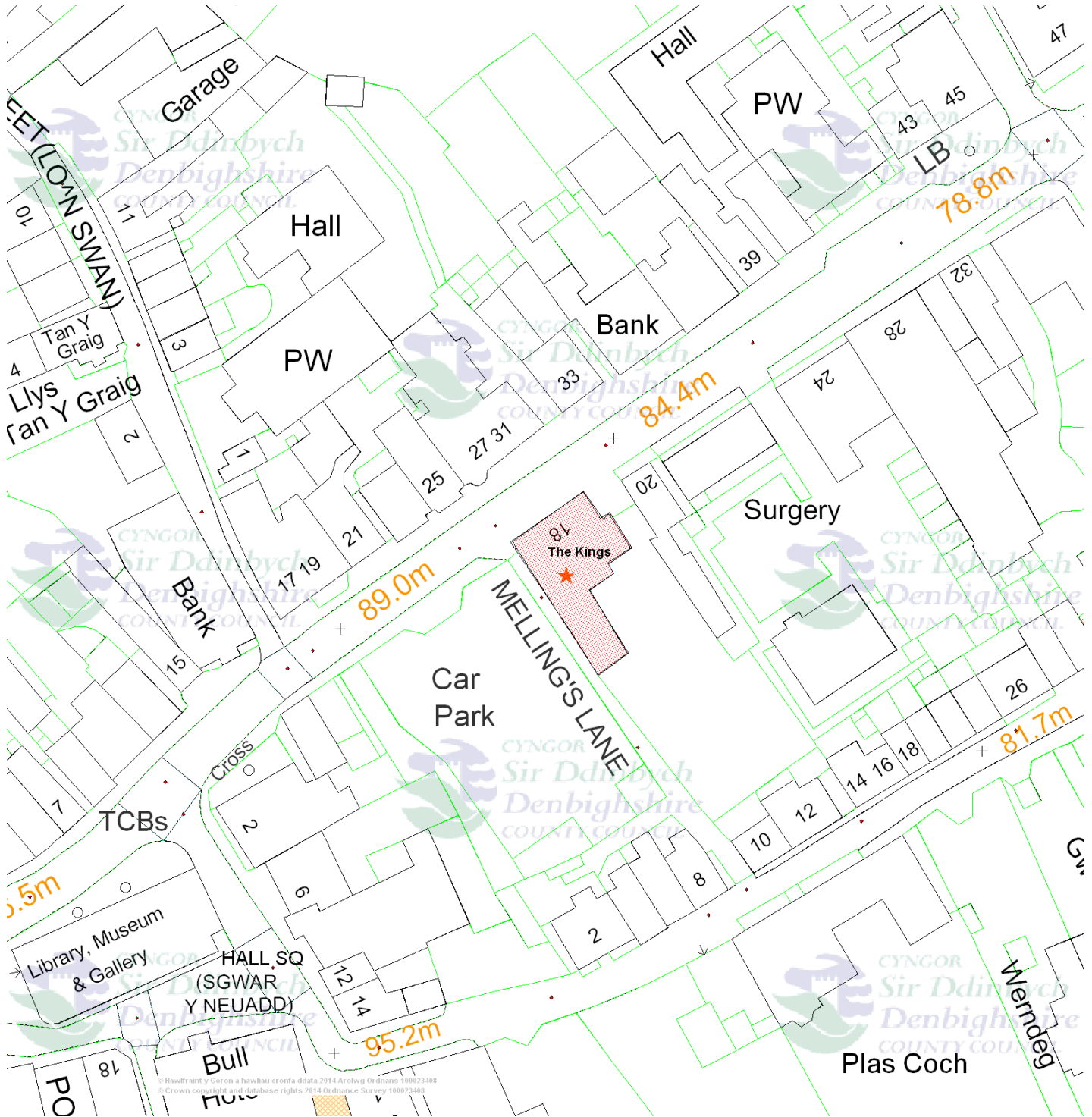
