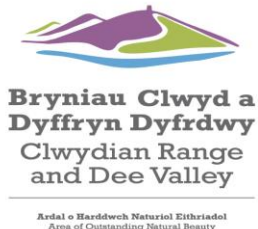

Cafwyd trafodaeth i ddilyn. Gofynnodd aelodau a fyddai digwyddiad Camera Obscura ar Ddinas Brân yn cael ei gynnwys yn Out & About a'r wasg leol, eglurodd Kate y byddai gwaith hyrwyddo unigol yn cael ei gynnal gan fod y digwyddiad yn rhan o Wyl Ymylol Llangollen. Mae Datganiadau Ardal yn cael eu cwblhau yn Sir y Fflint, Sir Ddinbych a Wrecsam.

Tirweddau Dynodedig – Arian Cyfalaf Ychwanegol

Mae'r Dirprwy Weinidog Hannah Blythyn wedi cyhoeddi y bydd tirweddau sy'n cael eu gwarchod yng Nghymru yn derbyn £4 miliwn yn ychwanegol gan Lywodraeth Cymru i alluogi gwelliannau allweddol yn cynnwys datgarboneiddio a mesurau gwyrdd, isadeiledd twristiaeth well a gwella bioamrywiaeth. Bydd swyddog gweithredol a gweinyddwr (wedi'i ariannu gan Lywodraeth Cymru) yn cael eu ph/benodi am ddwy flynedd i alw fforwm tirwedd a ddiogelir ynghyd. Roedd yr AHNE wedi mynegi diddordeb i gynnal y Swyddogion, os bydd yn llwyddiannus, byddai'r AHNE ar y blaen gyda phrosiect cenedlaethol. Mynegwyd pryderon ynglŷn ag effaith negyddol posibl ar lwyth gwaith yr AHNE. Serch hynny, y farn gryf oedd y byddai cynnal y prosiect yn fanteisiol a byddai'n helpu i gadarnhau mawredd a safle'r AHNE yn genedlaethol.

Cafwyd pleidlais ac fe gytunwyd yn unfrydol y byddai Partneriaeth yr AHNE yn cefnogi'r cais i gynnal y prosiect.

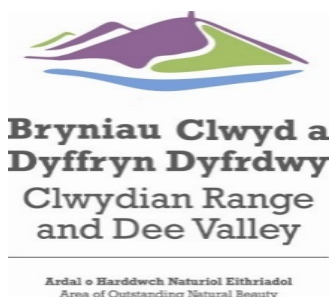

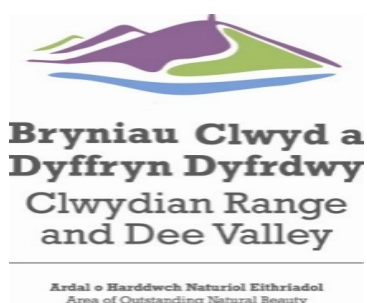

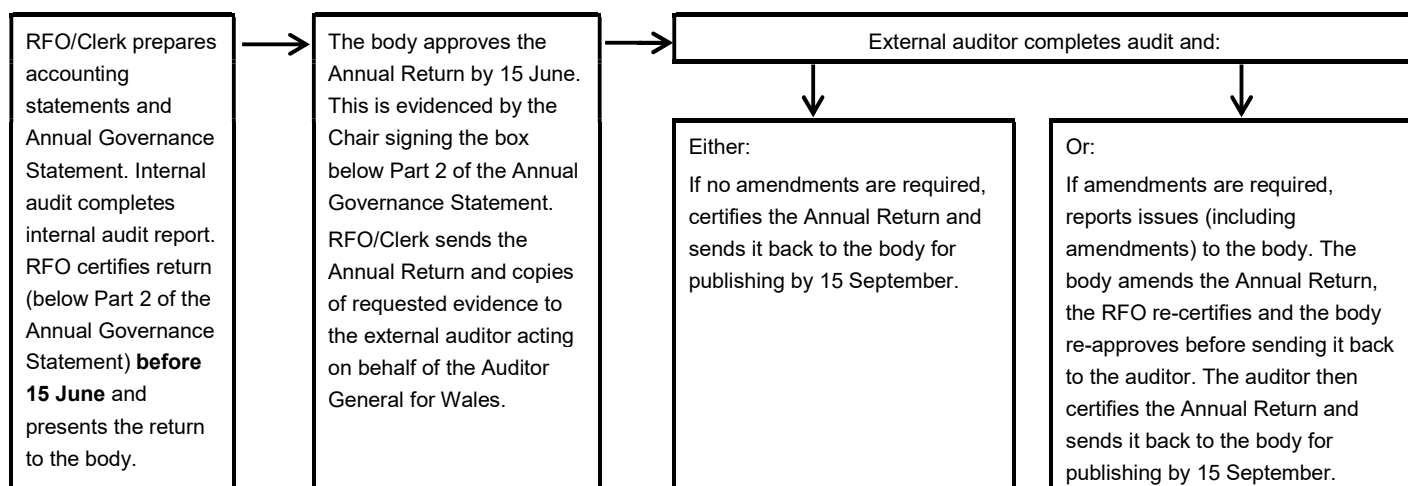

THE ACCOUNTS AND AUDIT PROCESS

Section 12 of the Public Audit (Wales) Act 2004 requires local government bodies in Wales to make up their accounts each year to 31 March and to have those accounts audited by the Auditor General for Wales. Regulation 14 of the Accounts and Audit (Wales) Regulations 2014 states that smaller local government bodies i.e. those with annual income and expenditure below £2.5 million must prepare their accounts in accordance with proper practices.

For minor joint committees with income and expenditure below £2.5 million, proper practices are set out in the One Voice Wales/Society of Local Council Clerks publication 'Governance and accountability for local councils in Wales – A Practitioners' Guide' (the Practitioners' Guide). The Practitioners' Guide requires that they prepare their accounts in the form of an annual return. This annual return meets the requirements of the Practitioners' Guide.

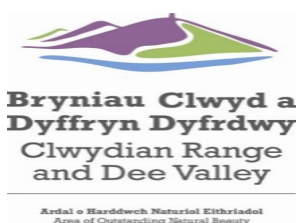

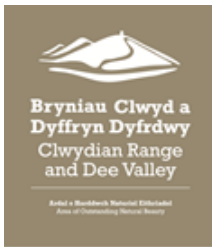

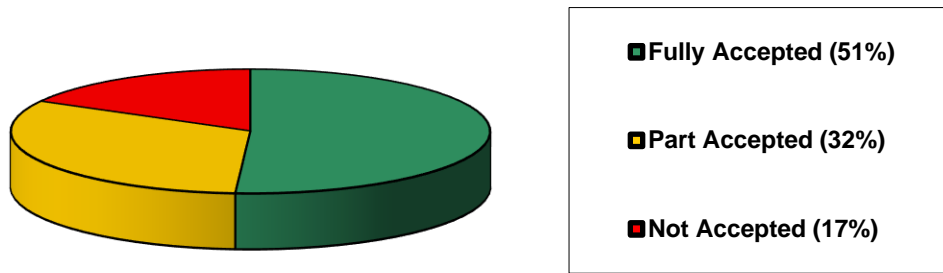
2. Cyfanswm yr ymgynghoriadau a gyfeiriwyd at yr AHNE yn 2019-20 oedd 274. Mae hyn ychydig yn is na'r llynedd (285), a allai fod y rhannol yn adlewyrchiad o'r gostyngiad mewn gweithgarwch yn ystod Mawrth 2020 o ganlyniad i'r pandemig Covid-19.
3. Roedd y rhan fwyaf o ymgynghoriadau (210 mewn nifer, 77% o'r cyfanswm) yn geisiadau cynllunio neu geisiadau cysylltiedig ar gyfer datblygu, a gyfeiriwyd gan y tri awdurdod cynllunio. Roedd y mwyafrif o'r rhain o Sir Ddinbych (75%), yna Sir y Fflint (24%) a Wrecsam (1%). Mae ceisiadau ffurfiol ac anffurfiol am gyngor cyn ac ar ôl ymgeisio yn parhau i gyfrif am ganran sylweddol o'r holl ymgynghoriadau (46 cais, 17% o'r cyfanswm), sy'n uwch na'r llynedd. Roedd materion yn ymwneud â pholisi (9) yn cyfrif am 3% o'r holl ymgynghoriadau, sy'n is na'r llynedd. Roedd apelïadau cynllunio (7) i gyfrif am weddill yr ymgynghoriadau.

Mae nifer y cynigion datblygu sy'n ymwneud â thwristiaeth yn gyson (18%) ac yn parhau i fod yn trydydd categori datblygu mwyaf, cyn amaethyddiaeth (11%), cynigion masnachol/manwerthu a diwydiannol (5%) a datblygiadau cyfleustodau/ynni (4%). Roedd gweddill yr ymgynghoriadau yn cynnwys datblygiadau cymunedol/addysgol, hysbysiadau, ceisiadau Gorchymyn Diogelu Coed, cynigion mynediad a mwynau.

6. Rhoddwyd caniatâd i'r rhan fwyaf o geisiadau cynllunio (87%), sy'n gyfaradwy â graddfa gymeradwyo blynyddoedd blaenorol. Dim ond 9% cais a wrthodwyd, a thynnwyd 4% o geisiadau yn ôl gan yr ymgeiswyr cyn y gwnaethpwyd penderfyniad arnynt.
7. Ni chododd yr AHNE wrthwynebiad i'r rhan fwyaf o geisiadau, dim ond awgrymu newidiadau i'r dyluniad, deunyddiau amgen neu dirlunio ychwanegol neu amodau goleuo er mwyn ceisio cadw a gwella cymeriad ac ymddangosiad yr AHNE. Cafwyd 23 gwrthwynebiad ffurfiol i gynigion datblygu, a mynegwyd pryderon sylweddol am 12 cais pellach. Mewn nifer o achosion mae cynigion datblygu yn cael eu haddasu i adlewyrchu safbwyntiau'r AHNE ac yn arwain at well canlyniad datblygu.

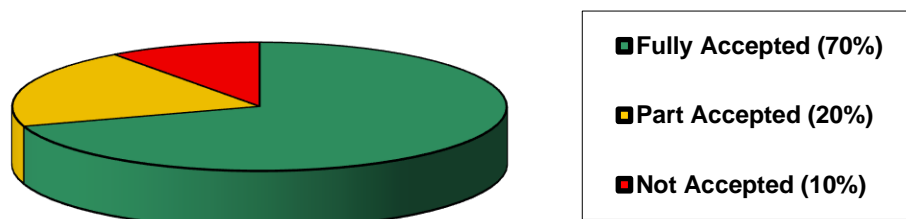

Mae dadansoddiad o ymatebion yr Awdurdod Cynllunio Lleol i sylwadau o sylwedd a wnaed gan yr AHNE ar geisiadau cynllunio a benderfynwyd arnynt (gweler y siart cylch trosodd) yn dangos bod y mwyafrif o'r sylwadau a wnaed gan yr AHNE wedi eu derbyn yn llawn (51%) neu'n rhannol (32%). Dim ond 17% o sylwadau na chafodd eu derbyn ac na weithredwyd arnynt gan yr ACLL. Mae'r perfformiad hwn yn dangos gwelliant parhaus dros y ddwy flynedd ddiwethaf a gall fod yn rhannol oherwydd yr ymdrechion i ddatblygu perthynas yr AHNE gyda'r Awdurdodau Cynllunio Lleol a'r swyddogion cynllunio, ynghyd â mwy o ymwybyddiaeth yn sgil mabwysiadu Canllaw Cynllunio Atodol yr AHNE gan yr Awdurdodau Cynllunio Lleol yn 2018. Hefyd, yn ystod y flwyddyn trosglwyddwyd y cyfrifoldeb rheoli am yr uned AHNE i Wasanaeth Cynllunio, Gwarchod y Cyhoedd a Chefn Gwlad Sir Ddinbych.
9. O'r 17 achos ble na dderbyniwyd sylwadau'r AHNE gan yr Awdurdodau Cynllunio Lleol, penderfynwyd ar 15 cais gan Sir Ddinbych a 2 gan Sir y Fflint. Ni chafwyd achosion yn Wrecsam ble na chafodd sylwadau'r AHNE eu derbyn yn llawn neu'n rhannol. Gan ystyried yr holl benderfyniadau sydd wedi'u gwneud gan bob awdurdod, roedd canran yr achosion ble na dderbyniwyd neu na weithredwyd ar sylwadau'r AHNE yn 18% yn Sir Ddinbych ac yn 12% yn Sir y Fflint. Mae hyn yn parhau i ddangos gwelliant sylweddol mewn perfformiad dros y ddwy flynedd ddiwethaf. Roedd y ffigurau cymharol ar gyfer Sir Ddinbych dros y ddwy flynedd ddiwethaf yn 25% yn 2017-18 ac yn 20% yn 2018-19. Roedd y data cyfwerth ar gyfer y gyfran o geisiadau a benderfynwyd yn Sir y Fflint ble na chafodd sylwadau'r AHNE eu derbyn yn 36% yn 2017-18 ac 16% yn 2018-19.
10. Ar y cyfan, roedd y sylwadau a wrthodwyd yn ymwneud â dyluniad, deunyddiau, goleuo a thirlunio, ac awgrymiadau ar gyfer gwella fel rhan o brosiect datblygu.

Er na dderbyniodd yr Awdurdodau Cynllunio Lleol sylwadau'r AHNE bob tro, mae dadansoddiad pellach o benderfyniadau'r achosion arwyddocaol ble cyflwynodd yr AHNE wrthwynebiad ffurfiol i gais yn dangos bod barn yr AHNE wedi ei derbyn yn llawn gan yr Awdurdod Cynllunio Lleol yn y rhan fwyaf o'r achosion. O'r 10 gwrthwynebiad a gyflwynodd yr AHNE ble cafwyd penderfyniad, bu i'r Awdurdodau Cynllunio Lleol wrthod 7 cais a chymeradwyo 3. Apeliadau Cynllunio

12. O saith apêl cynllunio a gyfeiriwyd at yr AHNE yn ystod y flwyddyn, penderfynwyd ar bedair ac mae tair dal yn aros am benderfyniad. O'r apeliadau hynny a benderfynwyd, gwrthodwyd tri gan yr arolygiaeth a chaniatawyd un. Yr achosion a wrthodwyd oedd estyniad mawr i dŷ ger Llanarmon yn lâl, tŷ newydd ger Trelawnyd ac oriau gweithredu depo llogi peiriannau ger Caerwys. Bu i'r AHNE wrthwynebu neu fynegi pryderon am y tri chais, ac fe gafodd hynny ei ystyried gan yr arolygiaeth. Roedd yr apêl a ganiatawyd yn gysylltiedig â'r un depo llogi peiriannau ger Caerwys ac yn ymwneud â dyluniad goleuadau allanol. Roedd yr arolygydd wedi ystyried pryderon yr AHNE ac eraill ynghylch effeithiau niweidiol posibl ar

awyr dywyll yr AHNE ond daeth i'r casgliad gan fod y safle gryn bellter y tu allan i'r AHNE nad oedd y rhain yn ddigon sylweddol i wrthod caniatâd.

13. Mae'r ddwy apêl sy'n aros am benderfyniad yn ymwneud â datblygiad tai mawr ac isadeiledd ffyrdd cysylltiol ynn Ngallt Melyd. Nid oedd yr AHNE yn gwrthwynebu mewn egwyddor i unrhyw un. Mae'r apêl arall sy'n aros am benderfyniad ar gyfer safle carafanau a gwersylla ger Nercwys. Bu i'r AHNE godi pryderon ynghylch effaith posib gwelliannau mynediad a fyddai'n golygu cael gwared a gwrychoedd sefydledig a waliau ffin carreg.

Datblygiad Heb Awdurdod

14. Yn ystod y flwyddyn cyfeiriwyd 25 achos posibl o ddatblygiad heb awdurdod a oedd yn effeithio ar yr AHNE at dimau gorfodi'r Awdurdod Cynllunio Lleol er mwyn iddynt ymchwilio iddynt. Roedd y mwyafrif (21 achos) yn Sir Ddinbych a 4 yn Sir y Fflint. Ni chafwyd achos o Wrecsam. Roedd cyfran sylweddol o'r achosion hyn yn ymwneud â gweithrediadau peirianneg a gwaith tipio, ond hefyd roedd achosion o newid defnydd, storio cerbydau, llochesau ceffylau, cynhwysyddion morgludo, carafanau, gwaith ar goed a gwro o gynlluniau a gymeradwywyd. Mae materion gorfodi fel rheol yn gymhleth iawn ac mae'n cymryd cryn amser i'r awdurdodau cynllunio ymchwilio iddynt a'u datrys, ac mae nifer o achosion heb eu datrys eto.

Ymgynghoriadau Polisi/Strategol

15. Nifer yr ymgynghoriadau polisi a strategol a gyfeiriwyd at yr AHNE yn 2019-20 oedd 9, a oedd yn ostyngiad mewn gweithgarwch dros y flwyddyn flaenorol, yn bennaf o ganlyniad i lawer llai o ddogfennau ymgynghori yn cael eu cyflwyno gan Lywodraeth Cymru a oedd yn berthnasol i'r AHNE. Fodd bynnag, cyhoeddodd Llywodraeth Cymru *Fframwaith Datblygiad Cenedlaethol 2020-2040* (FfDC) drafft, ymgynghorol yn ystod y flwyddyn, sydd o bosib â goblygiadau sylweddol ar gyfer yr AHNE. Bydd y FfDC yn ffurfio rhan o system y cynllun datblygu statudol yng Nghymru a rhaid i gynlluniau datblygu lleol gydymffurfio â'r polisiâu a'r cynigion cenedlaethol sydd yn y ddogfen. Bu i'r AHNE gyflwyno nifer o sylwadau ar y FfDC drafft a chodi pryderon arbennig mewn perthynas â chynigion ynni gwynt ar y tir a'u heffaith posib ar ein tirwedd a warchodir yn genedlaethol. Mae Llywodraeth Cymru yn ystyried ymatebion i'r ddogfen ddrafft ac yn bwriadu cyhoeddi'r FfDC terfynol ddiwedd 2020.
16. Bu i'r awdurdodau cynllunio barhau i wneud cynnydd gyda'r Cynlluniau Datblygu Lleol yn ystod y flwyddyn. Bu i'r AHNE ymateb i *Ymgynghoriad Strategaeth a Ffeirir* Ddrafft a *Safleoedd Ymgeisiol CDLL 2018-2033 Sir Ddinbych* ac *Ymgynghoriad Safleoedd Ymgeisiol Ychwanegol* dilynol. Cyhoeddodd Sir y Fflint y *Cynllun Datblygu Lleol i'w Archwilio 2015-2030* ac *Ymgynghoriad Safleoedd Ymgeisiol* cysylltiol. Cyflwynodd yr AHNE sylwadau ar yr holl ymgynghoriadau hyn gan geisio addasiadau i gadw a gwella cymeriad ac ymddangosiad yr AHNE yn gyson gyda'n Cynllun Rheoli. Yn ystod y flwyddyn bu i *Gynllun i'w Archwilio Gan Y Cyhoedd CDLL Wrecsam* barhau ei archwiliad, sy'n barhaus.

Gweithgor Cymeriad Tirwedd ac Amgylchedd Adeiledig

17. Mae Gweithgor Cymeriad Tirwedd ac Amgylchedd Adeiledig yr AHNE yn arwain ar faterion cynllunio a datblygu sy'n effeithio ar yr AHNE. Bu i'r grŵp gyfarfod dair gwaith yn ystod y flwyddyn ac yn parhau i ddatblygu ac adolygu eu rhaglen gwaith i'r dyfodol, sy'n blaenoriaethu camau gweithredu yn codi o Gynllun Rheoli'r AHNE. Yn ogystal â gwneud sylwadau ynghylch materion polisi a chynigion datblygu mawr, datblygodd y grŵp nifer o gamau gweithredu pwysig y Cynllun Rheoli, y rhai mwyaf sylweddol oedd y Fenter Awyr Dywyll a lleihau amhariad gweledol. Bu i'r gweithgor hefyd adolygu'r sefyllfa ddiweddaraf ar faterion cynllunio gwastraff a mwynau yn ac o amgylch yr AHNE.
18. Symudodd dyhead yr AHNE i sicrhau cydnabyddiaeth Cymuned Awyr Dywyll ffurfiol gan Gymdeithas Awyr Dywyll Genedlaethol (IDA) ymlaen yn ystod y flwyddyn. Daethpwyd i gytundeb gyda'r IDA i gyflwyno cais ar gyfer dynodiad yr AHNE fel Cymuned Awyr Dywyll yn Rhagfyr 2020, er ei bod yn debygol iawn y bydd rhaid gohirio ein cais o ganlyniad i oedi anochel a achoswyd gan y pandemig Covid-19. Mae'r cais i'r IDA yn amodol ar fabwysiadu canllaw cynllunio atodol (CCA) penodol yn ymwneud â materion goleuo a chytuno ar Bolisi Goleuo. Gyda chefnogaeth y tri awdurdod cynllunio lleol, penodwyd ymgynghorwyr i ddatblygu'r CCA a chynhyrchwyd drafft cyntaf o ddogfen, sydd ar hyn o bryd yn cael ei hadolygu gan weithgor o swyddogion sy'n cynnwys cynrychiolwyr o'r tri Awdurdod Cynllunio Lleol, Cyfoeth Naturiol Cymru a'r AHNE. Mae'r Polisi Goleuo yn ymwneud yn bennaf â gwaith yr awdurdodau goleuadau stryd cyhoeddus a chynhaliwyd cyfarfodydd gyda chynrychiolwyr o'r asiantau hyn. Daethpwyd i gytundeb ar ffordd ymlaen gydag adendwm Awyr Dywyll AHNE i'r Polisi Goleuo Priffyrdd cyfredol ac mae gwaith yn parhau ar ddrafftio'r ddogfen. Mae ymgysylltu â'r gymuned a chodi ymwybyddiaeth o faterion awyr dywyll trwy amrywiol ddigwyddiadau a drefnwyd gan Swyddog Awyr Dywyll Tirweddau Gwarchoddedig Gogledd Cymru wedi parhau yn ystod y flwyddyn. Yn ogystal â hyn, mae sylwadau'r AHNE ar geisiadau cynllunio yn parhau i hyrwyddo'r angen ar gyfer goleuo sy'n addas i awyr dywyll ble gallai hyn fod yn broblem.
19. Gwnaed cynnydd pellach o ran gostwng amhariad gweledol trwy'r Fenter Gwella Tirwedd y Grid Cenedlaethol (LEI) yn ardaloedd Dyffryn Morwynion a Thremeirchion, a gwnaed cais llwyddiannus i barhau ac ymestyn y fenter i ardal Y Mwynglawdd. Mae partneriaeth hirdymor AHNE gyda Scottish Power i dynnu llinellau trydan uwchben a'u gosod o dan y ddaear hefyd wedi parhau, gyda chynlluniau wedi eu cwblhau ym Mwlch Yr Oernant a Moel Hiraddug. Mae'r prosiectau tirwedd ymarferol a chadarnhaol hyn yn gwneud cyfraniad gwerthfawr i gadw a gwella cymeriad ac ymddangosiad tirwedd yr AHNE.
20. Eleni arweiniwyd Fforwm AHNE Blynyddol gan y Gweithgor Cymeriad Tirwedd ac Amgylchedd Adeiledig a'r thema oedd 'Cadw a Gwella Ansawdd a Chymeriad y Dirwedd'. Cynhaliwyd y fforwm ym mis Tachwedd yn Hen Lys Rhuthun sydd wedi cael ei adnewyddu, ac er gwaetha'r tywydd, roedd nifer dda yn bresennol a chafwyd nifer o gyflwyniadau diddorol a llawn gwybodaeth. Roedd y rhain yn cynnwys sut i ddylunio datblygiad newydd i barchu cymeriad a nodweddion yr AHNE, a lleihau amhariad gweledol trwy'r Rhaglen Gwelliant Gweledol y Grid Cenedlaethol a'r cynllun LEI cysylltiedig â rhaglen gosod llinellau trydan uwchben o dan y ddaear Scottish Power. Cafodd y fforwm ddiweddariad hefyd ar y prosiect 'Ein Tirwedd Ddarluniadwy' ardderchog.
