### 1 APOLOGIES

#### 2 DECLARATION OF INTERESTS

No declaration of interest had been raised.

#### 3 APPOINTMENT OF CHAIR

Nominations were sought for Chair of the Licensing Committee for 2023/24. Councillor Andrea Tomlin proposed, seconded by Councillor Hugh Irving, that Councillor Bobby Feeley be appointed Chair. There were no further nominations.

**RESOLVED** that Councillor Bobby Feeley be appointed Chair of the Licensing Committee for the ensuing year.

#### 4 APPOINTMENT OF VICE CHAIR

Nominations were sought for Vice Chair of the Licensing Committee for 2023/24. Councillor Brian Jones proposed, seconded by Councillor Andrea Tomlin, that Councillor Hugh Irving be appointed Vice Chair. There were no further nominations.

**RESOLVED** that Councillor Hugh Irving be appointed Vice Chair of the Licensing Committee for the ensuing year.

### 5 URGENT MATTERS AS AGREED BY THE CHAIR

No urgent matters had been raised.

### 6 MINUTES OF THE LAST MEETING

The minutes of the Licensing Committee held on 7 December 2022 were submitted.

**RESOLVED** that the minutes of the meeting held on 7 December 2022 be received and confirmed as a correct record.

#### 7 UPDATE ON THE WORK OF THE LICENSING SECTION IN 2022/23

The Public Protection Business Manager (PPBM) submitted a report (previously circulated) updating members on the work of the Licensing Section during 2022/23 which focused on both operational and management matters.

The report provided statistical data of the number of licences issued, complaints and service requests received covering the main functions – Alcohol and Entertainment; Hackney and Private Hire Licensing; Gambling, Gaming and Lotteries; Street Trading; Charity Collections and Scrap Metal together with other activities including service requests/freedom of information, overall workload results and communications. Management matters included reference to policies, fees and future workload considerations. The PPBM guided members through the report.

Members took the opportunity to discuss various aspects of the report with the PPBM who responded to questions and comments as follows –

- there were fewer applicants/drivers appearing before the committee which was a reflection of how well the current policy was working, with powers delegated to officers within the policy framework, and matters only being brought before members that involved deviation from policy in exceptional circumstances
- over the last twelve months there had been 34 new licensed driver applications and 24 licensed drivers leaving the profession resulting in an extra 10 licensed drivers during that period. However, there was a downward trend in the number of licensed drivers and vehicles generally
- it was reasonable to conclude that the reduction in the number of vehicle defects identified had been due to the effectiveness of the policy and testing regime
- it was agreed to include in future reports the number of premises licences surrendered in order to identify any trends/pressures, although it was noted that not all licences were surrendered when licensed premises ceased operating
- charitable collections involving putting clothing bags through letterboxes door to door were largely exempt from licensing due to charities holding Home Office Exemptions
- provided assurances that there was regular communication via email with the taxi trade which included highlighting the defects identified following vehicle inspections in order to raise awareness of those issues
- serious vehicle safety defects would involve suspension of the licence pending completion of the required works but vehicles with minor defects could continue operating with a notice of relevant works for completion within a set time period
- most complaints received in relation to licensed premises were linked to noise nuisance and predominantly an issue for Pollution Control, with the remit of Licensing Officers confined to ensuring licensing conditions were met. However, both Licensing and Pollution Control Officers worked closely together with a view to resolving issues of noise nuisance linked to licensed premises

- elaborated on the role and remit of the Personal Licence Holder and Designated Premises Supervisor in the operation of licensed premises; detailed the differences between Street Trading Permits issued by the Council and Pedlar's Certificates issued by the Police; and reported on the requirements for Scrap Metal Licences including separate licences for both sites and collectors
- reference to taxi licences issued could be found on the Council's website and once the work on the new database was completed it was hoped that information on all licences issued would be available for the public to view
- despite the continuing move to online processing the option remained for cash and cheque payments via One Stop Shops and arrangements made for those applicants/licensees who did not use the online service
- the number of Betting Shops in the county had remained static over the last few years and online provision was regulated by the Gambling Commission
- provided an update on the Welsh Government's White Paper on taxi and private hire licensing, with the closing date of 1 June 2023 on the initial consultation, and a further consultation on the detailed proposals expected in the autumn.

The Chair and members thanked the PPBM for the informative report on the scope and comprehensive work of the Licensing Section, and to all those who had contributed to that process.

**RESOLVED** that the contents of the report be noted.

#### 8 LICENSING COMMITTEE FORWARD WORK PROGRAMME

The Senior Licensing Officer submitted a report (previously circulated) on the priorities of the Licensing Section together with a revised forward work programme.

The priorities of the Licensing Section reflected the duty placed on the authority in relation to its responsibilities for the licensing function and the effective regulation, control and enforcement of licensees together with the authority's commitment to safer communities and the development of the economy. The scheduled review of the Hackney Carriage and Private Hire Statement of Policy had been postponed pending the outcome of the consultation on the recently published Welsh Government White Paper: Taxi and Private Hire Vehicle (PHV) (Wales) Bill, and a revised work programme had been presented for consideration. [A member briefing on the White Paper had been arranged immediately following the meeting.]

Members noted the update and revised forward work programme. It was confirmed that member training would also be included in the forward work programme.

#### 1.0 PURPOSE OF THE REPORT

1.1 To review the current tariff charges for hackney carriage vehicles (taxis).

#### 2.0 EXECUTIVE SUMMARY

2.1 Following a request by a licensed driver to review the current tariff charges officers have drafted proposals for further consultation.

#### 3.0 POWER TO MAKE THE DECISION

3.1 Local Government (Miscellaneous Provisions) Act 1976.

#### 4.0 BACKGROUND INFORMATION

- 4.1 Section 65 of the Local Government (Miscellaneous Provisions) Act 1976 ("the Act") allows the Council to fix the rates or fares within the county in connection with the hire of a vehicle.
- 4.2 A request was received by a licence holder to increase all tariffs and extras by 10%, using inflation as a marker. The justification submitted as part of the request was:
  - *i.* In the last 12 months costs have continued to increase at an alarming rate, with inflation running at over 10%, above inflation wage rises, garage costs increasing and electric costs increasing by over 50%.
  - ii. We also have the imminent imposition of the 30mph to 20mph speed reduction on September 17<sup>th</sup>. This will increase journey times. As taxis charge by the mile the drivers will be able to earn less per hour as they will be able to cover less miles.
  - iii. Payment by card more customers than ever wish to pay by card, in real terms this is a 2-3% reduction in the fare due to processing fees

- 4.3 As a result of the fare review request, Officers have taken the opportunity to consult with all licence holders on the proposal received, to gain an understanding of whether there is general support from the trade for a fare increase at this time. From 280 licensed drivers, we received 56 responses of which 47 were in support of a fare increase, which Officers feel is a sufficient number to progress with a fare review.
- 4.4 As a result of the consultation with licence holders, alternative proposals were submitted which can be found at Appendix A. As you can see there were many variations which were considered too many for this review.
- 4.5 Members will be aware that during 2022 a comprehensive hackney carriage fare review was undertaken by a Consultant, who recommended adopting a methodology for calculating any future fares. However in order to be able to utilise the methodology, data is required from licence holders to feed into the calculation and engagement from the trade is paramount for the methodology to be effective. This process has started but will take some time to obtain sufficient data to have a meaningful effect/result. In the absence of this data the Consultant recommended using the Retail Price Index for Motoring as a tool to increase/decrease fares. Members may wish to note that National Rail fares are also linked to RPI data as a whole, i.e. not just motoring, released every July.
- 4.6 The current Retail Price Index for Motoring as of August 2023 is 4.8%
- 4.7 The current tariff for Denbighshire is attached at Appendix B.
- 4.8 Members should note that although the Council set the table of fares a hackney carriage proprietor can charge a customer a lesser fee; the set charge is only the maximum charge permitted.

### 5.0 CONSIDERATIONS

- 5.1 The current "table of fares" was last amended in July 2022.
- 5.2 The charges for distance are used to compile a "league table" of taxi fares throughout the UK, produced by the Private Hire and Taxi Monthly <u>https://www.phtm.co.uk/newspaper/taxi-fares-league-tables</u>. Comparisons are based on two-mile journey on the normal tariff and does not take account of any extras / additions. Positon "1" is dearest.
- 5.3 Based on current charges Denbighshire are listed within the "league table", as of August 2023 as follows on the below table:

- 5.4 Should Members be minded to support a fare increase based on the proposal received as detailed in 4.2 above, it would amount to a 10% increase in maximum charges. Alternatively, should Members be minded to support a fare increase based on the Retail Price Index for Motoring, as previously recommended, it would amount to a 5 % increase in maximum charges (the percentage rate has been rounded up from 4.8%).
- 5.5 For ease of reference please refer to Appendix C to view what each proposal would amount to in terms of tariff, additional items and 2 mile journey together with details of maximum current fares for journeys for the six North Wales Counties.
- 5.6 Should Members resolve to support an increase in the current fares, Officers propose to go out to public consultation by publishing the required statutory notice for variations on the tariff. This notice must appear in one local newspaper circulated in the County and detail the proposed new tariff. There is a minimum statutory period of 14 days and Officers are proposing to run this for a period for 28 days. The notice will specify how and where objections can be made along with a specified date on which the tariff will take effect, if there are no objections.
- 5.7 If no objections are received at this stage the amended scale of fares and charges will come into effect after the expiration of the public notice i.e. the date specified. However, should objections be received at this stage, they must be brought back to the Licensing Committee for further consideration for a final tariff and a date of implementation.
- 5.8 Members should note that any final tariff will require a Lead Member Delegated decision to ensure the Council meets its constitutional obligations.
- 5.9 In summary Members are being asked to consider one of the following options:
  - Retain the current table of fares;
  - Support the proposal received to increase the tariff by 10%;
  - to increase the tariff in line with the Retail Price Index all Motoring as recommended by the Consultant;

### 6.0 **RECOMMENDATION**

- 6.1 Having considered of all of the available information it is recommended that Members instruct Officers to consult on the implementation of an increase to the tariff by 5% (rounded to the nearest full percent) in line with the Retail Price Index all Motoring.
- 6.2 Members are reminded that they may opt to take a different course of action i.e. do nothing by retaining the current table of fares, or support the proposal from the driver.
- 6.3 Authorise officers to proceed with statutory notice with an implementation date of at least 28 days following publication of the notice.
- 6.4 Instruct officers to prepare a report for the next Licensing Committee if any objections are received to that statutory notice.

#### 1. PURPOSE OF THE REPORT

1.2 To present, to Members, revised Byelaws relating to Hackney Carriage regulation, for their consideration.

#### 2. EXECUTIVE SUMMARY

2.1 For Members to consider approving the Department for Transport Model Byelaws under Section 68 of the Town Police Clauses Act 1847.

### 3. BACKGROUND INFORMATION

- 3.1 The Council, as the Licensing Authority, has the responsibility under the Town Police Clauses Act 1847, and the Local Government (Miscellaneous Provisions) Act 1976 for the licensing of Hackney Carriages and their drivers.
- 3.2 Since reorganisation in 1996 the Council has exercised this responsibility through the Council's Hackney Carriage and Private Hire Licensing Conditions (The Blue Book) and through Byelaws relating to Rhyl and Prestatyn only.
- 3.3 Expert Legal advice has recommended that the Council adopt Byelaws which cover the whole of the County to ensure that they accurately reflect changes in legislation and to ensure a fair, transparent and consistent approach is taken when determining enforcement and other issues relating to hackney carriage vehicles and drivers.
- 3.4 Section 68 of The Town Police Clauses Act 1847 allows a local authority

to make Byelaws for regulating the conduct of the proprietors and drivers of Hackney Carriages within their authority area.

- 3.5 The Department for Transport has produced a set of Model Byelaws as a basis for local authorities to use and it is not the intention to deviate from these model Byelaws, which can be found at Appendix A.
- 3.6 Making byelaws under s68 of the Town Police Clauses Act 1847 is a Council function (as opposed to an Executive function) under the Local Authorities Executive Arrangements (Functions and Responsibilities) (Wales) Regulations 2007. A report will therefore need to be presented to Full Council at a later date if Members are minded to support the model Department for Transport Byelaws.
- 3.7 The current Byelaws relate to the Rhyl and Prestatyn only and were confirmed on the 25<sup>th</sup> January 1972 (for Rhyl) and the 18<sup>th</sup> April 1975 (for Prestatyn) by the Secretary of State. Should the Council adopt the model Byelaws the Rhyl and Prestatyn Byelaws will be repealed. A copy of the current Byelaws can be found at Appendix B.

#### 4. CONSULTATION

- 4.1 Should Members be minded to support the proposed Department for Transport Model Byelaws, Officers will start formal consultation with all Hackney Carriage Proprietors and licensed drivers.
- 4.2 Any representations following the consultation will be reported to Full Council for Members consideration.

### 5. **RECOMMENDATION**

5.1 For Members to support the proposed Department of Transport Model Byelaws found at Appendix A and authorise Officers to commence consultation as detailed in 4.1 above.



## **BYELAWS – HACKNEY CARRIAGES**

Made under Section 68 of the Town Police Clauses Act 1847, and Section 171 of the Public Health Act 1875, by Denbighshire County Council with respect to hackney carriages in the county of Denbighshire

#### Interpretation

1. Throughout these byelaws "the Council" means the County Council of Denbighshire and "the District" means the County of Denbighshire

#### Provisions regulating the manner in which the number of each hackney carriage corresponding with the number of its licence, shall be displayed

2. (a) The proprietor of a hackney carriage shall cause the number of the licence granted to him in respect of the carriage to be legibly painted or marked on the outside and inside of the carriage or on plates provided by the Council prominently affixed at the front and rear

(b) A proprietor or driver of a hackney carriage shall not: -

- (i) wilfully or negligently cause or permit any such number to be concealed from public view while the carriage is standing or plying for hire;
- (ii) cause or permit the carriage to stand or ply for hire with any such painting, marking or plate so defaced that any figure or material particular is illegible.

## Provisions regulating how hackney carriages are to be furnished or provided

- 3. The proprietor of a hackney carriage shall:-
  - (a) provide sufficient means by which any person in the carriage may communicate with the driver;
  - (b) cause the roof or covering to be kept watertight;

- (c) provide any necessary windows and a means of opening and closing not less than one window on each side;
- (d) cause the seats to be properly cushioned or covered;
- (e) cause the floor to be provided with a proper carpet, mat, or other suitable covering;
- (f) cause the fittings and furniture generally to be kept in a clean condition, well maintained and in every way fit for public service;
- (g) provide means for securing luggage, if the carriage is so constructed as to carry luggage;
- (h) provide an efficient fire extinguisher which shall be carried in such a position as to be readily available for use; and
- (i) provide at least two doors for the use of persons conveyed in such carriage and a separate means of ingress and egress for the driver.
- 4. The proprietor of a hackney carriage shall cause any taximeter with which the carriage is provided to be so constructed, attached and maintained as to comply with the following requirements, that is to say:-
  - (a) the taximeter shall be fitted with a key, flag or other device, the operating of which will bring the machinery of the taximeter into action and cause the word "HIRED" or the word "HURIWYD" to appear on the face of the taximeter;
  - (b) such key, flag or other device shall be capable of being locked in such a position that the machinery of the taximeter is not in action and that no fare is recorded on the face of the taximeter;
  - (c) when the machinery of the taximeter is in action there shall be recorded on the face of the taximeter in clearly legible figures a fare equal to the rate or fare which the proprietor or driver is entitled to demand and take for hire of the carriage by time and distance in pursuance of the tariff fixed by the Council;
  - (d) the word "FARE" or "PRIS" shall be printed on the face of the taximeter in plain letters so as clearly to apply to the fare recorded thereon;
  - (e) the taximeter shall be so placed that all letters and figures on the face thereof are at all times plainly visible to any person being conveyed in the carriage and for that purpose the letters and figures shall be capable of being suitably illuminated during any period of hiring; and

(f) the taximeter and all the fittings thereof shall be so affixed to the carriage in such a way so that it shall not be practicable for any person to tamper with them except by breaking, damaging or permanently displacing the seals or other appliances.

Provisions regulating the conduct of the proprietors and drivers of hackney carriages plying within the district in their several employments, and determining whether such drivers shall wear any and what badges

- 5. The driver of a hackney carriage provided with a taximeter shall:-
  - (a) when standing or plying for hire, keep the key, flag or other device fitted in pursuance of the byelaw in that behalf locked in the position in which no fare is recorded on the face of the taximeter;
  - (b) before beginning a journey for which a fare is charged for distance and time, bring the machinery of the taximeter into action by moving the said key flag or other device, so that the word "HIRED" or the word "HURIWYD" is legible on the face of the taximeter and keep the machinery of the taximeter in action until the termination of the hiring; and
  - (c) cause the dial of the taximeter to be kept properly illuminated throughout any part of a hiring which is between half an hour after sunset and half an hour before sunrise, and also at any other time at the request of the hirer.
- 6. A proprietor or driver of a hackney carriage shall not tamper with or permit any person to tamper with any taximeter with which the carriage is provided, with the fittings thereof, or with the seals affixed thereto.
- 7. The driver of a hackney carriage shall, when plying for hire in any street and not actually hired:-
  - (a)proceed with reasonable speed to one of the stands appointed by the Council
  - (b)if a stand, at the time of his arrival, is occupied by the full number of carriages authorised to occupy it, proceed to another stand
  - (c)on arriving at a stand not already occupied by the full number of carriages authorised to occupy it, station the carriage immediately behind the carriage or carriages on the stand and so as to face in the same direction; and
  - (d) from time to time when any other carriage immediately in front is driven off or moved forward, cause the carriage to be moved forward

so as to fill the place previously occupied by the carriage driven off or moved forward.

- (e) remain with the carriage and be ready to be hired at once by any person when his carriage has remained on the stand for a longer period of time than any other carriage waiting to be hire on the said stand.
- 8. A proprietor or driver of a hackney carriage, when standing or plying for hire, shall not make use of the services of any other person to importune any person to hire such carriage.
- 9. The driver of a hackney carriage shall behave in a civil and orderly manner and shall take all reasonable precautions to ensure the safety of persons conveyed in or entering or alighting from the vehicle.
- 10. The proprietor or driver of a hackney carriage who has agreed or has been hired to be in attendance with the carriage at an appointed time and place shall, unless delayed or prevented by some sufficient cause, punctually attend with such carriage at such appointed time and place
- 11. A proprietor or driver of a hackney carriage shall not convey or permit to be conveyed in such carriage any greater number of persons than the number of persons specified on the plate affixed to the outside of the carriage;
- 12. If a badge has been provided by the Council and delivered to the driver of a hackney carriage he shall, when standing or plying for hire, and when hired, wear that badge in such position and manner as to be plainly visible.
- 13. If requested by the hirer of the hackney carriage the driver shall provide a receipt for the fare paid. The receipt shall include the first name, the surname and badge number of the driver and the name of the Operator (if any).
- 14. The driver of a hackney carriage so constructed as to carry luggage shall, when requested by any person hiring or seeking to hire the carriage:-
  - (a) convey a reasonable quantity of luggage;
  - (b) afford reasonable assistance in loading and unloading; and
  - (c) afford reasonable assistance in removing it to or from the entrance of any building, station or place at which they may take up or set down such person.

## Provisions fixing the rates or fares to be paid for hackney carriages within the district and securing the due publication of such fares

- 15. (a) The proprietor or driver of a hackney carriage shall be entitled to demand and take for the hire of the carriage the rate or fare prescribed by the Council, the rate or fare being calculated by a combination of distance and time unless the hirer express at the commencement of the hiring his desire to engage by time.
  - (b) Provided always that where a hackney carriage furnished with a taximeter is hired by distance and time the proprietor or driver thereof shall not be entitled to demand and take a fare greater than that recorded on the taximeter, save for any extra charges authorised by the Council which it may not be possible to record on the face of the taximeter.
- 16. (a) The proprietor of a hackney carriage shall cause a statement of the fares fixed by Council resolution to be exhibited inside the carriage in clearly distinguishable letters and figures.
  - (b) The proprietor or driver of a hackney carriage bearing a statement of fares in accordance with this byelaw shall not wilfully or negligently cause or permit the letters or figures in the statement to be concealed or rendered illegible at any time while the carriage is plying or being used for hire.

# Provision securing the safe custody and re-delivery of any property accidentally left in hackney carriages and fixing the charges to be made in respect thereof

- 17. The proprietor or driver of a hackney carriage shall immediately after the termination of any hiring or as soon as practicable thereafter carefully search the carriage for any property which may have been accidentally left therein.
- 18. The proprietor or driver of a hackney carriage shall, if any property accidentally left therein by any person who may have been conveyed in the carriage be found by or handed to him:-
  - (a) carry it as soon as possible and in any event within 48 hours, if not sooner claimed by or on behalf of its owner, to a Police Station in the district, and leave it in the custody of the officer in charge of the station on his giving a receipt for it;
  - (b) be entitled to receive from any person to whom the property shall be re-delivered an amount equal to five pence in the pound of its estimated value (or the fare for the distance from the place of finding to the Police Station, whichever be the greater) but not more than five pounds.

## PENALTIES

19. Every person who shall offend against any of these byelaws shall be liable on summary conviction to a fine not exceeding level 2 on the standard scale and in the case of a continuing offence to a further fine not exceeding two pounds for each day during which the offence continues after conviction therefor.

### REPEAL OF BYELAWS

- (i) The byelaws relating to hackney carriages in the former Urban District of Rhyl which were made by the Council of the Borough of Rhuddlan on the 11th day of February 1975 and which were confirmed by the Secretary of State on the 18<sup>th</sup> April 1975 and came into operation on the 1st day of May 1975; and

#### **BYELAWS**

made under Section 68 of the Town Police Clauses Act 1847, and Section 171 of the Public Health Act 1875, by the Council of the Borough of Rhuddlan with respect to Hackney carriages in the former Urban District of Rhyl.

#### INTERPRETATION

 Throughout these byelaws "the Council" means the Council of the Borough of Rhuddlan and "the district" means the former Urban District of Rhyl.

Provisions regulating the manner in which the number of each hackney carriage corresponding with the number of its licence, shall be displayed.

- (a) The proprietor of a hackney carriage shall cause the number of the licence granted to him in respect of the carriage to be legibly painted or marked on the outside and inside of the carriage, or on plates affixed thereto,
  - (b) A proprietor or driver of a hackney carriage shall:-
    - (i) not wilfully or negligently cause or suffer any such number to be concealed from public view while the carriage is standing or plying for hire;
    - (ii) not cause or permit the carriage to stand or ply for hire with any such painting, marking or plate so defaced that any figure or material particular is illegible.

Provisions regulating how hackney carriages are to be furnished or provided.

- 3. The proprietor of a hackney carriage shall:-
  - (a) provide sufficient means by which any person in the carriage may communicate with the driver;
  - (b) cause the roof or covering to be kept water-tight;
  - (c) provide any necessary windows and a means of opening and closing not less than one window on each side;

(d) cause the seats to be properly cushioned or covered;

- (e) cause the floor to be provided with a proper carpet, mat, or other suitable covering;
- (f) cause the fittings and furniture generally to be kept in a clean condition, well maintained and in every way fit for public service;
  - (g) provide means for securing luggage if the carriage is so constructed as to carry luggage;
  - (h) provide an efficient fire extinguisher which shall be carried in such a position as to be readily available for use;
  - (i) provide at least two doors for the use of persons conveyed in such carriage and a separate means of ingress and egress for the driver.

#### 4. The proprietor of a hackney carriage shall,

, cause the same to be provided with a taximeter so constructed as to be capable of registering two alternative tariffs and so attached and maintained as to comply with the following requirements, that is to say,

- (a) If the taximeter is fitted with a flag or other device bearing the words "FOR HIRE";
  - (i) the words "FOR HIRE" shall be exhibited on each side of the flag or other device in plain letters at least one and a half inches in height and the flag or other device shall be capable of being locked in a position in which the words are horizontal and legible;
  - (ii) when the flag or other device is so locked the machinery of the taximeter shall not be in action and the means of bringing it into action shall be by moving the flag or other device so that the words are not conveniently legible;
  - (iii) when the flag or other device is so locked that the aforesaid words are horizontal and legible no fare shall be recorded on the face of the taximeter.

- (b) If the taximeter is not fitted with a flag or other device bearing the words "FOR HIRE":
  - (i) the taximeter shall be fitted with a key or other device the turning of which will bring the machinery of the taximeter into action and cause the word "HIRED" to appear on the face of the taximeter;
  - (ii) such key or device shall be capable of being locked in such a position that the machinery of the taximeter is not in action and no fare is recorded on the face of the taximeter.
- (c) When the machinery of the taximeter is in action there shall be recorded on the face of the taximeter in figures clearly legible and free from ambiguity a fare not exceeding the rate which the proprietor or driver is entitled to demand and take in pursuance of the byelaw in that behalf of the hire of the carriage by distance.
- (d) The taximeter shall be so constructed as to be capable of registering two alternative tariffs, the one tariff being that applicable to daytime hirings under the provisions as to charges contained in byelaw 17 hereof and the other tariff being that applicable to hirings between midnight and 7.00 a.m. comprising a surcharge of Fifty per centum on the charges for mileage and waiting time.
- (e) The word "FARE" shall be printed on the face of the taximeter in plain letters so as clearly to apply to the fare recorded thereon.
- (f) The taximeter shall be so placed that all letters and, figures on the face thereof may be at all times plainly visible to any person being conveyed in the carriage, and for that purpose the letters and figures shall be capable of being suitably illuminated during any period of hiring.
- (g) The taximeter and all the fittings thereof shall be so affixed to the carriage with seals or other appliances that it shall not be practicable for any person to tamper with them except by breaking, damaging or permanently displacing the seals or other appliances.

5. The proprietor of a hackney carriage provided with a taximeter not fitted with a flag or other device bearing the words "FOR HIRE" shall cause the carriage to be provided with a sign so constructed as to comply with the following requirements, that is to say:

- (i) the sign shall bear the words "FOR HIRE" in plain letters at least one and a half inches in height;
  - (ii) the sign shall be capable of being so operated that it indicates clearly and conveniently to persons outside the carriage whether or not the carriage is for hire.

Provisions regulating the conduct of the proprietors and drivers of hackney carriages plying within the district in their several employments, and determining whether such drivers shall wear any and what badges.

- 6. The driver of a hackney carriage shall:-
  - (a) if the taximeter is fitted with a flag or other device bearing the words "FOR HIRE";
    - (i) when standing or plying for hire keep such flag or other device locked in the position in which the words are horizontal and legible;
    - (ii) as soon as the carriage is hired by distance, and before commencing the journey, bring the machinery of the taximeter into action by moving the flag or other device so that the words are not conveniently legible and keep the machinery of the taximeter in action until the termination of the hiring.
  - (b) if the taximeter is not fitted with a flag or other device bearing the words "FOR HIRE":
    - (i) when standing or plying for hire keep the taximeter locked in the position in which no fare is recorded on the face of the taximeter and operate the sign provided in pursuance of byelaw 5 so that the words "FOR HIRE" are clearly and conveniently legible by persons outside the carriage;

 (ii) as soon as the carriage is hired whether by distance or by time, operate the said sign so that the words "FOR HIRE" are not conveniently legible by persons outside the carriage;

- (iii) as soon as the carriage is hired by distance, and before commencing the journey, bring the machinery of the taximeter into action by moving the key or other device fitted for the purpose so that the word "HIRED" is legible on the face of the taximeter and keep the machinery of the taximeter in action until the termination of the hiring.
- (c) cause the dial of the taximeter to be kept properly illuminated throughout any part of a hiring which is during the hours of darkness as defined for the purposes of the Road Traffic Act 1972 and also at any other time at the request of the hirer.
- 7. A proprietor or driver of a hackney carriage shall not tamper with or permit any person to tamper with any taximeter with which the carriage is provided, with the fitting thereof, or with the seals affixed thereto.
- 8. The driver of a hackney carriage shall, when plying for hire in any street and not actually hired:-
  - (a) proceed with reasonable speed to one of the stands fixed by the byelaw in that behalf;
  - (b) if a stand, at the time of his arrival, is occupied by the full number of carriages authorised to occupy it, proceed to another stand;
  - (c) on arriving at a stand not already occupied by the full number of carriages authorised to occupy it, station the carriage immediately behind the carriage of carriages on the stand and so as to face in the same direction;
  - (d) from time to time when any other carriage immediately in front is driven off or moved forward cause his carriage to be moved forward so as to fill the place previously occupied by the carriage driven off or moved forward.

9. A proprietor or driver of a hackney carriage, when standing or plying for hire, shall not, by calling out or otherwise, importune any person to hire such carriage and shall not make use of the services of any other person for the purpose.

10. The driver of a hackney carriage shall behave in a civil and orderly manner and shall take all reasonable precautions to ensure the safety of persons conveyed in or entering or alighting from the vehicle.

11. The proprietor or driver of a hackney carriage who has agreed or has been hired to be in attendance with the carriage at an appointed time and place shall, unless delayed or prevented by some sufficient cause, punctually attend with such carriage at such appointed time and place.

12. The driver of a hackney carriage when hired to drive to any particular destination shall, subject to any directions given by the hirer, proceed to that destination by the shortest available route.

13. A proprietor or driver of a hackney carriage shall not convey or permit to be conveyed in such carriage any greater number of persons than the number of persons specified on the plate affixed to the outside of the carriage.

- 14. If a badge has been provided by the Council and delivered to the driver of a hackney carriage he shall, when standing or plying for hire, and when hired, wear that badge in such position and manner as to be plainly visible.
- The driver of a hackney carriage so constructed as to carry luggage shall, when requested by any person hiring or seeking to hire the carriage;

(a) convey a reasonable quantity of luggage;

(b) afford reasonable assistance in loading and unloading;

(c) afford reasonable assistance in removing it to or from the entrance of any building, station, or place at which he may take up or set down such person.

Provisions fixing the stands of hackney carriages.

16. Each of the several places specified in the following list shall be a stand for such number of hackney carriages as is specified in the list -

#### **REPEAL OF BYELAWS**

22. The byelaws relating to hackney carriages which were made by the former Urban District Council of Rhyl on 16th November 1971 and the byelaws relating to hackney carriages which were made by the Council on 8th June 1974, and which were confirmed by one of Her Majesty's Prinicipal Secretaries of State on 25th January 1972 and 17th July 1974 respectively, are hereby repealed.



  - (b) if a stand, at the time of his arrival, is occupied by the full number of carriages authorised to occupy it, proceed to another stand;
  - (c) on arriving at a stand not already occupied by the full, number of carriages authorised to occupy it, station the carriage immediately behind the carriage or carriages on the stand and so as to face in the same direction;
  - (d) from time to time when any other carriage immediately in front is driven off or moved forward cause his carriage to be moved forward so as to fill the place previously occupied by the carriage driven off or moved forward.

- 9. A proprietor or driver of a hackney carriage, when standing or plying for hire, shall not, by calling out or otherwise, importune any person to hire such carriage and shall not make use of the services of any other person for the purpose.
- 10. The driver of a hackney carriage shall behave in a civil and orderly manner and shall take all reasonable precautions to ensure the safety of persons conveyed in or entering or alighting from the vehicle.
- 11. The proprietor or driver of a hackney carriage who has agreed or has been hired to be in attendance with the carriage at an appointed time and place shall, unless delayed or prevented by some sufficient cause, punctually attend with such carriage at such appointed time and place.
- 12. The driver of a hackney carriage when hired to drive to any particular destination shall, subject to any directions given by the hirer, proceed to that destination by the shortest available route.
- 13. A proprietor or driver of a hackney carriage shall not convey or permit to be conveyed in such carriage any greater number of persons than the number of persons specified on the plate affixed to the outside of the carriage.
- 14. If a badge has been provided by the Council and delivered to the driver of a hackney carriage he shall, when standing or plying for hire, and when hired, wear that badge in such position and manner as to be plainly visible.

- The driver of a hackney carriage so constructed as to carry luggage shall, when requested by any person hiring or seeking to hire the carriage;
  - (a) convey a reasonable quantity of luggage;
  - (b) afford reasonable assistance in loading and unloading;

(c) afford reasonable assistance in removing it to or from the entrance of any building, station, or place at which he may take up or set down such person.

Provided always that where a hackney carriage furnished with a taximeter shall be hired by distance the proprietor or driver thereof shall not be entitled to demand and take a fare greater than that recorded on the face of the taximeter, together with any extra charge authorised by the following table :-

Provisions securing the safe custody and re-delivery of any property accidentally left in hackney carriages, and fixing the charges to be made in respect thereof.

- 19. The proprietor or driver of a hackney carriage shall immediately after the termination of any hiring or as soon as practicable thereafter carefully search the carriage for any property which may have been accidentally left therein.
- 20. The proprietor or driver of a hackney carriage shall, if any property accidentally left therein by any person who may have been conveyed in the carriage be found by or handed to him:
  - (a) carry it as soon as possible and in any event within 48 hours, if not sooner claimed by or on hehalf of its owner, to the Police Station in Prestatyn, and leave it in the custody of the officer in charge of the office on his giving a receipt for it;
  - (b) be entitled to receive from any person to whom the property shall be re-delivered an amount equal to five pence in the pound of its estimated value (or the fare for the distance from the place of finding to the said Police Station, whichever be the greater) but not more than five pounds.


#### PENALTIES

21. Every person who shall offend against any of these byelaws shall be liable on summary conviction to a fine not exceeding twenty pounds and in the case of a continuing offence to a further fine not exceeding five pounds for each day during which the offence continues after conviction therefor.

#### **REPEAL OF BYELAWS**

22. The byelaws relating to hackney carriages which were made by the former Urban District Council of Prestatyn on 22nd September 1952 and 4th March 1971 and which were confirmed by one of Her Majesty's Principal Secretaries of State on 22nd November 1952 and 28th May 1971 respectively are hereby repealed.

### 1. **PURPOSE OF THE REPORT**

- 1.1 Following the publication of the Welsh Government White Paper on the proposals to reform the taxi licensing regime, a review of our current practices has taken place and some areas have been identified where we can make improvements to the current regime.
- 1.2 Officers have identified an existing practice that could be adopted that would meet with the Welsh Government proposals and improve our policy whilst also bring the authority into line with other Welsh authorities, namely implementing Group 2 medical checks, in place of the current Group 1 medical check.

## 2. **EXECUTIVE SUMMARY**

- 2.1 To seek approval to review the current medical requirements in line with the proposals set out in the Welsh Government White Paper and Department for Transport standards.
- 2.2 To seek approval to consult with the licensed trade on the proposals should members be minded to approve.

## 3. **POWER TO MAKE THE DECISION**

3.1 The Local Government (Miscellaneous Provisions) Act 1976

## 4. BACKGROUND INFORMATION

4.1 Responsibility for determining the standards, including medical requirements, to be applied to taxi drivers rests with the Local Authority.

- 4.2 Current best practice advice is contained in the booklet 'Fitness to Drive: A Guide for Health Professionals' published on behalf of the Department by The Royal Society of Medicine Press Limited (RSM) in 2006
- 4.3 In March 2023 the Welsh Government published a White Paper "Taxi and Private Hire Vehicle (PHV) (Wales) Bill" to help modernise the taxi and private hire sector and bring greater consistency throughout Wales by proposing national minimum standards for the licensed trade.
- 4.4 Consultation on the White Paper closed on the 1<sup>st</sup> June 2023 however, there are no set timescales for the results of the consultation to be published due to the high volume of responses received, it is therefore proposed to continue reviewing our current practices with the Welsh Government proposals in mind, with the first review being our current medical standards.
- There are currently two DVLA Licence Groups for medical standards:
   Group 1 includes motor cars and motor cycles.
   Group 2 includes large lorries (category C) and buses (category D).
- 4.6 The medical standards for group 2 drivers are more stringent than those for Group 1 because of the size and weight of the vehicle and the higher risk emanating from drivers' hours.
- 4.7 Group 2 medical standards have been implemented throughout 19 of the 22 local authorities in Wales, which includes all of our neighbouring authorities.
- 4.8 The Council currently requests a medical examination to Group 1 standard signed by a registered medical practitioner on application for a licence and every 3 years thereafter. At 60 years of age a medical certificate is required annually. A copy of the current medical form is attached at appendix A.
- 4.9 Officers propose that applicants and existing drivers would need to meet the DVLA Group 2 medical standards of fitness to drive, and the following conditions are proposed:
  - i. The medical must be carried out by the applicant's own general practitioner (GP) or another GP at the applicant's registered practice that has full access to their medical records.
  - ii. In exceptional circumstances, and only with prior agreement from the Licensing authority, a medical assessment may be carried out

by another registered GP practice as long as the applicant's full medical history has been viewed and assessed by that GP.

- iii. For existing licence holders, during the transition to move from Group 1 to Group 2 medical standards, the licensing authority may direct any licence holder to supply satisfactory evidence in the form of a medical certificate, stating the licence holder meets the required Group 2 standards, should their medical fitness be called into question.
- iv. Any applicant for the grant or renewal of a licence who is unable to satisfy the licensing authority that they meet the required medical standard shall not have a licence granted to them, or the licence shall not be renewed, or shall be revoked.
- v. The requirement for applicants/licensed drivers to complete a medical examination is as follows:
  - A. Upon application and on first renewal following the implementation of Group 2 medical standards and every 3 years thereafter between the ages of 45 and 65 ie if you are under 45 years of age after the grant or renewal of your licence you will not require another medical until you are 45 years of age and then every three years thereafter.
  - B.Every year when the driver is aged 65 years or over
  - C. Or anytime as required by the licensing authority or a medical practitioner.
- vi. The medical form is valid for 4 months from the date the examining doctor, optician or optometrist signs it.
- vii. All licence holders are required to inform the licensing authority of any illness or condition that affects their ability to drive.
- viii. All costs associated with obtaining the relevant medical certificate are to be met by the applicant/licence holder.
- ix. At each renewal of licence (3 years) up to the age of 45 years the licence holder will be required to declare any medical issues that they may be aware of affecting their suitability to meet the Group 2 medical standards. Any medical declarations may require a Group 2 medical certificate at that renewal.
- 4.10 Welsh Government have also developed a standardised Group 2 standards medical form for welsh local authorities to implement, which

can be found at Appendix B.

4.11 To assist Members, the costs associated with both Group 1 and 2 medicals have been sourced from a number of GP Surgeries throughout Denbighshire and the current average costs are detailed below, which are met by the applicant/licence holder:

Group 1: £60 - £75 Group 2: £95 - £140

4.12 Should Members be minded to support the proposed changes to the medical standards it is suggested that at least 6 months' notice is given to existing licence holders before the proposed changes come in to force. This will allow licence holders time to comply with the new requirements and provide a new medical certificate on their next renewal. However, for new applicants it is proposed that the new medical standards come in to force sooner at an agreed date.

## 5. **CONSULTATION**

- 5.1 Any proposed change to the current policy will require the requisite consultation with all licence holders and interested parties.
- 5.2 It is therefore proposed that a 6 week consultation process will take place and the responses received will be taken into consideration.
- 5.3 Should objections be received to the proposals, Officers will report back to the next scheduled Licensing committee after the end of consultation.
- 5.4 However, should there be no representations objecting to the proposals, the proposed standards will come into effect at an agreed date.

### 6. **RECOMMENDATION**

- 6.1 It is recommended that Members consider the contents of the report and resolve to:
- 6.2 Authorise officers to consult with current licensed drivers and licensed Operators and Proprietors on the implementation of Group 2 medical standards, and
- 6.3 Where no objections are received following the consultation period, Members authorise officers to:
  - i. Implement a requirement for Group 2 medical certificates for

licensed drivers as set out at 4.5 above, with effect from 1<sup>st</sup> December 2023 for new applicants and 1<sup>st</sup> June 2024 for renewal licence holders.

6.4 Where objections are raised during the consultation period, Members instruct officers to prepare a report for a future Licensing Committee meeting where objections can be considered.
