*The purpose of this report is to keep you informed of some of the meetings / issues I have dealt with on your behalf and as a member of Denbighshire County Council during the 2012/13 municipal (Council) year which ran from May 2012 to May 2013.*

### **Local Member Activities**

Last year I:

- Continued to work on keeping the profile of Rhuddlan Library as high as possible. Two hundred children took part in the reading challenge and each were presented with a medal.
- Made representation on behalf of electors on the proposed building of 100 homes on Tirionfa.
- Attended the visit made by Jane Hutt to the new 10 affordable houses - David Owen Close.
- Held a public meeting to discuss litter dropping and dog fouling.
- Used commuted sums to fund bike racks and a bench that have been placed near the library.
- Continued to liaise with officers regarding Rhuddlan Bridge, investigations are on-going regarding the structure.
- Attended the opening of Plas Lorna, formerly known as Bryn Gwybr. This unit will provide for individuals with additional needs and will create 60 jobs.
- Liaised with officers regarding the upgrading of the forecourt and fencing at Harding Avenue .

As Carers Champion since 2008 I have helped many local people gain financial, physical and emotional support in order to live independently in their own home .I have also raised awareness of the needs of Carers.
