*The purpose of this report is to keep you informed of some of the meetings / issues I have dealt with on your behalf and as a member of Denbighshire County Council during the 2012/13 municipal (Council) year which ran from May 2012 to May 2013.*

### **Local Member Activities**

- Monthly surgeries on the first Tuesday of each month either at the North Wales Bowling Centre or walking and knocking at various areas across the ward.
- Advocating for a large number of individuals on issues with the Local Authority or other public services.
- Attending public meetings related to specific issues in particular areas of the ward.
- Advocating on behalf of residents of Glan y Gors to oppose a particular planning application by Network Rail.
- Liaised with Dong Energy on behalf of residents to ensure the public were fully informed and consulted on a planning application.
- Meeting DCC officers to address areas of concern around the ward.
- Liaison with the ward PCSO to maintain effective communication between residents and NW Police.
- Attending DCC full council meetings, speaking on a number of issues.
- Practical voluntary activities ie:
  - Food collection for Foodbank at Prestatyn retail park.
  - Litter collection at Barkby Beach with Countryside Services and residents.
  - Working with residents to construct sandbank defences at a Tower Beach in response to flood warnings.
- Attending a number of site visits in relation to planning applications.

### **Major Projects**

- Working with DCC officers on the Prestatyn and Meliden area plan. Ensuring funds are directed appropriately.
- Liaising and working with DCC officers on plans to protect and develop coastal Leisure facilities.
- Working with a Prestatyn community Foodbank in partnership with members of the community and interested groups.
