Annual Monitoring Report 2018

## 1. What is the report about?

The proposed publication of the Denbighshire Local Development Plan 2006 - 2021 (LDP) Annual Monitoring Report (AMR) 2018 and document submission to Welsh Government by 31st October 2018.

# 2. What is the reason for making this report?

To inform Members of the content of the LDP Annual Monitoring Report (AMR) 2018.

### 3. What are the Recommendations?

That Members note the contents of the LDP Annual Monitoring Report (AMR) 2018, Appendix 1.

## 4. Report details

Under the obligations of section 76 of the Planning and Compulsory Purchase Act 2004, as amended, and section 37 of the Town and Country Planning (Local Development Plan) (Wales) Regulations 2005, the Council is duty bound to produce an annual monitoring report for submission to Welsh Government (WG) by 31st October each year and publication on its website.

Monitoring represents an essential feedback loop within the process of policy-making. It should identify the key challenges, opportunities and possible ways

forward for revising and adjusting local policies. The process is a tool for measuring the relevance and success of the LDP and identifying any changes necessary. It also provides feedback on the extent to which the LDP Strategy and policies are being delivered and achieved.

The Council published the finalised LDP Review Report 2017 in December 2017 and Welsh Government approved the Delivery Agreement for the next Denbighshire Local Development Plan in May 2018. Both documents are crucial for starting working on the new Plan. Moreover, the LDP Review Report and the Annual Monitoring Reports are crucial evidence shaping the next LDP and inform local policy formulation.

This is the fourth Annual Monitoring Report (AMR) prepared by Denbighshire County Council, and supplements the previously published AMRs with regard to local policy performance and in gathering crucial evidence for the forthcoming LDP Review. Previous AMRs can be found on the DCC LDP website: www.denbighshire.gov.uk/ldp

This report discusses local policies that have been identified as not performing as expected or where legal changes outweigh previously defined indicators and trigger levels. It has become apparent over the last four years since LDP adoption that the following three principal areas of local policy are not performing as expected and are subject to review as part of the next LDP.

- LDP Growth Strategy failure to deliver number of dwellings as set out in chapter 5 of the LDP; linked to the Technical Advice Note (TAN) 1 '5-year housing land supply' requirement;
- Gypsy & Traveller Sites addressing the identified need as set out in the 'Gypsy & Traveller Accommodation Needs Assessment'; and
- Waste Management and Minerals legislative and regulatory changes necessitate amendment of local policies and related monitoring indicators.

Further details on these three topics, including background information and implications for related local policies can be found in the LDP Review Report and accompanying Information Papers (Building Sustainable Communities and Promoting a Sustainable Economy).

### 5. How does the decision contribute to the Corporate Priorities?

A decision is not sought on this item. However, the LDP contributes towards the following Corporate Priorities through setting out where and how new developments will be taken place up in the County up to 2021:

- Developing the local economy;
- Ensuring access to good quality housing; and
- Modernising the Council to deliver efficiencies and improve services for our customers

#### 6. What will it cost and how will it affect other services?

There are no costs for taking note of the content of this report.
