*The purpose of this report is to keep you informed of some of the meetings / issues I have dealt with on your behalf and as a member of Denbighshire County Council during the 2017/18 municipal (Council) year which ran from May 2017 to May 2018.*

#### **Local Member Activities**

As an elected member for the Central Ward of Prestatyn I have been busy dealing with residents queries and making representations on their behalf where appropriate.

I have dealt with a varied range of issues including Housing needs, Planning Matters .

Highways concerns and other concerns that residents have raised.

I have an 86% attendance rate for meetings at which I have been required and have also attended other committees and groups if local issues are under discussion.

My role within Denbighshire County Council has included the Chairmanship of the Licensing Committee dealing with all issues where licences are concerned (Taxis, Licensed premises etc ) and membership of two scrutiny committees which examine decisions taken on relevant actions of the Cabinet and the Council.

I represent Denbighshire County Council on the Police and Crime Panel which scrutinises the work of the Police and Crime Commissioner and have recently been involved with the appointment of a new Chief Constable for North Wales.

I would hope to continue to make myself readily available to all residents with concerns to raise.
