The Global Refugee project takes into account the five ways of working ensuring we consider the long-term impact of our decisions, to work better with people, communities and each other, and to prevent persistent problems such as poverty, health inequalities and climate change. However the project is funded for 5 years only with an expectation that the families will be imbedded in their communities and living independently.
