The School Catering Team also provides the School Holiday Enrichment Project during school holidays, a project funded by the Welsh Government and promoted by the School Catering Team throughout DCC.
Further actions required	To encourage those families/guardians who may be entitled to FSM to claim FSM, despite any stigma associated with such an application. This work is continuous both with the schools and parents/guardians alike, even more so through the ongoing COVID pandemic.
