Additional plan:

An additional plan has been submitted to the Local Planning Authority by the applicants. The plan shows sections through the site and can be viewed in detail on the Council website (along with all other relevant plans). For ease of reference the plan is included below.

The plan demonstrates the relationship between the proposed dwellings and the neighboring properties which are positioned at a lower level to the west of the site. Having regard to the details on the cross section plan, in terms of the potential impacts of the proposal on the residential amenity of the occupiers of these properties (including Hafan Deg and Ty'n y Berllan), Officers are of the opinion that the scheme is acceptable and would not result in an unacceptable overlooking or overbearing impacts on these properties. The proposed dwellings are considered to be situated a sufficient distance away from the neighboring properties to not result in an unacceptable impact on residential amenity.

## **ADDITIONAL ITEM:**

### **Awel y Mor offshore windfarm – updated plans consultation**

Members may recall that the Council were invited to comment on the Awel y Mor offshore windfarm pre-application consultation in Autumn 2021 and the Council's pre-application consultation response was discussed at the October 2021 Planning Committee.

The proposed scheme subject of the pre-application consultation included:

- An offshore windfarm comprising up to 91 wind turbines and associated foundations and other offshore infrastructure;
- Offshore cables to bring power to shore at Ffirth Breach;
- Underground onshore electricity cables from Ffrith beach to Bodelwyddan;
- Construction of a new substation on land to the west of St Asaph Business Park, Bodelwyddan, required to transform the power from the windfarm up to the required voltage to connect to the National Grid.

The Council received a letter at the end of January advising that, in light of the responses to the pre-application consultation, the developer has made minor revisions to the scheme and updated plans have been published.

Prior to submitting an application for development consent, the developer has invited the Council and other consultees to submit comments to them on the updated plans. Any comments the Council wish to make need to be submitted to the developer before the 2<sup>nd</sup> March.

The updated plans include the following new elements:

- A new site for the beach works Temporary Construction Compound and associated beach accesses, proposed to be located on land to the west and north-west of the North Wales Bowls Centre, with vehicular access off Ferguson Avenue, Prestatyn.
- A new construction vehicle access route across the beach.
- New areas of beach to be used for temporary placement of cable installation vessel anchors.
- Several minor new areas along the onshore cable route required for access and environmental mitigation works.

Owing to the short timescales, Officers are seeking delegated powers to submit comments on the updated plans on behalf of the Council. ensure the Chair of Planning Committee (CII. Joe Welch) and Lead Member (CII. Mark Young) are copied in. Officers will then seek agreement on a final response with the Chair and Lead Member before sending the response.
