
Summary for each Sustainable Development principle

Long term	The Admissions processes drive Education in Denbighshire. The above aspects of sustainability are therefore also linked to other areas of work; from the development of new schools, school transport, school management etc. The focus being to ensure pupils can attend their nearest suitable school, notwithstanding that legislation does permit parental choice.
Prevention	Admissions legislation in Wales does permit parental choice of school; however, the Authority works towards ensuring that places are available in the nearest suitable school.
Integration	Whereas the Admission Policy process does not have to directly consider the Local Development Plan, in a wider context for the development of Schools and Education throughout Denbighshire, this is very much part of the process through our Modernising Education Team. This ensures that schools are able to meet the demands that future developments may bring.
Collaboration	The Admissions Code processes are prescriptive, for which all Authorities in Wales must comply.
Involvement	The Admissions Code for Wales provides a list of statutory consultees for this process annually. This has been complied with for arrangements for Denbighshire from 2022/23.

Overall Impact	Neutral
Justification for impact	Although the policy is written within the legislative framework provided by the Welsh Government, the Oversubscription Criteria used are set by Denbighshire to keep local schools for local children, thus lowering time and distance in travelling to school.
Further actions required	The negative above is actually a positive in terms of the well-being of children, permitting access to education with their friends from the feeder school

Positive impacts identified:

A low carbon society	Families applying for local schools receive priority for places, which lowers travelling distance to school.
Quality communications, infrastructure and transport	Use infrastructure in measuring distance from home to school accessing up to date road/footpath information. Although not part of this policy Parents are to consider the implications of school transport when applying for certain schools. This is referenced in the Denbighshire's Learner Transport Policy.
Economic development	Although not part of the policy all primary schools have a Breakfast club, and many provide after school arrangements, thus supporting working parents. In Wales Breakfast clubs are obligatory from 830am.

Negative impacts identified:

A low carbon society	The policy has to include an oversubscription criteria. "Feeder school" arrangements may also result in more pupils being admitted to a Secondary school where that school is not the necessarily the nearest from home. However, such an arrangement is also supports the welfare of child; in that they can attend the secondary school with their friends and it is not purely on distance from home.

Justification for impact	No change to existing arrangements from previous years.
Further actions required	Parent / carers have the right to select the school of choice, and the oversubscription criteria may also result in pupils not attending their nearest suitable school. However, the Admissions process works within a Welsh Government framework and this is an unintended consequence for which the Authority has no control.

Overall Impact	Negative
Justification for impact	The legislation framework with which school admissions operates could cause anxiety in regard to whether parents / carers get the requested school place. This unintended outcome is beyond the control of Local Government and is directly linked to capacity issue at school, which are finite. The process tries to ensure that available places are assigned in a fair and equitable way.

Publicising the benefits of attending the local school. Providing an open and transparent process which shows a clear explanation of the constraints which admissions operate within and the considerations given to the applications received. Denbighshire's Modernising Schools agenda takes a long-term view of the places available in schools and the future requirements dependant on demographics and planning development.

A social and physical environment that encourage and support health and well-being	By admitting pupils to their nearest suitable school it could encourage walking / cycling to school where able. However, parents / carers can select a school of preference which may not be their nearest. For which they would then have to transport their children.

Further actions required	With supporting evidence, health conditions could be used in the oversubscriptions criteria, but there is a process by which parents / carers can raise such issues through appeal.

However, this aspect is covered within other polices, specifically the Learner Transport Policy, which will provide free transport in such circumstances. For parents who express a preference for a school which is not the nearest suitable school, this would not apply.
Areas affected by socio-economic disadvantage	The policy does consider any specific health issues of parents / carers as part of the admission process. However, these may be include in any declaration from parents / carers during the Appeals process. For which the independent appeals panel may consider these and other circumstances.
