

Rhyl Town Centre Public Space Protection Order 2023-24: Well-being Impact Assessment Report

This report summarises the likely impact of the proposal on the social, economic, environmental and cultural well-being of Denbighshire, Wales and the world.

Brief description: The proposal is the implementation of a Public Space Protection Order (PSPO) for Rhyl Town Centre. Rhyl town centre has higher levels of anti-social behaviour than other areas of Rhyl. This anti-social behaviour is unfair and harmful to residents, businesses and visitors to the High Street area. Rhyl town Centre has previously had two PSPOs for anti-social behaviour in place so this is a renewal. The effect of the PSPO will be to prevent and deal with individuals and groups of people consuming alcohol and/or causing anti-social behaviour on the High Street.

Who will be affected by the proposal? The boundary area for the proposed PSPO covers Rhyl Town Centre area, as follows: • Rhyl Promenade from East Parade to Alexandra Road • South from East Parade down Bath Street • From Brighton Road to the junction with Grange Road Bridge and west to Elwy Street • Elwy Street to the junction with Wellington Road • Wellington Road to John Street • John Street to West Parade, including the promenade The consequence of this PSPO will be that North Wales Police (NWP) will have additional powers to deal with issues with respect of anti-social behaviour and street drinking within the defined area. Due to the negative impacts of the behaviours covered in the proposed PSPO, this will positively impact on both the residents and business owners in Rhyl, together with those also visiting the Rhyl area.

Summary and Conclusion

Summary for each Sustainable Development principle

Long term

This proposal is about implementing a PSPO for Rhyl Town centre. There are no physical or financial assets considered as part of the proposal however there will be a small cost for the signage required. This proposal will positively impact on the Prosperous theme of the Corporate plan.

Prevention

DCC has worked hard with NWP and other partners to ensure there are a range of measures in place alongside the PSPO to support people. This includes: Re-opening Rhyl Youth Centre on the Promenade, dedicated support for young people as part of the Safer Streets funding scheme. Projects to help prevent people from becoming homeless. Regular meetings between the Council, NWP and other organisations to share issues, collectively tackle problems, and learn from success stories.

Integration

Rhyl town centre has higher levels of anti-social behaviour than other areas of Rhyl. This repeated anti-social behaviour is unfair and harmful to residents, businesses and visitors to the High Street area. The effect of the PSPO will be to prevent and deal with individuals and groups of people consuming alcohol and/or causing anti-social behaviour on the High Street. The Local Development plan has been considered in terms of affordable housing and homelessness but it will not help deliver

it.

Collaboration

Public consultation opened on the 24th of November 2023 and ran until Sunday 21st of January 2024. Notice of the consultation was emailed to groups/organisations in Rhyl. Additionally, the Head the Service and Lead Member for Housing and Communities attended the Rhyl Member Area Group Meeting (18th of December 2023) and Rhyl Town Council (17th of January) as part of the direct engagement and notification of the consultation.

Involvement

The National principles of public engagement were applied, as this was a planned public engagement, working with relevant partners and making to easy to take part. The consultation also provided background as to the requirements for implementing a PSPO for Rhyl Town Centre together with the work with North Wales Police and other partners to ensure there is a range of measures in place alongside the PSPO to support people and discourage them from committing anti-social behaviour.

Following receipt of the data and evidence from North Wales Police, Denbighshire County Council was satisfied that the Legal Test for a Public Space Protection Order (PSPO) at Rhyl Town Centre

had been satisfied. As a result, a public consultation was launched which opened on the 24th of November 2023 and ran until midnight on the Sunday 21st of January 2024. The proposed PSPO bans certain activities or behaviours within a geographical area, which may be considered to be anti-social. This anti-social behaviour has a detrimental impact on the quality of life of those in the locality. The PSOP is therefore a tool to ensuring the Rhyl Town Centre can be a safe, welcoming and inclusive environment for everybody which will increase community resilience.

The attractiveness of the area

Reducing anti-social behaviour will enhance the welcome of the town and make it more attractive (low levels of Anti-social behaviour). This proposal does not create new physical features such as green space.
