Dear Mr Jones,

The Town Council notes the intention to place a tree preservation order on the Robinia Pseudoacacia tree in the curtilage of the Town Hall in the ownership of the Council.

The Town Council is aware that a Tree Preservation Order makes it an offence to cut down, top, lop, uproot, wilfully damage or wilfully destroy a tree without the Council's permission. However, this tree is situated within the Llangollen Conservation Area and therefore is protected by the provisions in section 211 of the Town and Country Planning Act 1990. As you know these provisions also require owners to notify the local Planning Authority using a 'Section 211 Notice' at least six weeks in advance of carrying out works such as felling, cutting back and substantial reduction in size.

The Town Council therefore questions the need to place the order on the tree given its current protection and ownership by an accountable local authority.
