## **Appendix C**

## **Consultation with Staff and Governors**

The Formal Consultation began on the 9th of September and came to an end on the 22nd of October 2013.

Meetings were arranged with Staff and Governors in both Clocaenog and Cyffylliog.

Core Themes: During consultation meetings certain themes emerged. These are included below along with our response.

Question	Response
How long will the school remain on two sites?	By changing from a two site model to a single site we will be able to release revenue funding to draw down additional funding for the project. At this stage we are unable to confirm timescales.
We feel that if the school stays on two sites for more than 2 years, parents will move their children and the school will close?	We need parents to trust us. We can only demonstrate that we have invested in Ysgol Dyffryn Ial (Llandegla) and Ysgol Bro Dyfrdwy (Cynwyd). It is important that you include these fears in your response to the consultation.
Are people form Cyffylliog going to come here when the road to Ruthin is better?	Choice is part of Denbighshire County Council policy. We are planning for the new school to accommodate all existing pupils. Transport will be provided to the new school for existing pupils (If one of the sites are their nearest suitable school), if a parent chooses to attend a school that isn't their nearest suitable school, then they will not receive transport.
What about transport for breakfast and after school provision?	Transport isn't provided from Home to a breakfast club or afterschool provision. If required we can transport pupils from /back to their 'home' school for breakfast and / or afterschool provision. This is the detail that would require the input of the Temporary Governing Body, New Headteacher and discussions with individual families.
How the school will be staffed?	The new school requires a temporary governing body in place to appoint a new Head teacher who will then decide on staffing structure.  The Temporary Governing Body is formed by the Local Authority. We will request nominations from both existing Governing Bodies for experienced governors to sit on the Temporary Governing body.  The aim will be to ensure balance across the Governing Body with half the members

We also work closely with school admissions to help explain what the change means for parents who are anxious behind the change in category.
Isn't the Ruthin School going to take all the funding?	The new school in Ruthin will involve a lot of funding. It is important for respondents to enhance the status of Phase 2 with elected members. It is a manageable risk.
