Summary and Conclusion

Summary for each Sustainable Development principle

Long term

The policy will assist in the recruitment and retention of foster carers. It is vital that we attract more foster carers in order to meet the needs of out looked after children. The shortage of local foster carers has resulted in children being placed out of county, which results in a loss of local links to their family and community. Placing at a distance also increases carbon emissions as staff have to travel greater distances to undertake statutory visits to looked after children.

Prevention

This policy is designed to enhance the recruitment and retention of local foster carers. It can be demonstrated that most children and young people fare better when placed in or near their community. By increasing the number of foster carers that we have locally we can help to secure disadvantaged children within their own communities, and ensure they retain strong links with family, friends and school. Placing children more locally will assist in reducing the carbon emissions of the service.

Integration

The policy will help retain and recruit local foster carers. Keeping children within their local communities will assist with their emotional wellbeing and gives greater opportunity to retain important local community links.

Collaboration

This policy has been developed in partnership with HR, foster carers and Foster Wales. Foster Wales is a collaboration of all 22 local authorities in Wales, with the aim of providing standardised support to foster carers across Wales.

Involvement

Foster Wales and The Fostering Network have consulted widely with foster carer across Wales (including Denbighshire foster carers) and the UK. This work has resulted in a raft of recommendations designed to support foster carers and ultimately benefit looked after children, these recommendations include a Foster Friendly policy in respect of additional leave.
